ENGROSSED SENATE BILL NO. 2009

1 A BILL for an Act to provide an appropriation for defraying the expenses of the state fair
2 association; to provide legislative intent; and to declare an emergency.

3 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

4 **SECTION 1. APPROPRIATION.** The funds provided in this section, or so much of the
5 funds as may be necessary, are appropriated out of any moneys in the general fund in the state
6 treasury, not otherwise appropriated, to the state fair association for the purpose of defraying
7 the expenses of the state fair association, for the biennium beginning July 1, 2009, and ending
8 June 30, 2011, as follows:

17 **SIXTY-SECOND LEGISLATIVE ASSEMBLY.** The following amounts reflect the 2009-11
18 one-time funding items included in the appropriation in section 1 of this Act:

1 The 2009-11 one-time funding amounts are not a part of the entity's base budget for the
2 2011-13 biennium. The state fair shall report to the appropriations committees of the
3 sixty-second legislative assembly on the use of this one-time funding for the biennium
4 beginning July 1, 2009, and ending June 30, 2011.

5 **SECTION 3. EMERGENCY.** The appropriation of \$18,000,000 for the grandstand
6 project in the capital assets line item in section 1 of this Act is declared to be an emergency
7 measure.
