1 A BILL for an Act to amend and reenact sections 37-07.1-02 and 37-07.2-01 and to repeal  
2 section 37-07.1-06.1 of the North Dakota Century Code, relating to tuition waivers and grants  
3 for national guard members.

4 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

5 **SECTION 1. AMENDMENT.** Section 37-07.1-02 of the North Dakota Century Code is  
6 amended and reenacted as follows:

7 **37-07.1-02. Definitions.** As used in this chapter, unless the context or subject matter  
8 otherwise requires:

- 9 1. "School" means any university, college, career and technical education school,  
10 technical school, or postsecondary educational institution.
- 11 2. "State-controlled school" means any school which is controlled, financially  
12 supported, and operated by the state, a school district, or any other political  
13 subdivision.
- 14 3. "Tuition" means the normal registration fee. ~~It does not include graduation, activity,~~  
15 ~~or incidental fees, book rental, laboratory, service, supply, union building, hospital~~  
16 ~~and medical insurance fees, or any fees established for the operation and~~  
17 ~~maintenance of buildings, the income of which is pledged for the payment of~~  
18 ~~interest and principal on bonds issued by the governing board of any school.~~

19 **SECTION 2. AMENDMENT.** Section 37-07.2-01 of the North Dakota Century Code is  
20 amended and reenacted as follows:

21 **37-07.2-01. National guard tuition grants - Terms of grants.** Any qualifying member  
22 of the national guard who enrolls in an accredited postsecondary institution in North Dakota  
23 may, subject to the limitations of available appropriated funds and subject to national guard  
24 rules adopted by the adjutant general, receive a grant in an amount ~~equal to the payments~~

1 ~~made pursuant to chapter 37-07.1~~ not to exceed the cost of tuition and fees for similar courses  
2 and credit hours for each qualifying member of the national guard who is enrolled at the  
3 university of North Dakota. Any accredited postsecondary institution that agrees to participate  
4 in such a program must waive twenty-five percent of the tuition for qualifying national  
5 guardsmen. These grants must be distributed according to rules promulgated by the adjutant  
6 general and are available only so long as the member maintains satisfactory performance with  
7 the guard, meets the qualification requirements of the rules, and pursues a course of study  
8 which satisfies the normal requirements of the school. ~~As used in this chapter, the word~~  
9 ~~"tuition" has the same meaning as provided in section 37-07.1-02.~~

10           **SECTION 3. REPEAL.** Section 37-07.1-06.1 of the North Dakota Century Code is  
11 repealed.
