¹ This amendment increases funding from the tobacco prevention and control trust fund for the Comprehensive Tobacco Prevention and Control Executive Committee to provide funding for the development and implementation of the comprehensive tobacco control and prevention plan that will meet the Centers for Disease Control and Prevention best practices for comprehensive tobacco prevention and control programs.

North Dakota Century Code Section 54-27-25 is amended to remove the requirement that a minimum of 80 percent of the transfers from the tobacco settlement trust fund into the community health trust fund be used for tobacco prevention and control.
