**REPORT OF DELAYED BILLS COMMITTEE**

**MR. PRESIDENT:** Your **Delayed Bills Committee (Sen. Klein, Chairman)** has unanimously approved the introduction of a bill for an Act to amend and reenact section 40-23-07 of the North Dakota Century Code, relating to exemption of cemetery property from special assessment; to provide a statement of legislative intent; to provide an effective date; and to declare an emergency.

The bill will be SB 2441.

**REPORT OF DELAYED BILLS COMMITTEE**

**Purchase of flags of the United States.** A state entity or any political subdivision of this state may not purchase a flag of the United States of America unless the flag was manufactured in the United States of America. This section does not apply to the purchase of an item that is not a flag but which portrays a likeness of a flag of the United States of America, such as food, clothing, a lapel pin, a paper product, or other non-flag item."
