1 A BILL for an Act to provide an appropriation for defraying the expenses of the parks and
2 recreation department and the International Peace Garden; to provide for a transfer; and to
3 amend and reenact section 58-08-14.1 of the North Dakota Century Code, relating to
4 recreational grants.

5 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

6 **SECTION 1. APPROPRIATION.** The funds provided in this section, or so much of the
7 funds as may be necessary, are appropriated out of any moneys in the general fund in the state
8 treasury, not otherwise appropriated, and from special funds derived from federal funds and
9 other income, to the parks and recreation department for the purpose of defraying the expenses
10 of the parks and recreation department and the International Peace Garden, for the biennium
11 beginning July 1, 2009, and ending June 30, 2011, as follows.

18 **SECTION 2. ONE-TIME FUNDING - EFFECT ON BASE BUDGET - REPORT TO**
 19 **SIXTY-SECOND LEGISLATIVE ASSEMBLY.** The following amounts reflect the one-time
 20 funding items approved by the sixtieth legislative assembly for the 2007-09 biennium and the
 21 2009-11 one-time funding items included in the appropriation in section 1 of this Act:

30 The 2009-11 one-time funding amounts are not a part of the entity's base budget for the
 31 2011-13 biennium. The parks and recreation department shall report to the appropriations

1 committees of the sixty-second legislative assembly on the use of this one-time funding for the
2 biennium beginning July 1, 2009, and ending June 30, 2011.

3 **SECTION 3. DEFERRED MAINTENANCE - TRANSFERS.** The parks and recreation
4 department is authorized to transfer from the deferred maintenance line to other lines contained
5 in subdivision 1 of section 1 of this Act, amounts necessary to address extraordinary repair
6 needs. Any amounts transferred must be reported to the director of the office of management
7 and budget.

8 **SECTION 4. GAME AND FISH OPERATING FUND - TRANSFER.** The sum of
9 \$222,000, or so much of the sum as may be necessary, included in the estimated income line
10 item in subdivision 1 of section 1 of this Act, is from the game and fish operating fund, or federal
11 or other funds available to the game and fish department, and must be transferred to the parks
12 and recreation department for maintenance, operating, and extraordinary repairs expenses
13 relating to boat ramps at state parks for the biennium beginning July 1, 2009, and ending
14 June 30,2011.

15 **SECTION 5. EXEMPTION.** Up to \$700,000 of the recreation program line item
16 contained in section 1 of this Act is not subject to the provisions of section 54-44.1-11. Any
17 unexpended funds from this appropriation may be expended during the biennium beginning
18 July 1, 2011, and ending June 30, 2013, for the purposes provided in section 55-08-14.1.

19 **SECTION 6. AMENDMENT.** Section 55-08-14.1 of the North Dakota Century Code is
20 amended and reenacted as follows:

21 **55-08-14.1. Leadership and facilities grants.** The parks and recreation department
22 shall administer the funds made available to provide for recreational leadership grants and
23 facilities grants in the following manner:

24 1. ~~One fourth up to twenty-five percent~~ of all moneys made available to the
25 department for the grants must be used for a leadership grant program. ~~This~~
26 ~~program shall provide enhanced recreational opportunities to state residents,~~
27 ~~particularly in, with priority given to~~ communities with a population of thirteen
28 thousand or less, ~~regardless of age or state of health.~~ ~~Moneys .~~ Within the
29 availability of legislative appropriations, moneys must be provided to grant
30 recipients over a three-year period on a three-to-one seventy-five percent matching
31 basis basis for the first year of a grant, one-to-one fifty percent matching basis for

- 1 the second year of a grant, and ~~one to three~~ twenty-five percent matching basis for
2 the third year of the grant, after which the program must be fully funded locally.
- 3 2. ~~Three-fourths~~ No less than seventy percent of all moneys made available to the
4 department for the grants must be used for a facilities grant program. This
5 program must provide funds, on a fifty percent matching basis, for political
6 subdivisions to improve, renovate, or construct any type of facility primarily used for
7 community, park, and recreation purposes.
- 8 3. Up to five percent of all moneys made available to the department biennially for the
9 recreational and facilities grants program may be used by the department for
10 administration of leadership and facilities grants and to ensure completion of the
11 projects funded.
