1 A BILL for an Act to provide an appropriation for defraying the expenses of the extension
2 service, northern crops institute, upper great plains transportation institute, main research
3 center, branch research centers, and agronomy seed farm; to provide legislative intent; to
4 provide for transfers; to provide an exemption; and to declare an emergency.

5 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

6 **SECTION 1. APPROPRIATION.** The funds provided in this section, or so much of the
7 funds as may be necessary, are appropriated out of any moneys in the general fund in the state
8 treasury, not otherwise appropriated, and from special funds derived from federal funds and
9 other income, to the North Dakota state university extension service, the northern crops
10 institute, the upper great plains transportation institute, the main research center, branch
11 research centers, and agronomy seed farm for the purpose of defraying the expenses of the
12 North Dakota state university extension service, the northern crops institute, the upper great
13 plains transportation institute, the main research center, branch research centers, and
14 agronomy seed farm, for the biennium beginning July 1, 2009, and ending June 30, 2011, as
15 follows:

20 The 2009-11 one-time funding amounts are not a part of the entity's base budget for the
 21 2011-13 biennium. The extension service, northern crops institute, upper great plains
 22 transportation institute, main research center, branch research centers, and agronomy seed
 23 farm shall report to the appropriations committees of the sixty-second legislative assembly on
 24 the use of this one-time funding for the biennium beginning July 1, 2009, and ending June 30,
 25 2011.

26 **SECTION 3. ADDITIONAL INCOME - APPROPRIATION.** In addition to the amount
 27 included in the grand total special funds appropriation line item in section 1 of this Act, any
 28 other income, including funds from federal acts, private grants, gifts, and donations, or from
 29 other sources received by the North Dakota state university extension service, the northern
 30 crops institute, the upper great plains transportation institute, the main research center, branch
 31 research centers, and agronomy seed farm, except as otherwise provided by law, is

appropriated for the purpose designated in the act, grant, gift, or donation, for the biennium beginning July 1, 2009, and ending June 30, 2011.

SECTION 4. DEFERRED MAINTENANCE - TRANSFERS. The main research center may transfer from the deferred maintenance line to the main research center line, contained in subdivision 4 of section 1 of this Act, amounts necessary to address extraordinary repair needs. Any amounts transferred must be reported to the director of the office of management and budget.

SECTION 5. TRANSFER AUTHORITY. Upon approval of the state board of agricultural research and education and appropriate branch research center directors, the director of the main research center may transfer appropriation authority within subdivisions 1, 2, 4, and 5 of section 1 of this Act. Any amounts transferred must be reported to the director of the office of management and budget.

SECTION 6. FULL-TIME EQUIVALENT POSITION ADJUSTMENTS. The board of higher education may adjust or increase full-time equivalent positions as needed for the entities in section 1 of this Act, subject to availability of funds. The board shall report any adjustments to the office of management and budget prior to the submission of the 2011-13 budget request.

SECTION 7. UNEXPENDED GENERAL FUND - EXCESS INCOME. Any unexpended general fund appropriation authority to and any excess income received by entities listed in section 1 of this Act are not subject to the provisions of section 54-44.1-11, and any unexpended funds from these appropriations or revenues are available and may be expended by those entities, during the biennium beginning July 1, 2011, and ending June 30, 2013.

SECTION 8. EXEMPTION. The amounts appropriated for the center for transportation study, as contained in subdivision 3 of section 3 and the research greenhouse complex project, as contained in subdivision 4 of section 3, of chapter 20 of the 2007 Session laws, are not subject to the provisions of section 54-44.1-11, and any unexpended funds from these appropriations or related revenues are available and may be expended during the biennium beginning July 1, 2009, and ending June 30, 2011.

SECTION 9. EMERGENCY. The appropriation for deferred maintenance, extraordinary repairs, and capitol projects in subdivision 4 of section 1 of this Act is declared to be an emergency measure.
