- Drawing and cost estimate to divide the first floor legislative lounge area into two rooms.
- Provide a cost estimate to restore the brass and wood located in the house chambers, senate chambers and legislative hall.
- Provide a cost estimate to restore the ornamental wood desks located in the house and senate chambers.
- Provide a cost estimate to replace the handicap chair lift leading to the Brynhild Haugland room.


Each of you should have received a packet of information containing the following items:

- A project cost estimate for the brass, wood and desk restoration work.

The cost estimate to replace the existing handicap chair lift should not exceed \$32,000.






