TESTIMONY OF JEFF ENGLESON Director, Energy Development Impact Office North Dakota State Land Department

Taxation Committee August 24, 2010

The mission of the Energy Development Impact Office (EDIO) is to provide financial assistance to local units of government that are affected by energy activity in the state. Over the years, the EDIO has helped counties, cities, schools districts and other local units of government (organized townships, fire and ambulance districts, etc.) deal with both the booms and the busts associated with energy development in North Dakota. The EDIO became a part of the Land Department in 1989.

Since 1991, the EDIO has made grants only for impacts related to oil and gas development. Funding for these grants is appropriated by the State Legislature from a portion of the 5% Oil & Gas Gross Production Tax. For the 2007-09 biennium, the amount available to this program was capped at \$6.0 million; for the 2009-11 biennium, the cap was raised to \$8.0 million. About one-half of the funds are given away during each year of the biennium.

The Director of the EDIO is responsible for making all decisions related to the oil impact grant program. The Board of University and School Lands is the appellate for applicants not satisfied with the decisions made by the director. Over time, very few appeals have been made.

The EDIO is managed under NDCC Chapter 57-62. NDCC 57-62-05 and 57-62-06 provide the following guidance to the EDIO Director:

- Grants should be used "to meet initial impacts affecting basic government services, and directly
 necessitated" by oil and gas development. Basic government services does not mean marriage or
 guidance counseling, programs to alleviate other sociological impacts or programs to meet
 secondary impacts.
- The amount of tax an entity is entitled to from real property and from other tax or fund distribution formulas provided by law must be considered when determining grants.

The following award criteria are used when making grants to political subdivisions:

- A grantee must demonstrate the negative impact caused by oil and gas development in the area.
- A grantee must demonstrate its tax effort and financial need.
- The funds granted must be used to alleviate the hardship caused by oil and gas development.

HISTORIC INFORMATION

One of the great things about this program is that the EDIO Director has always had flexibility in administering the oil and gas impact grant program. This has allowed the program to adapt to changing needs as drilling activity has moved from one area of the state to another, and as oil and gas development has gone through both boom and bust cycles. The attached tables provide a breakdown of grants requested and awarded over the past 5 biennia by political subdivision type, by county, and by function.

These tables contain a lot of information; however, there are a few specific things I'd like to point out:

- Although the amount of grant requests has increased substantially over the past nine years, it has stabilized somewhat over the past 5 years.
- The amount of grants awarded to counties has decreased over the past nine years. The primary reason for this is that this program has recognized that the amount of gross production tax revenue going to counties has increased substantially in recent years. This was especially true in fiscal year 2010 with the implementation of the formula changes found in House Bill 1304.
- The amount awarded to organized townships, volunteer fire departments and ambulance services
 has increased substantially in recent years. This is primarily a result of this program recognizing
 that these entities have major, direct impacts from oil and gas development, but do not receive
 any share of the production tax revenues collected by the state.
- The amount of grants awarded to political subdivisions in Bowman County has decreased, while
 the amount awarded to entities in Mountrail County, Dunn County and various other counties has
 increased. This is result of the focus of development activity moving from the Cedar Hills area in
 Bowman County in the late 1990s and early part of this decade to the Bakken play in the Mountrail
 County, Dunn County and now other areas in northwestern North Dakota in more recent years.
- The one thing that hasn't really changed much over the years is the fact that the vast majority of the grants awarded (85+ %) have been for transportation related projects/functions and for fire and ambulance related equipment and services.

As these tables show, the flexibility of the EDIO program has allowed the EDIO Director to try to balance the needs of the various political subdivisions at any given point in time with the resources available. When drilling activity was heavy in Bowman County, a good chunk of EDIO funds went there; now that the Bakken play has spread throughout northwestern North Dakota, more funding is going to that area. In recent years, that flexibility has also allowed the Director to focus more on the townships, fire departments and other smaller entities that receive little or no gross production tax funding and less on counties and larger cities that saw substantial increases in gross production tax revenues in recent years

LEGISLATIVE CHANGES

During the 2009 session, the gross production tax distribution formula and the EDIO were popular topics in many different legislative committees. In the end, legislation was adopted that:

- Increased the amount of gross production taxes that was distributed to counties, cities and schools in fiscal year 2010 by an approximately \$25 million over the amount distributed in 2009. Initial estimates were that these payments would increase by approximately \$14 million.
- Directed that a portion of the increase in tax distributions be placed in infrastructure funds to be used by counties to help townships, schools, fire departments and other entities deal with the impacts of oil and gas development.
- Increased the funding available to the EDIO from \$6.0 million per biennium to \$8.0 million per biennium.

There are a couple of things that the EDIO Director took away with him from the 2009 legislative session that will be used to make grants during the current biennium. They include the following:

- It appears as if the legislature tried to take care of the "big guys" by substantially increasing the amount of gross production tax that goes to counties and larger cities.
- It appears as if the legislature did not intend for school districts to get additional funding through these programs, as any funds received impact the school funding formula.
- It appears that going forward, the legislature intends this program to focus on "filling in the gaps" for those entities that receive either no funding or inadequate funding under the gross production tax distribution formula.

SUMMARY OF 2010 GRANT ROUND RESULTS

During the 2010 grant round a total of 378 grant requests were received from 297 different political subdivisions; the total value of grant requests was \$31.9 million. On July 2, 2010, 290 grants were awarded to 266 political subdivisions; the total amount of grants awarded was \$4.0 million.

The Bakken/Three Forks play continued to spread outside of the Mountrail/Dunn County areas during 2010. With oil prices remaining relatively stable in the \$70 to \$80 per barrel price range for most of the past year, the rig count in North Dakota grew to 130 rigs as of early July 2010. Although Mountrail and Dunn counties are still very active, so are parts of Bottineau, Burke, Divide, McKenzie and Williams counties. Over the past year, more political subdivisions than ever were impacted by oil and gas development in North Dakota, and as the rig count keeps growing, so do the impacts.

Financial need was once again a main factor in determining which entities received grants this year. Many applicants that have received grants in the past were once again denied grants or received reduced grants this year. Counties and larger cities received very few grants this year. In addition, many townships that have previously received grants received reduced grants or no grant at all this year if that township had a large cash balance on hand and/or large amounts of unused grants. During the current grant round, approximately 67% of funds were allocated to transportation-related projects; while an additional 29% went to support fire and ambulance/health-related services.

I'd like to finish my testimony by making a couple of observations about the EDIO grant program in fiscal year 2010:

- Although they might not like it, I think most counties and larger cities understand that the focus
 of this program has changed. This program cannot solve the million dollar problems that many
 counties/cities are experiencing. Going forward, this program will be less about giving
 counties grants and more about working with counties to help solve the problems of the
 political subdivisions in their county.
- The larger producing counties appear to have very specific, well thought out plans for their infrastructure funds. Some of the smaller producing counties need to work to develop such plans and then communicate those plans to townships and schools.
- The \$7.8 million of infrastructure funding that was available to counties to make grants to townships and schools for fiscal year 2010 is almost double the \$4.0 million available to EDIO.
 Since infrastructure funding is based on the amount of oil produced in a given county, those counties with higher production have more money to help townships and schools.
- The legislature may want to consider changing NDCC 21-06-10, which is the law that dictates how money received through the leasing of federal lands under Lake Sakakawea is distributed. There is a small township in Mountrail County that has received more than \$4.0 million of bonuses as a result of the current formula. In addition, the New Town school district has collected more than \$22.0 million under the current formula. The formula may have made sense in the past, but with the millions of royalty and bonuses at stake now, it might be a good time to revisit the formula and its purpose.
- Although there are no official policies and rules that govern this program, the Director does
 develop guidelines and principles each year that are used to help determine who should
 receive grants. I will gladly go over the guidelines followed this year if the committee so
 desires.
- Giving away \$4.0 million per year isn't much different than giving away \$3.0 million per year.
 The amount of extra work involved was minimal. However, if funding for this program increases substantially, the nature of the program will need to change.
