

Project Background

- □ Centers of Excellence program established in 2005 to assist North Dakota's colleges and universities in collaborating with private sector businesses
 - Competitive grant program which provides grants to colleges or universities of up to one-third of the cost of joint projects with a private sector business
 - As of June 30, 2009 this program has awarded \$42.3 million to 18 Centers of Excellence across the state
- North Dakota Department of Commerce and the North Dakota Centers of Excellence Commission were tasked by the Legislative Assembly to conduct a best practice review
 - Centers of Excellence program's statute is set to expire in 2011
 - Best practice review may assist in deciding whether or not to continue a Centers of Excellence program in some form
- TPMA received competitive award in response to North Dakota Department of Commerce RPF 601.00.10



Scope of Work

- ☐ Conduct a best practice review of North Dakota's Centers of Excellence for Economic Development program
 - Review of the current Centers of Excellence program
 - Comparison to best practices of similar programs in other states
 - Identification of administrative and legislative changes necessary to implement any recommendations
- ☐ Present findings and recommendations to the North Dakota Centers of Excellence Commission and the legislative Interim Workforce Committee meeting during the Summer of 2010

Recommendation 1.0

- □ Pursue a Focused Technology-Based Economic Development (TBED) Strategy
 - Already embedded in Goal 3 of the State's new economic development plan, and is being incorporated into the plan for the State Board of Higher Education
 - We are suggesting that North Dakota leadership adopt an expanded range of strategic TBED objectives

Recommendation 2.0

- Build and Assign a Metrics Working Group to Report New Performance Measurements for the COE Program that Align with State Level TBED Metrics
 - Assign a working group to develop TBED Report Card and aligned COE metrics
 - Include reporting "average leverage" ratios to track total and industry investment leveraged by the state investment as core performance metrics for the COE program

Recommendation 3.0*

- □ Educate, Train and Provide Services in Intellectual Property (IP) Practices and Technology Transfer
 - Need guidance about rules and procedures for IP management and technology transfer
 - The Bayh-Dole Act

Recommendation 4.0

■ Monitor Federal Funding

 Each university and COE should create a very transparent system to track and report applicable federal funding that would trigger the Bayh-Dole Act provisions for specific COE projects and proposals

Recommendation 5.0

□ Adopt a more integrated statewide technology management program that can serve all campuses and COEs



Recommendation 6.0

- □ Develop a COE-based "Proof-of-Concept" Program
 - Provide small amounts of flexible funding
 - □ Help tease out commercial ideas
 - Connect university inventors
 - Encourage interactions between university researchers and industry

Recommendation 7.0

- □ Add Independent Peer Review to the COE Proposal Process
 - Likely that future proposals will require increasingly technical review
 - Pre-empt potential future political challenges
 - External feedback
 - Expose North Dakota R&D and commercialization programs to a cadre of national experts



Recommendation 8.0

□ Reassess Matching Requirements

- Reassess the 2:1 match requirement
- Provide clear guidance on permitted in-kind match

Recommendation 9.0*

□ Allow for Modest Overhead

Permit a modest overhead charge to universities on state provided COE funds (on the order of 5%-10%), since it is clear that some new costs are imposed by the COE program

Recommendation 10.0*

□ Review Reporting Requirements

- Viewed by COE Directors as onerous and time consuming
- Convene working group to seek private sector input on the best ways to collect jobs/wage data
- Need guidance on policies and procedures for contractual negotiation between parties
 Include in training program for COEs
- Streamlining, record consolidation and standardization through technology

Recommendation 11.0*

☐ Create a Targeted Eminent Scholar Program

- Flexible fund
- Focused on priority industry sectors
- Tied to existing COEs
- Linked to industrial experience/commercialization
- Criteria must be flexible, but with very high minimum standards

Recommendation 12.0

□ Create a Small Business Focused Grant Program

- Barriers to small firms exist
- Reduce match requirements for smaller firms
- Offer a separate competitive grant fund
- SBIR matching grant

Recommendation 13.0

□ Create a Federal Funding Match Initiative

- Create or reserve a portion of future COE funding for a state priority COE matching fund
- This fund would be available to help provide local match to university centers which are seeking high value federal (and perhaps foundation funded) projects that meet the highest priority state economic development objectives

Recommendation 14.0

- □ Strengthen Collaboration and Build Commercialization and Entrepreneurial Networks
 - Create networking program focused on linking COEs with firms in target clusters and key external sources of R&D, commercialization, and entrepreneurial funding and support
 - Incentivize collaboration through funding
