Chairman Skarphol: Introduced Ken.Bertsch, Commissioner of the State Seed Department.

Bertsch: Mr. Chairman and members of the committee.

Rep. Martinson: I want to thank Ken Bertsch for being short and to the point and I move a **DO PASS.** Laughter.

Chairman Skarphol: Well, Mr. Bertsch, we have a motion. Do I have a Second?

Rep. Williams: Second

Chairman Skarphol: We have a motion and a second so now we can have discussion.

Bertsch: Now I can just ask for questions. Thank you, Rep. Martinson. All the information is in attachment 1. The only discrepancy I was going to point out is the budget bill on 1022 shows an increase of \$88,000 and in reality is actually an increase of \$66,000. For some strange reason, every time my budget proposal goes out, it doesn't include the equity fund that is rolled in at the end of the session from last time. But otherwise, all of the information is laid out for you. I believe Rep. Dosch is the only one who hasn't heard my spiel. Salary information is all in my testimony and you will see that there is an increase of \$66,000. I have also included how that breaks out in terms of programs for operating expenses.

Chairman Skarphol: And these are all special funds, I mean there are no general funds at all involved in this and you are self funded with regard to that.

Bertsch: Correct, and we do have a board of directors of the seed commission.

Rep. Williams: There was a question that Rep. Delzer brought up last session. Your asking for a net increase of \$66,516. These are not state dollars, correct?

Bertsch: That is correct.

Rep. Williams: What I am asking is, how much money you have in this fund if you take the

\$66,000 out. Where does that money come from?

Bertsch: That is true.

Chairman Skarphol: You have increased revenue to cover the cost of that \$66,000 or is it

coming out of reserves?

Rep. Williams: Last session, when we got into that Rep. Delzer asked that guestion and we had to for a bit until we got that information. I am just wondering if it is reserve or

what, what happens to that fund if you take the \$66,000 out.

Bertsch: If our revenues don't met our planned expenditures, for example if you have a short year and we don't certify as many acres of seed, which happens. Our revenues can go up and down based on the number of acres we certify and the number of tests that are going on in our laboratory. If they don't reach expenditures, then they will come out of those reserves

Rep. Williams: May I ask what you have in reserves?

.Bertsch: About \$2 1/2M.

Rep. Williams: Thank you, that is what I was asking.

Chairman Skarphol: And, anticipated revenues, is that shown here?

Bertsch: Not in my testimony.

Tammy Dolan, OMB Analyst: I can answer that. She explains, according to the special funds \$2 1/2M in revenue are those appropriated which would be from the ending balance. However, the expenditures are typically less.

Chairman Skarphol: When you say typically, what does that mean? Can you give us an idea on a percentage basis.

Tammy Dolan: I wouldn't have that data.

Rep. Monson: Tammy, can you tell us, in comparison to the last biennium, how much did they start with? If you end up with 1 1/2M in reserves, that means you are going backwards by a million if they spend all that was appropriated. How were they the biennium before?

Dolan: What I have right now just shows estimated revenues for this biennium, I don't have the actual appropriations. I could get that.

Chairman Skarphol: I think the question really is, you've got 2 1/2M in reserves today. You are going to use, for purposes of discussion, half of it. Should we anticipate there becoming a problem in the future or are reserves at some point in time going back up?

Bertsch: I don't anticipate a problem. In fact, I don't anticipate going backwards by 2 1/2M in any way shape and form. In fact, our budget has always been adequate and we build it, for example, for what we call a contingency fund. That's nothing more than a saving feature in our budget. We build those kinds of things in so we can account for those variables either in yearly operating or even in cases such as, years back because of aissue where the seed department had to put out 20 or 30 people. And quickly outdistanced their budget and had to go to the emergency commission. We have room in our budget that can account for either a very busy year or a reserve that can account for that. We don't plan to spend what you provide authority for.

Rep. Monson: We don't do this for everybody.

Bertsch: I certainly appreciate that. I do understand that as a self funded budget agency with a rather small budget, we are able to stay within budget.

Rep. Williams: I call for the question.

Chairman Skarphol: We have a motion and a second to approve **HB 1022** as presented. Call the roll.

Representative Monson: That is true. This is all special funds, no general funds. These are all grower fees, no state or federal funds. They do license and register the seed after it is tested. There is no equipment to speak of. There is an increase in this budget at a total of \$88,516. Their reserves are about \$2.5M and their expected revenues are looking at about \$5.6M. Their expenditures are expected to come in about \$6.9M. There is a trend here and if the fees are not coming in as fast as they have been, this agency could see their reserves go backward. They see no need to raise fees now.

Chairman Holmberg called the committee to order on Monday, March 7, 2011 at 3:20 pm. All committee members were present. Tad H. Torgerson, OMB and Sheila M. Sandness, Legislative Council were also present.

Ken Bertsch, State Seed Commissioner and Administrator of the State Seed Department testified in favor of HB 1022 and provided written Testimony attached # 1. All my comments you can read in my testimony. We are a single line budget, which occurred back in about 2005. There are very few changes to our budget. The salary line only changes by the amount that was recommended by the governor, and as I understand the 3 and 3 that started out is now 4 and 1, but as you can see there are no changes in our budget at the present time in terms of salaries. In terms of our operating lines we have a very slight increase for operating due to some additional mandatory testing processes that we are putting in place. Our capitol line is reduced this year and the major reason is if you recall in the last budget we came and asked for a \$200,000.00 appropriation to allow us to do a building project in our graft and office which has been completed so our capital line is reduced. All the other lines in our budget which include a contingency line and a grants line remain the same from the last budget. On page 3 of my testimony you can see how our budget breaks down by programs that we operated within the department, the 5 major programs that we operate.

Chairman Holmberg asked if there are any questions. The hearing was closed on HB 1022. We may take it up tomorrow.


Regarding the audit review question requested by Legislative Council: the most recent audit of the Department contained a recommendation for creation of a financial control risk assessment process, as did most agencies. This review process is underway. Our audit was otherwise clear of any recommendations.

As you know, the Seed Department is a self-funded agency, whose budget consists (in total) of special funds and whose revenues are derived from service fees.

We have continued to outline the six major areas (salaries, operating, capital improvements, grants, contingencies) so that Appropriations committees may have a basis for comparison regarding operating functions of the agency.

The Grants line item remains at the same level. The Department grants funds to the North Dakota Crop Improvement and Seed Association for the promotion of North Dakota Certified Seed.


