Chairman Andrist opened the committee hearing on HB 1176 relating to notification by the North Dakota firefighter's association of the treasurer of each fire department or company to the auditor of each municipality.

Representative Karen Karls, District 35. Introduced and in support of HB 1176.

Renee Loh: Executive Director of the North Dakota Firefighter's Association. See written testimony #1, #2, #3.

Chairman Andrist: As I understand this and if I can paraphrase what you're saying, 18-04-08 now requests you to do something that is redundant and already being done through the State Fire Marshall.

Renee Loh: Right, it's a duplication of services. The Fire Marshall and I have visited in depth about this. We just feel it's in the states' interest and as long as the form is on the North Dakota Fire Marshall and people need to send it to him by law that we would just like to have that.

Senator Olafson: In the second to the last paragraph, on page 1, you start talking about a check being issued from the State Insurance Department to the designated bank of the rural fire department. What is that payment? All of a sudden you start talking about some payment that is apparently sent on a regular basis? What is the payment that is sent and what's the basis of that? Renee Loh: Yes, if you look at this form, it actually lists the official name of the department and all of the pertinent information. Then it is signed off by the city's auditor and the fire chief. When the Fire Marshall gets this information back, he reviews the forms and if he feels that all of the information is correct, he sends that information to the state insurance department, and then also to the North Dakota Firefighters. The reason it goes over to the insurance department is that the funding that

comes for the fire department actually comes through from the premium tax money and that is why this form goes to the insurance department and to us.

Senator Olafson: So what would be a typical payment that a rural fire department would receive from the insurance department?

Renee Loh: They all are different amounts. From this information there is a formula put in place and that amount of money then is sent out to that fire department.

Senator Olafson: Does the funding for that come from the insurance premiums we all pay? **Renee Loh**: Yes.

Jerry Hjelmstad, North Dakota League of Cities, Support for repeal of this section of HB 1176. Testimony #4. We feel it is duplication. Right now the information is provided by the Fire Marshall to the insurance department and they do send out the insurance premium tax directly to the fire districts. In response to Senator Olafson's question on how much it is. I did get a copy of the letter that the city of Norwood got from the insurance department from there fire district. That distribution amounted to \$11,495 that is distributed in September of each year.

Chairman Andrist: I suppose that would be a characteristic number, but not the same number. But do you know what it is based on? Jerry Hjelmstad: It's a portion of the fire insurance premium tax that is paid and distributed back. Chairman Andrist: I understand that, the payment. Jerry Hjelmstad: Or how they determine which amount? Chairman Andrist: Yes. Jerry Hjelmstad: No, I don't. Chairman Andrist: Based on the size of the city? Renee Loh: Right, there are all those different components.

Chairman Andrist: Anyone further wants to testify in support, opposition or in neutral for HB 1176.

Section 18-04-08: Notification of municipalities entitled to benefits.

"On or before the first day of June each year, the secretary of the North Dakota Firefighter's Association shall notify the auditor of each municipality entitled to the benefits provided in this chapter of the name of the treasurer of each department or separately organized company in good standing in the North Dakota Firefighter's Association".


18-04-05. Amount due cities, rural fire protection districts, or rural fire departments - Payments by insurance commissioner. The insurance commissioner shall compute the amounts due to the city fire departments, certified rural fire departments, or fire protection districts entitled to benefits under this chapter on or before October first of each year. The insurance commissioner shall allocate one-half of the biennial legislative appropriation for distribution under this section to each eligible city not within a fire protection district, each rural fire protection district organized under this title, and each rural fire department certified by the state fire marshal, and pay the amount allocated in September of each year. The allocation must be made in proportion to the amount of insurance company premiums received by insurance companies pursuant to section 26.1-03-17 for policies for fire, allied lines, homeowner's multiple peril, farmowner's multiple peril, commercial multiple peril, and crop hail insurance on property within the city, rural fire protection district, or area served by the certified rural fire department to the total of those premiums for those policies in the state.

18-04-06. Office of management and budget to issue warrants on state treasurer for benefits. Repealed by S.L. 1971, ch. 230, § 3.

18-04-07. Disbursement of fund by city auditor. Moneys received by the city auditor under the provisions of this chapter must be disbursed as follows:

- 1. In a city having a paid fire department, the money must be placed in a fund to be disbursed by the governing body of the municipality in maintaining the fire department. If the municipality has a duly organized and incorporated firefighters relief association, the money must be disbursed in accordance with section 18-05-04.
- 2. In a city or rural fire protection district having no paid fire department, the money must be paid over to the treasurer of the fire department, or to the treasurer of each separately organized fire company that satisfies the requirements of section 18-04-01 in equal proportions when there is more than one in the municipality or rural fire protection district, upon the written order of the department or companies approved by the governing body of the municipality or rural fire protection district. If the municipality or rural fire protection district has a duly organized and incorporated firefighters relief association, the amount must be disbursed in accordance with section 18-05-04.
- 3. For the purpose of this section, a nonpaid or volunteer fire department is any department in which less than fifty percent of the personnel of the department are full-time regularly salaried firefighters. A volunteer firefighter is a firefighter who does not receive a regular monthly salary though the firefighter may receive compensation for each fire call the firefighter responds to.

18-04-08. Notification of municipalities entitled to benefits. On or before the first day of June in each year, the secretary of the North Dakota firefighter's association shall notify the auditor of each municipality entitled to the benefits provided in this chapter of the name of the treasurer of each department or separately organized company in good standing in the North Dakota firefighter's association.

Re: Fire District Payment for District #3841 - NORTHWOOD F/P DISTRICT

North Dakota law provides that properly organized fire districts receive financial assistance in the form of an annual payment administered by the Insurance Department. This payment reflects a portion of the insurance premium tax collected from the sale of certain insurance products sold within each fire district.

The 61st Legislative Assembly began on January 6, 2009, and appropriated \$6,200,000 for the purpose of making payments to fire districts for the biennium beginning July 1, 2009, and ending June 30, 2011 (HB 1010). The \$6,200,000 (\$3,100,000 per year) is allocated based on the relationship of gross premium reported in the previous year, for each fire district, to the total gross premium reported in the previous year statewide. The formula used to determine this annual allocation for Fire District X is as follows:

(Gross Premium reported for Fire District X ÷ Statewide Gross Premium) × \$3,100,000

The Gross premium reported for your fire district in 2009 was \$1,301,916. This premium amount accounted for .3708% of the total statewide gross premium of \$351,089,411. Your payment in 2010 then is .3708% of the \$3,100,000, or \$11,495.48.

 $(\$1,301,916 \div \$351,089,411) \times \$3,100,000 = \$11,495.48$

Enclosed is a check for your share of the insurance premium tax distribution to the fire districts. Actual dollar amounts may differ slightly, due to rounding.
