Explanation or reason for introduction of bill/resolution:

Provide an appropriation to the Dept. of Veterans' Affairs for stand down events

Minutes:

Chairman Bette Grande opened the hearing on HB 1177. Rep. DeKrey was unable to come down due his testifying on another committee.

Lyle Schuchard, Chairperson, ND Administrative Committee on Veterans' Affairs, appeared in support. He handed out a poster that he had from a stand down in Bismarck last year that the law intern made a copies of and gave to committee members. Then he gave his testimony. Attachment 1.

Chairman Bette Grande: For clarification, when you are doing these stand downs and you talk about the homeless, we are looking also for really just that whole destitute group so that the CVOs can have best effort to stay in touch with them, to be able to work with them, not just on a one day thing but through the process of bringing them along. Is that not really an ultimate goal?

Lyle Schuchard: That is the goal and there is follow up like the county veteran services offices. Ron Otto and Mark Landeis are there from Burleigh County and Morton County. They had their computers there. They will get you online and if you are eligible, they will sign you up. They will follow up with you and make sure you get the help you need. The homeless shelters follow up with you. Many agencies do. That is what it is all about. You are right.

Chairman Bette Grande: If you look down this list, you will see that there are a lot of government and medical agencies. You will also see JC Penney's and some others. There are a lot of donations that go towards this. There is the outreach to the communities for the awareness. It is just not awareness to find your destitute veteran out there but you are also involving the community in to seeing and finding out exactly what is going on. We want to expand this program out to reach out to all the corners of the state and find out where our veterans are.

Rep. Bill Amerman: In your testimony you said this stand down used to be supported by the post war trust fund but those funds weren't available so you had to get this grant. Why weren't the funds available?

Lyle Schuchard: When the market down, our fund lost a lot of money. I think we were close to \$5 million in that fund at one time, and we had plenty of money to fund all of our grants and our programs. We could buy hearing aids, glasses, and dentures for our veterans. When the fund went south, we had to cut back on those programs. We cut back on a number of programs that we funded. We had \$10,000 we funded if a veteran was sued for veteran's preference and had a case. We would give up to \$10,000 to help them to resolve that. The other thing that we funded was stand downs. We would get up to \$5,000 from the post war trust fund to run the stand down.

Rep. Bill Amerman: Who administers the fund and do you know how the fund stands at this time?

Lyle Schuchard: Right now, the 4.1 million is the principal. That has to stay there. You can't spend into that. We are getting \$200,000 per biennium at \$25,000 a quarter to fund all our programs. The Treasurer's Office has been able to give us those funds right now. She said if the funds ever accumulate more through interest investments that she could give us more money, she would that. So far we have not been able to get additional funds. What we are getting is the \$200,000 and we are covering the basics with that.

Rep. Karen Rohr: I am a healthcare provider. We get lots of emails and information on veterans that are lost. Families are looking for them. I noticed this first stand down was held in San Diego, so when you put all this information in your databases, is this shared on a nationwide basis?

Lyle Schuchard: I do not believe our information is shared on a national basis. I do not know if there is an agency at a national level that collects all that information. I can find out. If there is, we certainly would want to get on that database and make sure our information is plugged into the national.

Rep. Karen Rohr: Just as a sideline on that. I have actually seen them as patients that they are even looking for their family.

Lyle Schuchard: We have never had that. One of the things we see—you know we call this homeless, but anybody that walks through the door that had a problem, we will provide assistance. What we find is trying to determine the number of homeless, because a lot of them don't want to admit that. Last fall we had somebody that went out to his car. He had a little rundown car packed full of clothes. We thought he was coming back and getting clothes, because we give clothing, \$60,000-\$70,000 worth of clothing we bring in from the government. We thought he was coming back time after time and loading up his car, so we walked over and talked to him. No he wasn't. He was living in his car. He would not put homeless on his sheet because he is embarrassed to do that.

Rep. Glen Froseth: I see in your testimony, you have a list of providers. It seems to me a program like this should be an excellent opportunity for some corporate sponsors to take

hold of and get publicity. Have you ever looked into trying to find corporate sponsors to sponsor these stand downs in various communities?

Lyle Schuchard: We have not. Right now when you go out and try and get money from companies and businesses, everybody is knocking at their door. We have tried to round up money to buy a van. We are going to have to replace vans, and that came out of the post war trust fund. We go to the Ford Motor Company to see if we can get a van donated or at least a very reduced price.

Rep. Lonny Winrich: Are you familiar with a program called Homeless Connect?

Lyle Schuchard: There is a homeless coalition. Last year we had our stand down combined with the homeless. We had both of them at the Am Vets. We had the homeless coalition upstairs and the veterans was downstairs. It got to be so big that we couldn't have it together the next year. We had to split off again. They loaded that one floor up with the same kind of sponsors and help that we did for the homeless. I think at that one there was between 700 and 800 people that came through the door.

Rep. Lonny Winrich: We have had several of them in Grand Forks too. I think the veterans' organizations have participated and helped but it is not limited to veterans.

Lyle Schuchard: Yes and it wasn't that day. It was both. Just a point, if it wasn't for the volunteers, we couldn't run these programs. There are costs there. You have to pay for the building. You have to pay for the food. We give them a noon lunch. That is probably \$2,000 right there. We have to have some security there. We probably have 30 or better volunteers that come in and really make this thing run for us.

There was no one neutral or in opposition to this bill.

The hearing was closed.

Explanation or reason for introduction of bill/resolution:

Minutes:

Chairman Bette Grande reopened the hearing on HB 1177.

Lonnie Wangen, Commissioner of Veterans Affairs, appeared. Attachment 1.

Chairman Bette Grande: For clarification, this bill that we have in front of us asking for the \$40,000, that will be a seed money that is there so when Dickinson wants to start doing the same as the way Fargo is doing it, they may incur somewhere \$4,000 to \$10,000 in cost, and they would be able to receipt that back to you? Eventually, after they have done two or three of them they would end up in the situation like Fargo where it does not require any money since it is all done now on donation basis.

Lonnie Wangen: That is correct. That is our goal to just get them started so they can be self sufficient as soon as possible.

Chairman Bette Grande: Stand downs don't necessarily have that bigger cost once community becomes involved?

Lonnie Wangen: That is correct. When the federal VA gets involved and starts providing more and more, it does help a lot. What we have had in the past, the meals and all that are usually covered, but sometimes you have to pay some vendors to come in to provide the service or purchase things you are going to give them. Down the road those start to be fundraisers that take care of that or else people donate them. Then they are self sufficient.

Rep. Lisa Meier: How many times a year does Bismarck actually have these stand down events and Fargo as well?

Lonnie Wangen: I am not sure in Bismarck. Fargo has two. They usually have a spring and a fall. It is important to do the fall one because winter is coming and we want to give them the good clothing and get them into housing.

Lyle Schuchard: We have had one every year for six years. We have one a year. As far as the cost goes for that stand down, we have been getting money from the outside for each one of those. We have not been able to get enough money locally to fund our stand down.

Rep. Lisa Meier: About how many individual veterans come to these events?

Lonnie Wangen: I believe the count that we had with Bismarck was 245. The Fargo one I did not get the count of the last one. I was at that one myself, and there had to have been over 300.

Rep. Karen Karls: You had a statistic on suicide. I didn't get the number. Could you repeat that?

Lonnie Wangen: According to Vital Records in North Dakota, since 2006 the death certificates that showed military service, there were 75. Percentage wise 2007 was probably the worst. We had 30% of the suicides in the state were veterans.

Chairman Bette Grande: Treasurer's Office, we had some questions that came up off of testimony and I would like to allow you to address those.

Rep. Bill Amerman: What kind of situation is the post war trust fund in now? Is it coming back or how are we looking on that?

Carlee McLeod, State Treasurer's Office: First, I would like to address the premise of that question. It is true that the post war trust fund did suffer some losses during that period where all trust funds across the nation dropped. We actually did quite well in comparison to similar trust funds across the country. By guite well, most suffered a 30-35% drop, and we were in between 17 and 20% during that time period. When I came to the Treasurer's Office, Treasurer Schmidt told me to dig into everything I can regarding this post war trust fund coming off that dip and do a strong legal analysis of how that fund was set up initially, how it was currently being administered, and where we need to be going with it. As we did that, we realized that how this fund was started back in the 90s, it had been administered incorrectly since then. Rather than paying out true income, we gave money to Co of VA whenever they asked. They were looking at the fund and assuming things were income when they were not. They were acceptable gross of the fund. We are guided by the Uniform Principal and Income Act which is part of the North Dakota Century Code. We did analysis of the income, determined what our income had been, and what we thought it would be. At that point we put out an office policy, gave it to Co of Veterans' Affairs, and we told them we anticipate that the income will be roughly \$200,000 in this next biennium. The previous biennium they had been given slightly under \$400,000 which was not true income. They had this limit. I believe they felt a crunch, because they had been taking in applications where they didn't really have proper spending authority. It is not that the post war trust fund is not providing the same amount of income. It is that we are all trying to deal with the change in policy that is consistent with law. Our office and Co of Veterans' Affairs have worked with the Attorney General's Office. We have had multiple meetings. I believe we are on the same page of understanding how income actually is derived and what can be used for these. In the meantime, they are trying to adjust to this

and to the needs and at that point in time, they did go through the grant process. Now they are coming to you as we move forward with our income policy. With that being said, the post war trust fund is producing pretty decent income right now. We are not seeing hits like we had in those rough market days. The status of the fund is that it is \$4,242,000 as of the end of December. We had a very good month of income. The treasurer invests the funds according to both growth and income and knowing the needs out there has invested with strong income producing funds. We hope that will continue, and we monitor it constantly to try to produce enough income. The needs of the vets weigh very heavily on the Treasurer's heart as the daughter, wife, sister, and mother of veterans, a son who just came back from Iraq not too long ago and another who will be leaving for boot camp shortly, and so she commissioned a study that a couple of analysts from NDSU have been working on to understand what the needs of future vets are or will be. We are getting very close to being able to release that. I think that will show you how the fund has been used, where it needs to be, and at that point you will have to be making some decisions. We feel comfortable right now that all the grants applications have been paid or the money that is available is what they need at this time.

Rep. Bill Amerman: Rest assured, I wasn't on any hunt of any sort, but when I read testimony that they used to get it from there and now they are unable to I just wanted an overview of how the trust fund went and I thank you very much.

Rep. Glen Froseth: Maybe just a little update on how the post war trust fund came about. I think it started out at \$5 million, didn't it? I don't know for what reason the principal was reduced. I don't really understand why the principal had been reduced even at a low rate of interest.

Carlee McLeod: The actual initial corpus of the fund was about \$4.1 or \$4.2 million. It was in 1996, I believe, that the fund in existence was created. We are right on track with the actual principal. The way that the wording of the constitution is all income has to be paid over for the benefit of veterans. Understanding the needs of the veterans, this fund has been invested to provide income to meet their needs and does not have the opportunity to grow. The Uniform Principal and Income Act defines income, and we are bound by that. This fund is not exempted. I believe that SIB does have funds that are exempted from that, but we are held to strict guidelines about what is income and we have to pay it all over.

Rep. Gary Paur: You say that the Treasurer's Office is doing a study on this whole business, right?

Carlee McLeod: Yes. We have commissioned a study on how the fund has been used and what needs will be in the future for veterans and assuming that the similar benefits would be available where we would need to grow the funds to be able to pay out that sort of income.

Rep. Gary Paur: It would appear to me to be prudent with this bill to wait until that study is probably done.

Carlee McLeod: That is up to you. The scope of the study did not analyze the stand down dollars but the grants program which is the main part of the trust fund.

Chairman Bette Grande: The stand down dollars will not be in the post war trust fund. The stand down is actually kind of anomaly of its own. It is something separate than what we want to deal with post war trust fund. We will deal with post war trust fund in another bill in a couple weeks.

The reopening of the hearing was closed.

Explanation or reason for introduction of bill/resolution:

Provide an appropriation to the Dept. of Veterans' Affairs for stand down events

Minutes:

Chairman Bette Grande started the meeting by looking at HB 1177. That is the bill where they came in and they are wanting to have money for stand downs. An amendment was presented. Attachment 1. One of the things I asked Lonnie was how much do you want to spend on each of these? How do you want to do it? He said \$5,000 maximum so that was the initial thought on that. In discussion with appropriations and how things are looking especially with the last bill we heard, we need to figure out how we are going to merge all these dollars. I believe the amendment is suppose to read Page 1, Line 5, replace \$40,000. I would like to put it at \$20,000. That gives them the opportunity to set up four more stand downs and what I am hoping that does is it tells them, also as Lonnie had said, they are trying to get this to where they are doing it with private funds so we are not utilizing every stand down in this session. Some of the communities have proven that they will do it, and I know that once they have established—they have them in two places now—if they can establish them in four more, the rest of it should start to flow for them. This is not suppose to be a payout for these stand downs like that. These are suppose to be community involvement.

Rep. Glen Froseth: The amendment reads to replace \$40,000 with \$40,000.

Chairman Bette Grande: We had a little typing error back here, and I am asking the committee to write the word \$20,000 there.

Vice Chairman Randy Boehning made a motion to accept the amendment.

Rep. Gary Paur seconded the motion.

A voice vote was taken. Motion carried.


Rep. Karen Karls made a motion for a Do Pass as amended and rerefer to appropriations.

Explanation or reason for introduction of bill/resolution:

A BILL for an Act to provide an appropriation to the department of veterans' affairs for stand down events.

Minutes:

You may make reference to "attached testimony."

Chairman Delzer: Opened discussion on HB 1177. The title was read.

Representative Bette Grande, District 41: We have asked for a set-aside of \$20,000 with \$5000 per event, to have the commissioner of veterans' affairs put forth stand downs at four locations. They would be in other areas than Fargo-Grand Forks-Bismarck, to reach out to homeless vets, that's typically the target of these stand downs. The plan is, when they do their first stand down in that community, they utilize this fund as their start up fund, up to \$5000 for the event, and after that, the community picks up the involvement and it moves to private funding.

Chairman Delzer: This is limited to \$5000, and you hope to have four or more?

Representative Grande: Correct.

Chairman Delzer: In lines 8-9 of the bill, it says 'this act is not subject to 54-44.1-11,' is

that the turnback?

Roxanne Woeste, Legislative Council: Yes, I believe so.

Chairman Delzer: Was that put in there on purpose, or is there a reason you would not want this subject to turnback?

Representative Grande: Initially they wanted to place this in the post-war trust fund, but that doesn't work to put funds in there, so this is going to be a separate account. They were hoping to hold onto it past the biennium, in case they didn't get the stand downs done, and they would continue to run from that.

Chairman Delzer: Should they not come back and ask for a reappropriation?

Representative Grande: I don't care either way.

Chairman Delzer: Questions by the committee? It's pretty self-explanatory. I would ask the Human Resources section dealing with vets affairs and the vets home take a good look at this and see how this mingles with the appropriation for that. Further questions or comments by the committee?

Representative Skarphol: I'm curious if this will be in the baseline next time around.

Chairman Delzer: Was there any questions of the bill sponsor about that?

Representative Grande: To have it as their request in their budget?

Representative Skarphol: Correct, for the next biennium should we anticipate it being part of their budget request?

Representative Grande: I'm not sure if they've ever asked for that as a budget line, but I think it would be simpler if they would. To me there's some confusion over how they do some of their bills. These come from their ACOVA, so this was not from the bill sponsor, per se. When the administrating council puts out their requests, that's what this comes from. That may not have been a part of the commissioner's budget at that time. I would forsee that being a better route for this.

Chairman Delzer: Isn't this just supposed to be start up money, and once they're done, they're supposed to be done locally going forward?

Representative Grande: That would only be seven communities, I'm not sure how many communities might want this.

Chairman Delzer: You must need a large-sized community to have an event like this to have any value to it.

Representative Grande: I would agree with that.

Representative Skarphol: Should we anticipate this to be in the baseline next time?

Tad Torgerson, Office of Management and Budget: We'd probably request some clarification in the legislation as to the intent, if it was to be continued or one time.

Chairman Delzer: Was there a request this time for any stand down money?

Torgerson: I'm not aware of any.

Representative Klein: Is this for guard or regular, or both?

Representative Grande: Every veteran would qualify to come.

Chairman Delzer: That opens a question, because in the adjutant general's budget there is a lot of money for the service centers in Bismarck and I think they're planning one for Fargo, so that may need to be looked at.

Representative Pollert: Is there an event in Fargo that was covered by the city?

Representative Grande: Correct, Fargo's been doing them for a number of years, with private funds. Bismarck has had a number of them. They have struggled with getting the private funding in Bismarck. Grand Forks has had them, mostly with private funds. They're trying to add Dickinson, Williston, Minot, at this point.

Chairman Delzer: Did you ask what the normal cost is in the Fargo area?

Representative Grande: \$4000-\$5000, including meals for the veterans. For clarity, these stand downs are really for the homeless destitute. These are not people coming to, e.g., the service center for the National Guard. We would love for them to filter through there, but this is the community outreach to those that are hard to reach, hard to convince to come into a center, but they might be willing to come in for that free lunch, then we can get their name, get them registered, get them their winter clothes they're not going to have. This is the lowest denominator.

Representative Dahl: Did they indicate how many new veterans they're signing up for services as a result of these events?

Representative Grande: I don't recall that they talked about it. At the event in Bismarck, there were 245 veterans that attended the stand down. This is a nationwide thing that the various states do with the VAs. They have about 200 of them that operate across the nation. The cost runs between \$4000-\$7000 for a stand down in Bismarck.

Chairman Delzer: Has Bismarck had one?

Representative Grande: Bismarck has had a couple.

Chairman Delzer: Further questions? We'll get some more information and take this one up later.

Chairman Delzer: Opened discussion on HB 1177. There was a handout of proposed amendment .03001. The policy committee that had this amended the bill and then voted 12-0 Do Pass. They went from \$40,000 to \$20,000 and added some language that the state treasurer had to approve the expenditures. One of the things we noticed when we had our discussion about it was it is currently not set to be turnback, and there was discussion on whether or not there should be local match.

Representative Wieland: Went over amendment .03001. Basically it puts the reporting mechanism in, and talks about a match.

Representative Dahl: Regarding the language in the third section of the amendment, regarding private matching funds, I thought there was talk of city funds being used. Would this preclude this appropriation from being used if they don't use private dollars?

Chairman Delzer: Yes it would, but the Fargo stand down is not at issue. If Fargo is doing them on their own with the private businesses, the idea behind the bill was to go in some communities where they aren't doing them, and put a little money out there to see how well or if it would work in their community. And it would require these communities not currently doing them to come up with half the money.

Representative Kaldor: I have attended only one stand down event, in Bismarck, and there were many professionals who volunteered their services. That doesn't count as part of the match. I am concerned about putting this in, as a lot of these stand down events are really dependent on a lot of people volunteering time.

Chairman Delzer: Would you feel better if it said dollar for dollar or in-kind?

House Appropriations Committee HB 1177 2/15/11 Page 2

Representative Kaldor: I would. I know a lot of people are uncomfortable with in-kind contributions, but I witnessed what they do, and it's unbelievable, to see these people providing services and spending their entire day doing that. These events are pretty important and serve a population that is sometimes very challenging to serve.

Representative Skarphol: In-kind only makes some of us uncomfortable when it comes to Centers of Excellence, I would have no difficulty incorporating in-kind here.

Representative Monson: I wouldn't have a problem counting the in-kind. How do you determine before the day how much in-kind is going to show up?

Chairman Delzer: It's like when a farmer goes to the bank and says how much he's going to make farming, we make it work.

Representative Kaldor: I think the organization scheduled the services there. I'm assuming they had this well planned in advance.

Representative Wieland: I don't have a problem adding that. I will make a motion to include that on the amendment. Up to this point it's all been financed by the cities that held these things, and I think they're very supportive anyway. I move the amendment plus the addition of the words 'in-kind.'

Representative Skarphol: Second.

Chairman Delzer: We have a motion to amend the bill with .03001, incorporating 'in-kind' as part of the match. Discussion on the motion to amend. Voice vote carries. We have the amended bill before us.

Recording error.

Representative Wieland: I move Do Pass as Amended.

Representative Pollert: Second.

If you do not meet all your financial obligations to put this on, we will pay what you can't raise. This has worked out in Bismarck and Fargo. Fargo doesn't have to ask us for funds anymore. The last time in Bismarck, they did not have to come to us for funds.

Chairman Kilzer asks, is the bill still alive?

Lonnie Wangen states it is in the Government and Veterans Affairs committee and says it's scheduled for this Friday.

Chairman Holmberg called the committee hearing to order on HB 1177. Sheila M. Sandness - Legislative Council; Lori Laschkewitsch - OMB.

Dick Dever, District 32, State Senator Testified in support of HB 1177.

I want to start by expressing my appreciation to **Carlee McLeod**, (Deputy State Treasurer) for being here on the last bill (HB 1468). I very much appreciate all the work that she and the treasurer do, particularly in support of veterans.

HB 1177 came to us initially with \$40,000 in it to support stand down events for veterans. It was amended in the House to \$20,000 and they had that go through the treasurer's office for approval of expenditure of those funds and we took that requirement out and left it at \$20,000. Veteran's stand down events currently take place in Fargo and Bismarck on an annual basis. They have an event at a location. In Bismarck, the last couple of years has been held at the Amvets in Fargo. It's grown to a point where they do it now at the Fargo Dome. They bring different resources from the community together and then invite veterans to come and most of them are needy veterans and they provide legal services, haircuts, Job Service is part. It's a wonderful event. The cost of putting one of those together is about \$5000. They are asking for \$20,000 so they can expand that across the state to four other cities. The ones in Fargo and Bismarck, having had some experience, are self-sustaining so they don't require additional money. They've gone to the Community for those funds in the past. We think that \$20,000 is reasonable. It's a good program and we'd like to see it expanded across the state. The bill requires private matching funds so it's not that we're just funding the event.

I think also the success of these events is highly a factor of the passion of the people that put it together. That's what we've seen and they've been very successful. We would encourage passage of this bill as well.

TESTIMONY ON HB 1177 - ND VETERANS COORDINATING COUNCIL.

A veteran is an individual that has signed a blank check in the amount of and up to including his or her life for their country. Good morning, my name is John L. Jacobsen. I am the Chairman of the Legislative Committee of the North Dakota Veterans Coordinating Council.

The Coordinating Council is made up of 15 members, 3 from each of the membership of the five Veterans Organizations in North Dakota:

- American Legion
- AMVETS
- Disabled American Veterans
- Veterans of Foreign Wars
- Vietnam Veterans of America

It is the policy of the Coordinating Council to support legislation that will benefit the welfare of the veterans of the State of North Dakota. The committee MUST concur totally, that is all 15 members must agree on the legislation to be supported or else it does not get the support.

In this case, the Coordinating Council cannot support HB 1177 in it's present format, but would support it if it were in the original format as an full appropriation rather than a greatly reduced amount.
