Minutes:

Chairman DeKrey: We will take a look at HB 1179.

Darold Payne: He demonstrated the racing game for the committee.

Rep. Nancy Johnson: Sponsor, support (see attached 1).

Chairman DeKrey: Thank you. Further testimony in support.

Darold Payne: I am the creator of this game, I would like your support (see attached 2). Explained the game and how the betting is handled. A race can be run in about 20-30 minutes from beginning to end (taking the bets, running the game and the \$ tally for the bet winners). No one can bet more than \$20. I designed the game to play in a nursing home where my wife is living.

Rep. Klemin: Do you have a patent, copyright or trademark for this Horse-N-Around Racing Game.

Darold Payne: Everybody always asks me about this. I am giving this to the State and I'll tell you why. My wife is at St. Luke's. I can't afford to have her, the State is paying through Medicaid and is paying for her to be there. I thought I'll give this to the State, and by making money on this it will pay for her being there. That was the object of why I designed the game.

Rep. Klemin: Have you done any research to see if anyone else has a patent, trademark or copyright on this particular game that you might be violating.

Darold Payne: I never tried, but I came up with this idea on my own. I've never even heard of anything like it. I know what you're saying, that horse racing is common. But the way this is set up, I don't think that I would even have to worry. This is not an ordinary horse race. Trinity High School has a different horse racing game.

Chairman DeKrey: Thank you. Further testimony in support.

Keith Lauer, Director of the Gaming Division for the AG's office: We found an inconsistency in lines 13 and 14 of the bill. After visiting with Mr. Payne, some language was suggested, with the previous language the maximum bet per horse was \$2.00. Well with 6 horses, that would mean a maximum of \$12 could be bet. We have the player may not bet more than \$20 on a race. We just wanted to clear up that language; that a bet is \$2.00 and keep it simple.

Chairman DeKrey: Does the AG have an opinion on the bill.

Keith Lauer: We are neutral on the bill. I would like to make one clarification of Mr. Payne's statement about gambling in a private premises being legal. Technically it's not legal, it's just that there isn't a penalty, as long as you are not wagering more than \$25. Just a clarification. The state's constitution does not allow you to authorize private gaming in homes.

Rep. Delmore: Is there any problem with the question that Rep. Klemin asked, with what other games that might be called horse racing and somebody else coming in to the state and now they'd be authorized to conduct this game, even though we have no idea what it's about.

Keith Lauer: I know that there is an electronic game out there that Bingo King has; it's an electronic bingo game that you play on special cards that has a horse race theme and I think that is probably copyrighted. The thing is with this language, it really doesn't tie it to this particular way of selecting. He mentioned dice could be used as an alternate method. I'm not sure of any patents out there on manual horse race games that I'm personally aware of, but there may be. But the way this law is written, it doesn't say it has to be run the way he's suggesting, it's just a way that he has come up with running it and it doesn't mean that dice couldn't be used too, or something else. The law is pretty generic as far as allowing the game. If there were problems with the way it was being run, I think changes could be made to make it legal too.

Chairman DeKrey: Thank you. Further testimony in support. Testimony in opposition.

Warren DeKrey, ND Council on Gambling Problems: Opposed, we already have 8 different authorized games approved. I would suggest that we already have more games approved than we need. I would request that the committee vote no on this bill.

Chairman DeKrey: Thank you. Further testimony in opposition to bill 1179. We will close the hearing. Let's take a look at HB 1179, what are the committee's wishes.

Chairman DeKrey and members of the House Judiciary Committee, for the record, my name is Nancy Johnson. I am a representative for District #37, Dickinson.

HB 1179 would include a horse racing game in the list of games currently allowed for charitable gaming. This morning the creator of the game is here to explain what the game is, how it operates and how the betting works.

He has been running the horse racing game (without the monetary bets, of course) for senior citizens and others around the Dickinson area to enthusiastic responses. After doing that he felt that perhaps others in the state would enjoy the game too. So on his own he has been perfecting the game and writing the rules and would like this opportunity to share it with you.

As you are aware, to be an acceptable game for charitable gaming it must be specified within the statute. That is why we are here, to request that you give a DO PASS recommendation to HB 1179 so that we can say...the horses are off!

Thank you, Mr. Chairman and committee members, I would stand for any questions and then it would be my pleasure to introduce Mr. Derald Payne.



How the Horse-N-Around Racing Game Works

- 1. Put six horses on one end of the race track that is divided into six lanes.
- 2. Run the rope from each horse down the track and through the end board.
- 3. Use a bingo machine to make the horses move. When you call out a number and name, the horse moves forward one nine inch space, by someone sitting at the end of the track pulling the rope, which is marked every nine inches. Return the ball into the bingo machine before drawing another ball.
- 4. Numbered bingo balls 1 thru 6 moves each of the 6 horses. Balls 7 thru 9 are Jokers. Balls 10 thru 19 also moves horse number 1. Use just the left number on the ball to figure out which horse moves. Balls 20 thru 29 moves horse number 2. The same works for horses 3 thru 6. Each horse has 11 balls to move them. Balls 70 thru 75 are also Jokers. When a Joker comes up during the race, a horse or horses Leading the race beyond the fifth space, stumbles back one space. If no horses are beyond the fifth space, the Joker does not count. If a horse makes it up to the finish line but not over, that horse cannot move back more than one space in case more Jokers come out.
- - 5. When balls 11, 22, 33, 44, 55, & 66 are drawn the corresponding horse moves two spaces instead of just one.
 - 6. If more than one Joker comes out in a row and the Leading horse or horses have not come up to the finish line, they can move all the way back to the fifth space.
 - 7. The horse has to make it nine spaces beyond the starting position, to win the race. After the horse wins the race, the Joker does not count while the remaining horses try for second and third place.
 - 8. The five bets are Win, Place, Show, Exacta, and Trifecta.
 - 9. Suggest all bets be two dollars.

How the Horse-N-Around Racing Game Works

- 1. Put six horses on one end of the race track that is divided into six lanes.
- 2. Run the rope from each horse down the track and through the end board.
- 3. Use a bingo machine to make the horses move. When you call out a number and name, the horse moves forward one nine inch space, by someone sitting at the end of the track pulling the rope, which is marked every nine inches. Return the ball into the bingo machine before drawing another ball.
- 4. Numbered bingo balls 1 thru 6 moves each of the 6 horses. Balls 7 thru 9 are Jokers. Balls 10 thru 19 also moves horse number 1. Use just the left number on the ball to figure out which horse moves. Balls 20 thru 29 moves horse number 2. The same works for horses 3 thru 6. Each horse has 11 balls to move them. Balls 70 thru 75 are also Jokers. When a Joker comes up during the race, a horse or horses <u>Leading</u> the race beyond the fifth space, stumbles back one space. If no horses are beyond the fifth space, the Joker does not count. If a horse makes it up to the finish line but not over, that horse cannot move back more than one space in case more Jokers come out.
- 5. When balls 11, 22, 33, 44, 55, & 66 are drawn the corresponding horse moves two spaces instead of just one.
- 6. If more than one Joker comes out in a row and the Leading horse or horses have not come up to the finish line, they can move all the way back to the fifth space.
- 7. The horse has to make it nine spaces beyond the starting position, to win the race. After the horse wins the race, the Joker does not count while the remaining horses try for second and third place.
- 8. The five bets are Win, Place, Show, Exacta, and Trifecta.
- 9. Suggest all bets be two dollars.
