Minutes:

Rep. Porter: We will open HB 1193.

Rep. Brandenburg: I am from district 28. HB 1193 deals with the state land in the hands of the state, in being able to sell off parcels of the land in small tracts. There is a program in place to deal with small parcels that are broken off. I don't think this bill is needed.

Rep. Porter: Are there any questions for Mr. Brandenburg? Is there further testimony in support of HB 1193? Is there any opposition to HB 1193?

Mike McEnroe: We oppose the bill. We support Rep. Brandenburg's conclusion at the end of his testimony that the bill is not needed at this time. ( see attachment 1)

Mike Donahue: I am with the North Dakota Wildlife Federation. We oppose the bill. We have had discussion with Rep. Brandenburg about it and we agree with him to kill the bill.

Mike Brand: I am Director of the Surface Land Division for the State Land Department. I think you will like the fiscal note on this one better than HB 1466 with no fiscal impact.

As Rep. Brandenburg said since 1981 the Land Board has had a policy to sell these small tracts.

Rep. Porter: Are there any questions for Mr. Brand on the policy?

Rep. Brabandt: How many of these tracts are still available?

Mike Brand: There are 45 tracts if you look on page 2 item number 1 on the list there is 1,136 acres in 45 small tracts. The board does entertain sales small tracts up to 80 acres in size. ( see attachment 2)

Rep. Porter: Is there any other testimony in opposition of HB 1193? As this we will close the hearing on HB 1193.

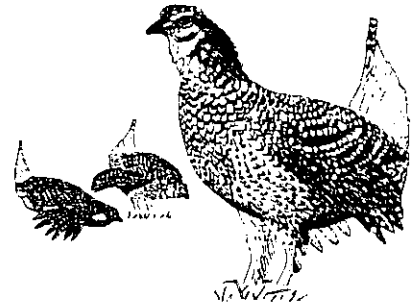

**Chairman Porter and members of the Energy and Natural Resources Committee:**

**My name is Mike McEnroe and I represent the North Dakota Chapter of The Wildlife Society. The Chapter is a professional organization made up of over 320 biologists, land managers, university educators, and law enforcement officers in the wildlife and natural resource field.**

**The Chapter opposes HB 1193 requiring the sale of small parcels of original grant ~~and~~ non-grant lands.**

**State school lands are a valuable public land resource in North Dakota. We oppose any broad-brush or wholesale approach to the sale of these lands. Further, according to the fiscal note for HB 1193, the Land Board already has policy encouraging the sale of small, severed parcels of school land.**

**We would be interested in a list of 40-acre or smaller tracts to see what the whole impact of this legislation.**

**There also seems to be an error in English-metric conversion figures in the bill. Forty acres is 16.67 hectares. 97.12 hectares amounts to 233.04 acres. It is unclear which size tract is to be included in the bill.**

**We support retaining the state school lands in public ownership. The bill is not needed, and the math error makes it unclear as to what is intended.**

**We urge a "Do not Pass" on HB 1193. Thank you for the opportunity to comment. I will answer any questions the committee may have.**

School and institutional lands were granted to the State of North Dakota at statehood solely for the support of the schools and various state institutions. The constitutional responsibility for managing these trust lands rests with the Board of University and School Lands composed of the Governor, the Secretary of State, the Attorney General, the State Treasurer and the Superintendent of Public instruction. As trustees, the land board is always open to improving and maintaining the income to the trusts.

Selling small, isolated tracts is a good idea. In fact, in 1981 the land board promulgated a policy encouraging the sale of small tracts "...which are **severed** by a highway, road, railroad, canal, river or lake..." if they are less than 80 acres in size for grassland and 40 acres in size for cropland and hay land. In addition, the land board has instructed the commissioner to entertain sales of any **isolated** tracts as shown by the Lund sale which is currently in progress. The land board and the state land department have followed these promulgated guidelines for nearly 30 years. Listed below are several recent sales and three pending sales under the current policy.

The question is not whether or not the land board would sell small, severed tracts – they will. Rather, the question is whether or not there are buyers for these tracts at their fair market value.

The sale process is driven by inquiries, generally from an adjacent landowner or the current lessee. Upon application, the tract is appraised and the applicant is notified of the minimum opening bid. All tracts are sold at public auction in the county courthouse.

The most common reason that a land sale does not proceed is that the applicant is not willing to pay the fair market value when presented with the appraised valuation. In that case, the sale does not go forward. If the applicant is willing to offer the fair market value as the opening bid and pay the sale costs, the sale can proceed.

The following observations are offered:

1. A search of our electronic database found 1,136 acres in 45 tracts ranging in size from 1.44 acres to 40 acres that would meet the criteria proposed by house bill 1193. A few more tracts would likely be found with a physical search of maps.
2. Roads and rivers do not necessarily sever a tract. Many roads especially in the west are not fenced and most rivers in North Dakota do not sever the land. Cattle cross rivers and it is less costly to fence across a river than to fence parallel to a river.
3. 97.2 hectares is equal to 239.89 acres and not 40 acres.
4. The word “shall” in the bill will not necessarily increase sales. The severed tracts anticipated by house bill 1193 are currently eligible for sale upon application.
5. The land board has a documented and positive history of selling small, severed parcels. Small tracts usually appraise higher than larger tracts so there is a financial incentive for the land board to continue to make these small, severed tracts available for sale.
6. The land board will continue to sell small, severed tracts whether or not house bill 1193 passes.
7. The issue is whether or not there is interest in purchasing a severed parcel and whether the applicant is willing to pay the fair market value as required under the constitution.

House bill 1193 will not affect the current land sale policy of the land board and will probably have minimal effect on generating sales of small, severed tracts.

The state land department believes that hb1193 is unnecessary and does not accomplish anything that is not already being done by the land board. Therefore, we are neutral.
