Rep. Kasper: I represent District 46. Last session we had a bill, I can't recall the number but it dealt with outfitters and what it did it clarified the current law that said "store like Cabela's or any other chain stores like Cabla's who refer hunting parties to outfitters in North Dakota would not be classified as outfitters. The Legislature passed that bill and we put a sunset in it to see what would happen after 2 years. Two years have passed and things have gone very well, we will have testimony later that will explain what has happened and why we are asking for the repeal.

AN ACT to amend and reenact subsection 4 of section 20.1-03-36.1 of the North Dakota Century Code, relating to licensing of outfitters; to provide an expiration date; and to declare an emergency.

BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

¹⁰⁹ **SECTION 1. AMENDMENT.** Subsection 4 of section 20.1-03-36.1 of the North Dakota Century Code is amended and reenacted as follows:

4. A license is not required for a person to provide services on real property that person owns or leases for the primary pursuit of bona fide agricultural interests ef, for a nonprofit organization registered with the secretary of state, or for a person that acts as a booking agent for a person that legally conducts business as an outfitter. A booking agent that refers an individual to an outfitter under this subsection may receive a fee or commission for the referral. The director shall determine the number of acres by county exempted from licensure by this subsection and shall publish the results. The director shall provide written information to the public on the possible liability exposure for outfitting under this subsection and on the benefits of liability insurance and proper training. For purposes of this section, a booking agent means a person that receives only a fee for referring or marketing the services of a legal outfitter in this state.

SECTION 2. EXPIRATION DATE. This Act is effective through July 31, 2011, and after that date is ineffective.

SECTION 3. EMERGENCY. This Act is declared to be an emergency measure.

SARA OTTE COLEMAN -- TOURISM DIVISION DIRECTOR, ND DEPARTMENT OF COMMERCE HB 1288

Chairman Porter and members of the House Natural Resources committee I am Sara Otte Coleman director of the Tourism Division for the North Dakota Department of Commerce and I am here today to ask for your favorable consideration of House Bill 1288.

This bill will remove the sunset on legislation you put into place last session that addressed how we classify on-line booking engines. It is important to the tourism industry for three reasons.

North Dakota's outdoor resources attracted more visitors to North Dakota in 2008 than any other type of travel according to our most recent visitor profile study. Our outdoor experiences attract 21% of our total visitors for various niches including hunting and fishing. Although we do not have recent research on the impact of hunting and fishing on our state's economy we do know that out of state visitors spent in excess of \$4.36 billion in North Dakota in 2008 and 2009. And we also know that 124,159 hunting and fishing licenses were sold to non residents during the 2009-2010 season. This impact is felt across the state but it is especially important in our rural areas.

Time and money are some of the most precious commodities. Hunting and fishing lodges, guides, outfitters and land owners wishing to offer their land for hunting often do not have the time to manage their reservations or a huge budge to market their offerings. Hiring staff is often not possible. Using a marketing company or booking agent to list their properties and manage reservation allows them to continue offering this valuable service. Booking and marketing agents are not interested in obtaining a guiding license as they do not provide that type of service.

This new legislation allows North Dakotans to compete with similar offerings in other states and provides valuable new dollars to sustain operators and many rural businesses. Since this law was changed in 2009 numerous providers are now listed with booking agents. A simple Google search will reveal dozens of opportunities for visitors to book North Dakota for their next outdoor experience.

In summary the legislation is working to help operators attract more visitors to North Dakota and I urge your support of HB 1288.
