Rep. Koppelman: Is there any estimate of what this might cost counties if they were implemented?

Rep.Devlin: I think the fiscal note is going to be very low. Per Diem is \$45 - \$62.50 or whatever and they meet quarterly or whatever so I don't think it would cost \$1000 statewide.

Chairman Johnson: This is a little bit different than the library one because the library just allowed for reimbursement of meals. It did not allow for any per diem in it, if I remember correctly.

Rep.Devlin: I thought we allowed for compensation. I think the issue was the Kidder County State's Attorney said they couldn't provide expenses or anything and I thought the committee went with compensation.

Chairman Johnson: We can check into that later.

Terry Traynor, Association of Counties: We have several counties in our association that were very interested in this bill and asked that I stand up and support the bill. Our 35 counties that have job development authority's levies. A number of the larger ones use their money to support a combination with the city job development authority. I too agree there wouldn't be a huge cost in this. I suspect that some counties would not provide reimbursement. Most of the county boards that are out there are capped out at \$45. Water board I believe is higher than that. We have never surveyed this because it was never

**Senator Cook**: I think that there should be a provision to limit the pay, a typical meeting is a 45min drive to the meeting, an hour meeting and a 45 minuet drive back. If you are going to ass it out, because they could already be being paid by someone else even if they take 2 hours off to go to a meeting.

**Senator Nelson**: The current law is 'may not receive' and the proposed change is 'may receive'.

**Senator Cook**: I am not sure if there are many other places in code that says that they will not receive compensation.

**Senator Berry**: By putting that language in there does it restrict it to people who maybe aren't being paid by someone else who need to stay at that level?

Senator Marcellais: Whose budget does it come out of?

Chairman Dever: The counties.

Senator Marcellais: Then I don't think that we should make that decision

Chairman Dever: If we wanted to put a limit on it we could put a coma at the end of that and say 'not to exceed...'

A motion was made for a do not pass by Senator Schaible with a second by Senator Cook, there was no further discussion, roll was taken and the motion passed 6-1 with Senator Schaible carrying the bill to the floor.

Good Afternoon Madam Chairman and esteemed members of the House Political Sub-divisions Committee.

For the record, I am Rep. Bill Devlin of District 23, which is a rural county in eastern ND made up of all our part of five rural counties.

I am here today as the prime sponsor of HB 1312. It is a bill providing county government right to pay per diem to members of a County Job Development Authority. It is strictly permissive language allowing the local government to make that decision if they wish. To my knowledge it is the only county related board where this isn't allowed.

It is the same situation that we dealt with earlier on library boards.

In my area, we have people that drive 20 to 30 miles each way for a Job Development Authority meeting. Sometimes they spend the whole day, sometimes half a day but other than gas and a lunch they don't get reimbursed for any of their time. Many people are probably fine with that but in other times there is a need to provide some type of compensation.

This is strictly permissive language. It doesn't mandate anything but just allows a county to be able to provide per-diem in some situations if needed.
