Minutes:

Chairman DeKrey: We will open the hearing on HCR 3037.

Rep. Lois Delmore: Sponsor, support. Explained HCR 3037. HCR 3037 suggests a study of immunity from civil and criminal liability for certain functions within our state. As this committee well aware, we've had a number of bills this session that deal with the immunity issue.

Chairman DeKrey: Thank you. Further testimony in HCR 3037.

Bill Newmann, Executive Director, ND State Bar Association: Support. We support the resolution. This started out as one or two bills introduced early on this session to try and address the issue of immunity of non-lawyer guardians ad litem. There were some drafting issues. A few people got together, Sherry Mills-Moore from the Bar Association, some folks from the Supreme Court and others, and in the process of trying to figure out what language they wanted to suggest, they found out that there were six or more different provisions out there, none of them consistent with one another. It was suggested in order to try to make some sense of it all, there should be a study resolution that would give us a chance to look at all of these different variations and try to achieve some consistency amongst all of them. We support the resolution.

Rep. Koppelman: How do you see this going, you talked about consistency. Do you think that there should be a bright line determination across the Century Code that certain groups or types of people get immunity and other don't. I know that we usually deal with this on an individual basis on the merits.

Bill Newmann: I'm not sure I understand the question because every time you grant immunity to someone, others are excluded. What I think the goal should be here, is to provide identical immunity for both law trained and non-law trained guardians ad litem in every kind of case in which guardians ad litem are asked to function. There are inconsistencies now, not only among the statutes but amongst court rules as

well. That's something else I think needs to be addressed with the other branch of government.

Rep. Koppelman: As you will note, I'm sure the resolution doesn't mention guardians ad litem specifically, it's broader than that, and that's why I was asking the more general question. As a former Supreme Court Justice, you are very familiar with sovereign immunity. Do you envision this study revisiting that question in any way.

Bill Newmann: I don't, but I'm not familiar with all of the motivation that went into the drafting of the particular language of this resolution. My understanding is that it comes about because of this confusion over guardians ad litem.

Rep. Onstad: We're really looking at the inconsistency of language. It's not going to change the granting of immunity, it's how it's read, we're trying to look at it in a more consistent basis in the language.

Bill Newmann: That's my understanding of what this interim study should be as to try to provide a consistent and extensive kind of immunity, and it's consistent in its inclusion of who is granted this immunity and who is not.

Chairman DeKrey: Thank you. Further testimony in support. Testimony in opposition to HCR 3037. We are going to close the hearing. What are the committee's wishes in regard to HCR 3037.

Rep. Delmore: I move a Do Pass and to place it on the Consent calendar.

Rep. Maragos: Second the motion.
