Sheila Dalen: President of the North Dakota County Recorders Association: Testimony Attached (1). Sheila brought 5 other written testimonies, (2-6).

Chairman Senator Klein: Asked Sheila to explain exactly what they are extracting and providing.

Sheila: Every day they record documents. In the current law we can charge for the exact image of that document. What people want now is in paper form, electronic form and on flash drives, sent up to FTP sites daily, monthly reports. We input the data in are office, all the legal descriptions the related documents associated with that. (Sheila continues with explanation.)

Chairman Senator Klein: They charge up to fifty cents for the document?

Sheila: Shows reports and types of documents that have been done. They are sometimes in electronic form, flash drive or FTP sites, four different document forms.

Senator Andrist: Is there a typical call for a lot of information?

Sheila: Several companies want it daily and some monthly. Some want all the records back as far as they go. Some want all the images and all the data. They are required to pay upfront, some are billed on a monthly bases.

Senator Andrist: What is required of your staff in your office?

Sheila: She goes through the different types of documents they provide. On a daily bases we sit and index all the information off of everyone of the documents. It is saving those entities from having to come down and get the information. They are now able to pull it and pop it into their systems.

Senator Nodland: Do you have the certified and non- certified on paper now?

Sheila: Certified copies can only be in paper form.

Senator Nodland: Can you give an idea how the work load has changed in the cast couple of years?

Sheila: We went from hand writing to the computer system. With technology you still need your people to input the data into the computer. It makes it more assessable and searchable.

Senator Laffen: You will be allowed to charge for electronic data regardless of the fashion you can charge up to fifty cents?

Sheila: Yes, no matter what form.

Senator Laffen: Will it someday be available on the web site?

Sheila: There is an access fee for downloading it from the web. So this makes it assessable in the County Recorder's office.

Ron Ness, North Dakota Petroleum Council: Representing a large portion of the customer base of the recorders. In support of the bill. Stated that we are in the electronic technology age and industry has no problem in paying the fee

Tim Pearson, Senior Vice President of the North Dakota Quarantine and Title Company: As a user of this information, they have eight different offices around North Dakota and they use it in different facets. It use to be difficult to get this information. They now can get it in digital form. It is time and cost saving for them. They now can get the information more quickly from the Registrar of Deeds office.

Chairman Keiser: Opens the hearing on SB 2168.

Aaron Birst~North Dakota Association of Counties: Introduces the bill. On the senate side there was full support.

Representative Ruby: What's an instrument?

Aaron Birst: Under the current understanding, the recorded instrument would be the pages in that recorded title.

Representative Ruby: If you are charging a dollar for that instrument, now you have to extract information, why is it less?

Aaron Birst: Less is more. We went to the counties and nobody was charging more than 50 cents.

Representative Frantsvog: Is there a limit on what subdivisions can charge?

Aaron Birst: Yes there is.

Sheila Dalen~Ward County Recorder: (See attached testimony 1).

Chairman Keiser: What are you charging for the data?

Sheila Dalen: Up to 50 cents for the data of this document.

Representative Ruby: The one with 15 pages could be up to \$15 and the other one would

be 50 cents?

Sheila Dalen: If you are purchasing a copy of the document that walked into the office, a recorder can charge up to a dollar for each page. If they want the data rather than an House Industry, Business and Labor Committee SB 2168 March 9, 2011 Page 2

image, they can purchase the data and slip it into the system and put it in the appropriate fields. That is what we are asking for in the "up to 50 cents"?

Chairman Keiser: What's a document? Is it 15 pages?

Sheila Dalen: Yes, it's 15 pages.

Chairman Keiser: I want data, so where you have complied all the data, will that be 50

cents?

Sheila Dalen: Yes.

Representative M Nelson: I assume these electronic instruments cover many more than

one document?

Sheila Dalen: Yes.

Chairman Keiser: A paper copy could be up to \$20. It's 50 cents for each of those items

in there whether it's paper or electronic?

Sheila Dalen: Correct.

Representative Clark: Once somebody buys the data, can they recreate the document

from that?

Sheila Dalen: If they purchase the data, no, they don't have the document or image and all they are taking is information data. They can place that information in their systems.

but they cannot recreate the image without getting an actual copy.

Representative Amerman: Will you come back a session or two and ask for more?

Sheila Dalen: Since there was no fee in place, we wanted to stay reasonable.

Representative Ruby: You are not even close to the dollar, what is the standard charge

for purchasing of the image?

Sheila Dalen: Across the state, there are reasons for different fees.

Representative Ruby: Do you always input the data electronically.

Sheila Dalen: Yes, everybody that has a computerized system now, it's all manually

indexed individually.

Chairman Keiser: Language says "up to" which is reasonable.

Representative N Johnson: The 40 page document, how much would that cost if you

charged the 50 cents?

Sheila Dalen: \$100.

Representative M Nelson: Do you end up liable for the correctness of the information that you are data entering?

Sheila Dalen: We have disclaimers everywhere.

Ron Ness~North Dakota Petroleum Counsel: We are large users of this and I would encourage you not to over analyze this; we think it's reasonable to charge 50 cents.

Representative Ruby: Can the data be charged separately?

Ron Ness: Currently no charge under law. This is an increase and you would be doubling the increase.

Chairman Keiser: Anyone else here to testify in support, in opposition, in the neutral position of SB 2168? Closes the hearing, what are the wishes of the committee?

Representative Ruby: Moves a Do Pass.

Representative Kreun: Second.

Chairman Keiser: Further discussion?

As the Rolette County Recorder, Colleen J Bertsch, I am requesting your support of SB 2168. We receive requests for data from numerous out-of town banks, real estate appraisers, attorneys, surveyors, collection agencies, Farm Credit Services, Farm Service Agencies, real estate agents, our local abstract company, as well as individuals.

The banks are requesting information on their own previously recorded mortgages that they may want to release, or mortgages from other lending institutions that may have a first lien.

They need the information as quickly as they can receive it to better serve their clients, and we are now able to provide that information in seconds, rather than days.

Appraisers and real estate agents are usually looking for comparable sales, and need the most up to date information we have available, because values change rapidly.

Attorneys always need the last deed of record when preparing new documents, so they are able to determine present ownership. They also may need information on any mortgages on the property. Rolette County has only one local attorney, so the surrounding area of Cando, Rughy, and Bottineau attorneys are our regular customers. They very much appreciate that they don't have to travel for an hour to receive information.

We have no local surveyors, so our corner monument records are very important information we have made available on our NDRIN website, as well as by email.

Rolette County is very much a farming community, so the information we can now instantly provide to the farm lending institutions and government service providers is an invaluable tool for them to complete their work. When farm property is sold or exchanged that changes farm program payments, and Farm Service Agencies appreciate our quick response time.
