Abednego Thomas, Board Member, Immigrant Development Center (IDC)

Testified in favor of SB 2313. Written testimony #1

Senator Bowman asked what exactly does this curtail as far as international trade. He asked him if they would be working with trade relations with other countries. Are they going to bring new products in? Are they going to export products out? Justify what this is all about.

IDC representative said this opportunity will give people who have the skills the opportunity to use these skills in this country. If a woman use to sew, she would open a store front to sew and use her talent. She said that they won't be bringing products from outside ND. We will use our talents to create new jobs.

Senator Warner asked what was in that spot or address before.

The building is called IDT and it is owned by four guys and has tenants.

Senator Warner asked if they would be displacing the tenants.

She said they would keep some of them.

Dawn Mayo, Assistant Planner, Fargo Community Development and Planning

Testified in favor of SB 2313. No written testimony.

She said that they have worked with this group for 5 years. They have a gap in funding and this bill would close the gap and allow them to sell their products. This International plaza is modeled along the same as in the Twin Cities Global Market. It is a fun place to visit and cultural ideas can be exchanged. Many new Americans arrive with the clothes on their back and this market will definitely help new Americans with job creation.

Daniel Granados, Board member of the IDC, testified in support of SB 2313. He is originally from Texas and worked in the beets and that is how he came to Fargo/Moorhead. He has lived her for the past 29 years. He grew up in Chicago and he had family entrepreneurs. He always wanted to start his own Mexican authentic restaurant. The area has never had 100% authentic Mexican restaurants. He graduated last year and has worked at Phoenix International for the last six years. He said that he has been with IDC for the last five years and has gone through training and they have their business plan ready and asked the committee to consider passing SB 2313.

Chairman Holmberg asked if this was the first time he testified before the ND legislature.

Mr. Granados replied yes.

Hadiza Asovic Murad - Cultural Diversity Resource Center

Testified in favor of SB 2313. No written testimony.

She explained her training that she received. She did training for an entrepreneur certificate. She did the research and then went to Wells Fargo and they helped with a business plan. The cost was \$200 to develop the business plan. SBA approved 80% of my \$150,000 loan. She could not come up with the rest of her loan because she had no history. She said that she was denied the Micro-loan. They told her they did not approve her loan for \$30,000 because she had no history. She said that she was just an immigrant, a first generation immigrant like your fathers and grandfathers. I want to work for my money. She said that we have the skills we just need opportunity. Let us be a healthy community members where we can create our businesses, hire our people and get them off of social services. She said that she wanted refuges to work just like she does.

Chairman Holmberg asked if the banks ever talk to her about the beginning entrepreneur loan program through bank of ND.

Discussion followed on trying to start a business and possibility of funding.

Chairman Holmberg said he would give her the contact information for the Bank of ND. He also explained to her and the group how the process would work.

Senator Wanzek asked if she still hadn't gotten her business up and running.

Ms. Murad said that after doing research, and working with local restaurants, the only obstacle was the loan. She said this is an opportunity for ND to learn more about the world. We want to bring culture and richness to the downtown. Right now it's a dead zone. We are creating jobs for our elderly and those on assistance.

Senator Wanzek asked have you run this by private business.

Hadiza Asovic-Murad answered that they have a saying, Balkans have ideas, and westerners have money. She said they cannot buy my ideas and she is trying to keep her ideas for herself.

Chairman Holmberg closed the hearing on SB 2313.

Senator Grindberg said he had some dialogue with the folks that are trying to get this off the ground. With their financial pro forma, it's difficult for this state to put funding into buying a building. He gave them his assurance that the work that will be done on the Commerce budget and any other related funding that perhaps there would be a tie there, but no promises from his view point. He told them he would not support a direct grant appropriation under the proposal they had. That would be the reason why he would vote no on this with the caveat that we will look for some options whether it's tying additional funds from the state of MN which is under way and or any local means that may be available.

Testimony of the Immigrant Development Center 15 1/2 8th ST South. Fargo, ND 58103 IN SUPPORT OF SB 2313THE GRANT-IN-STATE INTERNATIONAL GOODS TRADE CENTER BILL January 31, 2011

Senator Holmberg and Members of the Committee, thank you for this opportunity to testify in Support of Senate Bill 2313, Grant-In-State International Goods Trade Center Bill.

My name is Abednego Thomas, Board Member for the Immigrant Development Center. OR

Fowzia Adde, Executive director of the Immigrant Development Center

We are here today representing the organization to provide a background and show support for Senate Bill 2313. This bill will appropriate \$250,000 to the North Dakota Department of Commerce for completion of the International Market Plaza project in Fargo, North Dakota. This project will create a minimum of 57 new full time jobs and 16 businesses to be filled by low-income individuals, including TANF recipients, non-custodial parents, and immigrants and refugees. These jobs are in high-growth industries with wages between \$15,997 and \$31,599, offering career opportunities to earn substantial wages over time. Ultimately, this project leads to economic self-sufficiency and a reduced burden on public assistance.

The populations of immigrant were about 7%, last census increased to 10%. A 2002 study by North Dakota State University in Fargo estimated that a refugee family of four costs the taxpayers \$21,965 during the initial settlement period. That figure includes \$8,220 in Federal cash assistance, \$1,900 in food stamps, and \$11,200 in Medicaid, but does not include additional costs for education, job training, childcare and rental assistance. Assuming that only 25% of the 57 jobs created (or 14 jobs) will be filled by refugees during their settlement period the Federal government would save over \$300,000 as a result of this project.

The total cost of this project is \$965,800 and \$715,800 is currently secured. We have 16 tenants that are ready to occupy the International Market Plaza. Our financial plan demonstrates how the income generated by the tenant rents and fees cover the operational costs, including ongoing marketing activities, and wages with benefits for two cleaning and maintenance employees. Our financial plan projects income and expenses over a 7-year period and demonstrates stable profits and project sustainability. Marketing activities for

the International Market Plaza will ensure customer growth and keep costs low for the businesses.

The public and private financing for the development portion, as well as the technical assistance and management, allow us to offer the tenants below market rents and fees. These are lower costs to the businesses, as well as the International Market Plaza's ability to attract a greater number of customers as compared to a single storefront without any institutional support, result in sufficient revenue streams for each business to support their job creation plans.

As a neighborhood revitalization project, this project has key elements that support Fargo's Renaissance Zone Development Plan, those are as follows:

- Developing activity generating enterprises,
- Encouraging workable districts that integrate a wide range of activities and land uses, including cultural attractions,
- Utilize ground floor space for uses that will encourage streets to come to life shops, offices, cafes, restaurants and other "public" facilities,
- Encourage safe streets and safe neighborhoods by relying on and utilizing the "natural surveillance" of lively and active streets,
- Design spaces, facilities and features that will attract people to the area both day and night, on weekdays and weekends, and during all seasons of the year, and
- Coordinate public and private efforts to ensure that projects enhance, rather than detract from the connectivity of the area. Strong connections between people, places and things to do are vital to creating a strong sense of community.

Therefore, I urge the committee to support Senate Bill 2313 for Grant-In-State International Goods Trade Center Bill, also known as the International Market Plaza. This concludes my testimony. Thank you.
