Senator Andrist opened SB 2330, relating to fallen firefighters memorial weekend.

Senator Donald Schaible, District 31 introduced this bill and support of SB2330. See written testimony.

Senator Andrist: Could have this been accomplished by a resolution? Why did you choose to put it in a bill instead? Senator Donald Schaible: The reason I put it this is because it was brought to me the day before the deadline by firefighters across the state and I guess that was the reason. It could have been done by a resolution. I would have to say that then Governor John Hoeven suggested that we submit it as a bill. Yesterday I talked with Governor Jack Dalrymple and he also thought it was a good idea. If it should've been in a resolution I guess it would be my mistake from being a freshman. Senator Andrist: No I am not sure it is a mistake; usually these types of things do come in resolutions.

Renee Loh, Executive Director of the North Dakota of the North Dakota Firefighters Association. Supports SB 2330. When our firefighters across the state of North Dakota, are out they are risking their lives each and every day. It is not uncommon in communities for firefighters to have served almost their entire lifetime. This would be a way that we could honor them for the and good and generosity of all the hours that they have expended protecting our North Dakota communities.

Justin Adolf: President of the Professional Firefighters in North Dakota. We would also ask for do pass on this bill. Roughly 300 firefighters cover 40% of the population in the State of North Dakota and those are paid firefighters. Firefighting is a very dangerous profession that you would think would get better and safer with time. But with building construction and petroleum products it's getting more and more dangerous. We roughly lose 100 firefighters nationwide each year. We've had 5 in the state in North Dakota since 1977. But we should support those 5 that we've lost.

Senator Dotzenrod: This bill does not have in it, any dates. Is there a national, specific date or time of the year that we should expect this to be happening? **Justin Adolf**: This year in 2011, it is the 14-16 of October and it roughly falls in that same time frame every year. **Senator Dotzenrod**: The fire in Sherwood, is that where some of the five fatalities occurred?

Brooks Martin: representing the West Region Director of the Everyone Goes Home Program which is an organization under the National Fallen Firefighters Organization. I also here am in support of SB 2330 this morning. The National Fallen Fire- Fighters Foundation is an organization which was established in 1992 by congress. There sole mission is to support the families of the fallen firefighters across the United States. Every year typically the first weekend in October they honor the fallen firefighters at a national memorial service held in Emmetsburg, Maryland. This bill does in coincide with that weekend. This year because of a religious holiday, it was pushed back an additional week to accommodate that holiday. We will actually be the second weekend in October this year. A guestion on the fatalities in North Dakota, we've had 5 fatalities in the state of North Dakota since 1977 when records were started being kept. We had 2 firefighters that were killed as a result of the Sherwood, North Dakota incident; 1 who was killed Williston. North Dakota during a trailer house fire, 1 killed in Anamoose, North Dakota during a fireworks display, 1killed in Hebron, North Dakota about five years ago that died on a wild line fire from a heart attack. Those are the five deaths that we've had in our state. We are trying greatly to try and reduce our line of duty deaths across the country and across the state of North Dakota.

Senator Andrist asked for those to testify in opposition to this bill. None present. Is there anybody who wants to testify in a neutral position? None present.

Chairman Johnson: Opened the hearing on SB 2330.

Senator Schaible: (See testimony #1). I have talked to Gov. Jack Dalrymple and he is support of this also.

Rep. Koppelman: Your last comment was interesting to me because the governor's office has been before us maintaining that if any bill said the governor shall is unconstitutional.

Senator Schaible: I did talk to him about it and it was recommended why this wasn't a resolution and I guess that is the way this should come, but at the time it was brought to me that is what we did. He was in favor of the concept.

Rep. Koppelman: The legislature could declare that this week happens every year and then say the governor may issue a proclamation recognizing it so that way the legislature would be the one establishing that the week is set aside.

Senator Schaible: Any way we would get the same result if fine with us.

Justin Adolf, President of the Professional Firefighters of ND: I am here on behalf of over 300 paid firefighters in the state. We cover roughly over 40% of the population of our state. We are asking for a do pass on this bill because of sacrifices that firefighters make all across this nation. Each year we loose on average of 100 firefighters in the line of duty. Last year was a very good year. We only lost 87; which is still 87 too many. So far this year we have lost 23 firefighters in the line of duty. There have been 5 since 1977 in North Dakota. That doesn't sound like a lot but that is 5 more than we need to have. Our career is very dangerous; but a very rewarding career. We don't do it just for the money. We recognize this by putting the flag at half staff in October. This year it will be October 14th though 16. That is a way we can show them we still support their families.

Rep. Koppelman: We are all aware of 911 and the sacrifice there. Have we lost any in ND?

Justin Adolf: We lost 5 since 1977. Our firefighters are very diverse though out the state.

CJ Craven, Fire Chief of the City of Minot and the President of the ND Fire Chief's Association: I am here on behalf of the ND Fire Chief's Assoc. who represents departments of all types from volunteer to career to combination departments. We support this bill and would be happy we could resolve this in whatever manner is the best so we could recognize the fallen firefighters on the same day that we do at nationals.
