## REMARKS OF THE HONORABLE RICK BERG, UNITED STATES CONGRESSMAN

It is great to be back here at the North Dakota Legislature...back home. Thank you Mr. President, Senator Stenehjem, Senator Christmann, Senator Taylor, and Senator Schneider.

People have been asking what it's like in the US House. The most surprising thing to me is how similar it is to our process. At my first caucus, the caucus chairman worked to quiet the caucus just like here. People fight over committee assignments, office space, parking, and when the cameras are out the speeches get longer....and the cameras are always out in DC.

One of the major differences is if a bill passes one chamber, the other chamber doesn't have to take it up. In committees questions are asked by seniority. It took me two hours to ask a question at the healthcare hearing and you know how hard it was for me to stay quiet for that long.

When I was first elected to the legislature, North Dakota was facing some tough issues-hard economic times, out-migration, high taxes and a business climate that was hardly the envy of the nation. Back then, there were those in other states that wrote off North Dakota's prospects. Some went so far as to say our state wasn't good for much more than grazing animals—they called this place the "buffalo commons."

A lot has changed. Now North Dakota is known as one of the best places in America to do business. This didn't happen by accident. Our successes are in no small part due to the work done by this body. The legislature in North Dakota was proactive in its pursuit of business and job growth. We focused on creating a great business climate first. We made sure that those who wanted to start or grow a business could be assured that the rules wouldn't change on a whim. North Dakota has become a place of stability, of certainty. This attitude transformed North Dakota into what we have today...we truly are the envy of the nation.

When I first got out to Washington, DC, other congressmen would ask how come North Dakota is doing so good, that our unemployment is only 5 percent. I'd respond by saying, "You're wrong. It's only 3.5 percent."

In North Dakota, we learned long ago that we can't spend more than we bring in and we must save for a rainy day. We know that the best way to boost our economy is jobs, and that business, not the state or federal government, creates these jobs. We also learned that too much government can kill jobs and growth by creating uncertainty and overbearing regulations, scaring the private sector and creating a stagnant economy. This is the situation we are seeing across our nation, and after getting out to Washington, DC, I've found the situation is even worse than I thought.

There remains a cloud of uncertainty for our families and businesses, and this must change if we are to get America back on track. The US House of Representatives is pushing policies to reduce spending and promote an environment that creates jobs and economic growth.

Yesterday, the Congressional Budget Office reported that the nation's federal deficit will grow to nearly \$1.5 trillion this year alone. Our nation's mounting debt makes it obvious that the out-of-control government spending must stop. For you veteran legislators, you know my old charts that show ongoing spending and revenue...and the gap, when I tried for the federal budget I couldn't get it on one page.

Our federal government needs tangible, common-sense solutions to reduce federal spending and lower our national debt. They need the common sense that we have in North Dakota. Washington's current level of spending is unsustainable. Congress must set its budgetary priorities and provide the American people with confidence that Congress is serious about getting our country back on track.

In our nation's capitol, there are those who believe we can't get out of the mess we are in. To those, I say, "Look west to a state called North Dakota. If you want to know how to govern, look west from Washington to a city called Bismarck. Look west to a place called the North Dakota House of Representatives and the North Dakota Senate." The answers to our nation's problems can be found right here in North Dakota.

When I ran for this office, I said I wanted to make Washington more like North Dakota. I have thought it would be great to turn over some of these federal problems to the Republicans and Democrats in the North Dakota Legislature and I'm sure that in 80 days, we could get things done.

I am proud to say I was a member of this great body – the North Dakota Legislature.
