The Senate convened at 1:00 p.m., with President Wrigley presiding.

The prayer was offered by Pastor Rebecca Aardahl, Missouri Slope Lutheran Care Center, Bismarck.

The roll was called and all members were present except Senator Nething.

A quorum was declared by the President.

POINT OF PERSONAL PRIVILEGE

SEN. MURPHY rose on a point of personal privilege.

REMARKS OF SENATOR MURPHY

MR. PRESIDENT: It is a privilege to briefly address you and this body on this day of national pride in our leaders. I rise today to relate to you the beauty of what happened to most of our ancestors, and not so long ago. Last Friday I was in attendance at the Federal Courthouse when thirty-eight people from twenty-four countries were sworn in as new citizens.

Last week you may have noticed a statistic- that in 1940, forty percent of North Dakotans were foreign-born. I sat with four Air Force men who had traveled down to support two of their fellow servicemen joining our numbers- one from South Korea and one from Mexico. My friend, an auto mechanic from Sweden, was among them, as was an Argentine wheat researcher employed at one of our universities with his wife from Spain. Both of them were becoming naturalized as their children played in the back row. Both people from Africa came because they wanted to, from war-torn Bosnia and Yugoslavia, from China and Ukraine.

Frankly, Mr. President, I was moved as I watched them wait patiently through the ceremony. At that time, my appreciation for my country was refreshed and I wished that all of us in this room would have been there to experience the excitement of all in that room. We know that it is too often true that we don't know what we have 'til it's gone- that we take so much for granted.

As they were asked to be active citizens, Mr. President, I was proud of all our legislators for taking advantage of their rights and maximizing their participation. You and everyone here deserve to remind ourselves that we are in a special position to help these new citizens. I want to thank you and this body for being examples for our established and new citizens on this Presidents' Day.
