- Approve terminology adopted by the Public Employees Retirement System Board to comply with federal requirements (NDCC § 54-52.1-08.2)
- Receive periodic reports from the Office of Management and Budget during the 2011-12 interim on the status of implementation and administration of the compensation philosophy statement and compensation system initiatives included in House Bill No. 1031 (2011 Senate Bill No. 2015, Section 10)
