- 1033 § 3 Study issues affecting higher education, including higher education funding mechanisms and higher education budget methods
- 2351 § 2 Study the assessment of mandatory fees and fees for optional purposes or services by institutions under the control of the State Board of Higher Education, including the manner in which such fees are determined, identified, and justified and whether the programs, purposes, services, and activities supported by such fees should in fact be supported by tuition dollars, legislative appropriations, or other public or private funding sources

- Receive annual report from the State Board of Higher Education regarding the number of North Dakota academic scholarships and career and technical education scholarships provided and demographic information pertaining to the recipients (NDCC § 15-62.2-05)
- Receive report from any tribally controlled community college receiving a grant under NDCC Chapter 15-70 detailing the expenditures of the grant funds, a copy of the institution's latest audit report, and documentation of the enrollment status of students (NDCC § 15-70-05)
