Chairman Grindberg, members of the Budget Section, I am Paul Kramer, Assistant Director Fiscal Administration, for the Department of Human Services. I am here today to provide information on transfers made by the Department in excess of \$50,000 pursuant to Section 3 of 2011 Senate Bill No. 2012. The Department has made the following budget adjustments in excess of \$50,000 through September 19, 2012:
