

### **Trauma Volume at Trinity**

- 2011 1119 Patients
- 2010 861 Patients
- 2009 682 Patients
- 2008 509 Patients
- Flooding in 2011 decreased numbers for June and July. If not for the flood, Trinity would have been close to 40,000 patients in the Emergency Department this past year. 2012 Projection is over 40,000.
- Trauma Volume: Trinity has more than doubled in volume of trauma over the past 4 years.
   Most of which is relatively severe and the majority of that increase is due to oil related activity.
- Trinity has become comparable to Sanford in Fargo with essentially identical trauma volume even though the population base is much less.
