- a. A Connection for Families and Agencies has been created to provide a list of geographically indexed materials. This document is currently being updated per department practices and to meet new 2011 statute requirements. The document is a joint fiscal effort between the Department of Health (DoH) and the Department of Human Services (DHS). The DoH takes the lead on the project working with numerous partners to assure accuracy and inclusion of all agencies and services. The document is reviewed by both DoH and DHS processes before finalized, printed and distributed.
- b. The Fetal Growth and Development booklet was created in 1998 to describe the anatomical and physiological characteristics of the unborn child. This booklet is currently being updated to meet new 2011 statute requirements. The new booklet will be titled Information About Pregnancy and Abortion. Information in the booklet is objective and nonjudgmental and designed to convey accurate scientific information. Resources used in creating the booklet include peer reviewed journals (written in English and published since 2000), recent editions of textbooks and information from professional organizations.
- c. Materials regarding support obligations of the father are a new statute requirement as of 2011. This information has been included in the *Information About Pregnancy and Abortion* booklet. Resources used in creating this information were obtained through the DHS, Child Support Enforcement Division.
- d. Materials regarding abortion methods and risks are a new statute requirement as of 2011. This information has been included in the *Information About Pregnancy and Abortion* booklet. Objection information for this material was obtained through peer reviewed journals (written in English and published since 2000), recent editions of textbooks and information from professional organizations.

Note: Materials (b), (c) and (d) are combined into one booklet. Information regarding material (a) is included in the combined booklet.

- All of the above printed materials are reviewed every two years for legislative requirements and accuracy, and are updated and
 reprinted as needed. The department requests review and input of the materials by key partners before finalization of documents.
 North Dakota Family Alliance and the Red River Women's Clinic have been asked to provide review and input for the
 Information About Pregnancy and Abortion booklet.
- When producing these materials, the DoH follows N.D.C.C. Chapter 14-02.3, Limitation on Abortion, Section 14-02.3-01, state
 policy on abortion and childbirth, which states "An agency of this state may not produce, distribute, publish, disseminate, endorse
 or approve materials of any type that between normal childbirth and abortion, do not give preference, encouragement and support
 to normal childbirth."

- When printed materials are updated and reprinted, postcard and e-mail notification that the materials are available for order are sent to health-care providers, local public health units, county social service offices, Head Start, etc. Information that the materials are available on the department's website also is included. Entities and/or individuals may order by phone, e-mail or online.
 Note: Copyright royalties for unborn child pictures at two-week gestational intervals in material (b) have been paid to make these materials accessible online.
- All of the above printed materials are available at no cost from the North Dakota Department of Health upon request and in appropriate numbers to any person, facility or hospital. Administrative support staff maintain inventory and fill orders for all materials.
- Funds to support these materials are provided by the Title V Maternal and Child Health grant within the DoH. The DHS also provides funding for printing and distribution of the *A Connection for Families and Agencies* document through the Children and Family Services Division, Head Start State Collaboration Project.
- As per 2011 HB 1297, Section 16, the cost incurred by the Department of Health as a result of producing the printed information of the Abortion Control Act may not exceed fifty thousand dollars for the 2011-13 biennium.
