- 1 A BILL for an Act to provide appropriations to the department of human services and the
- 2 supreme court for guardianship services.

BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

4 SECTION 1. APPROPRIATION - DEPARTMENT OF HUMAN SERVICES - ADULT

- 5 **PROTECTION.** There is appropriated out of any moneys in the general fund in the state
- 6 treasury, not otherwise appropriated, the sum of \$1,286,415, or so much of the sum as may be
- 7 necessary, to the department of human services for the purpose of providing adult protective
- 8 services, including the assessment of the needs of vulnerable individuals, identification of
- 9 alternatives to quardianship, and the compilation and dissemination of information regarding
- 10 family and local quardianship resources, for the biennium beginning July 1, 2013, and ending
- 11 June 30, 2015. The department of human services is authorized twelve full-time equivalent
- 12 positions for this initiative.

13 SECTION 2. APPROPRIATION - DEPARTMENT OF HUMAN SERVICES - LEGAL

- 14 **COSTS.** There is appropriated out of any moneys in the general fund in the state treasury, not
- 15 otherwise appropriated, the sum of \$146,000, or so much of the sum as may be necessary, to
- 16 the department of human services for the purpose of providing for legal costs associated with
- 17 the establishment of guardianships for low-income individuals with serious mental illness, with a
- disability, or who are elderly, for the biennium beginning July 1, 2013, and ending June 30,
- 19 2015.

20 SECTION 3. APPROPRIATION - DEPARTMENT OF HUMAN SERVICES -

- 21 **GUARDIANSHIP SERVICES.** There is appropriated out of any moneys in the general fund in
- 22 the state treasury, not otherwise appropriated, the sum of \$517,000, or so much of the sum as
- 23 may be necessary, to the department of human services for the purpose of contracting with

- 1 private entities to provide guardianship services, for the biennium beginning July 1, 2013, and
- 2 ending June 30, 2015.
- 3 SECTION 4. APPROPRIATION SUPREME COURT COURT MONITORING. There is
- 4 appropriated out of any moneys in the general fund in the state treasury, not otherwise
- 5 appropriated, the sum of \$314,495, or so much of the sum as may be necessary, to the
- 6 supreme court for the purpose of providing training and technical assistance to court personnel
- 7 on guardianship-related issues and monitoring and investigating complaints against guardians,
- 8 for the biennium beginning July 1, 2013, and ending June 30, 2015. The supreme court is
- 9 authorized one full-time equivalent position for this initiative.
