1 A BILL for an Act to create and enact section 57-06-17.5 and a new subsection to section
2 57-51-02.2 of the North Dakota Century Code, relating to a new natural gas gathering and
3 collection systems property tax exemption and oil and gas gross production tax exemption; and
4 to provide an effective date.

5 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

6 **SECTION 1.** Section 57-06-17.5 of the North Dakota Century Code is created and enacted
7 as follows:

8 **57-06-17.5. New natural gas gathering and collection systems property tax**
9 **exemption.**

10 A natural gas gathering pipeline of a three-inch diameter or larger, and its associated
11 equipment, or a natural gas or natural gas liquids collection system which is initially placed in
12 service on or between January 1, 2013, and December 31, 2017, is exempt from property taxes
13 for the first taxable year after the line is initially placed in service, and the taxable valuation as
14 otherwise determined by law on the gathering pipeline or collection system and the associated
15 equipment must be reduced by:

- 16 1. Seventy-five percent for the second taxable year of operation of the transmission line.
17 2. Fifty percent for the third taxable year of operation of the transmission line.
18 3. Twenty five percent for the fourth taxable year of operation of the gathering pipeline or
19 collection system.

20 After the fourth taxable year of operation the gathering and collection systems are no longer
21 exempt, in any way, from payment of full property taxes as otherwise determined by law. For
22 purposes of this section, "initially placed in service" includes both new construction and
23 substantial expansion of a preexisting gathering or collection system, and "substantial
24 expansion" means a capacity increase of twenty percent or more. Associated equipment

1 includes compression, liquid separation facilities, and any other equipment absolutely
2 necessary to gather or collect natural gas and natural gas liquids. A "collection system" is a
3 system that collects at least seventy-five percent of the gas and natural gas liquids from the well
4 for compression to liquid for use as fuel or transport to a processing facility, production of
5 petrochemicals or fertilizer, or conversion to liquid fuels. Natural gas processing and other
6 natural gas liquid refining plants or facilities are expressly excluded from this section.

7 **SECTION 2.** A new subsection to section 57-51-02.2 of the North Dakota Century Code is
8 created and enacted as follows:

9 An operator who collects natural gas at a well site by natural gas gathering line,
10 electrical generator, or collection system described in section 38-08-06.4 shall be
11 entitled to an exemption from the tax imposed under this section for a period of one
12 year from the day the natural gas is first collected.

13 **SECTION 3. EFFECTIVE DATE.** Section 1 of this Act is effective for taxable years
14 beginning after December 31, 2012. Section 2 of this Act is effective for taxable events
15 occurring after June 30, 2013.
