

**FIRST ENGROSSMENT
with Senate Amendments
ENGROSSED HOUSE BILL NO. 1023**

Introduced by

Appropriations Committee

(At the request of the Governor)

1 A BILL for an Act to provide an appropriation for defraying the expenses of various state
2 departments and institutions; and to declare an emergency.

3 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

4 **SECTION 1. APPROPRIATION.** There is appropriated out of any moneys in the general
5 fund in the state treasury, not otherwise appropriated, the sums as hereinafter provided or so
6 much of the sums as may be necessary. These sums increase the general fund authority
7 enacted by the sixty-second legislative assembly to the stated departments and institutions of
8 the state of North Dakota for the purpose of defraying their expenses, for the period beginning
9 January 1, 2011, and ending June 30, 2013, as follows:
