

**FIRST ENGROSSMENT
with House Amendments
ENGROSSED SENATE BILL NO. 2009**

Introduced by

Appropriations Committee

(At the request of the Governor)

1 A BILL for an Act to provide an appropriation for defraying the expenses of the state fair
2 association; to provide space for highway patrol training; and to declare an emergency.

3 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

4 **SECTION 1. APPROPRIATION.** The funds provided in this section, or so much of the funds
5 as may be necessary, are appropriated out of any moneys in the general fund in the state
6 treasury, not otherwise appropriated, to the state fair association for the purpose of defraying
7 the expenses of the state fair association, for the biennium beginning July 1, 2013, and ending
8 June 30, 2015, as follows:

14 SECTION 2. ONE-TIME FUNDING - EFFECT ON BASE BUDGET - REPORT TO

15 **SIXTY-FOURTH LEGISLATIVE ASSEMBLY.** The following amounts reflect the one-time
16 funding items approved by the sixty-second legislative assembly for the 2011-13 biennium and
17 the 2013-15 one-time funding items included in the appropriation in section 1 of this Act:

20 The 2013-15 one-time funding amounts are not part of the entity's base budget for the 2015-17
21 biennium. The state fair association shall report to the appropriations committees of the
22 sixty-fourth legislative assembly on the use of the one-time funding for the biennium beginning
23 July 1, 2013, and ending June 30, 2015.

1 **SECTION 3. EMERGENCY VEHICLE OPERATIONS COURSE.** The state fair association
2 shall allow the highway patrol to use parking lot space on the state fairgrounds for an
3 emergency vehicle operations course and shall provide temporary classroom space as needed
4 for related training courses, for the biennium beginning July 1, 2013, and ending June 30, 2015.

5 **SECTION 4. EMERGENCY.** The capital assets line item in section 1 of this Act is declared
6 to be an emergency measure.
