SB 2036 updates the oil and gas tax revenue that goes into the property tax relief sustainability fund.

Section 1 provides for an increase in oil and gas tax revenues deposited in the property tax relief sustainability fund to \$403,407,000 for the 2013-15 biennium. The projected cost of the mill levy reduction grant program is \$395,622,720 for the 2013-15 biennium.
