- 1 A BILL for an Act to provide an appropriation for defraying the expenses of the agriculture
- 2 commissioner; to amend and reenact section 4-01-21 of the North Dakota Century Code,
- 3 relating to the salary of the agriculture commissioner; and to provide for transfers.

4 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

SECTION 1. APPROPRIATION. The funds provided in this section, or so much of the funds as may be necessary, are appropriated out of any moneys in the general fund in the state treasury, not otherwise appropriated, and from special funds derived from federal funds and other income, to the agriculture commissioner for the purpose of defraying the expenses of that agency, for the biennium beginning July 1, 2015, and ending June 30, 2017, as follows:

1 SECTION 2. ONE-TIME FUNDING - EFFECT ON BASE BUDGET - REPORT TO 2 SIXTY-FIFTH LEGISLATIVE ASSEMBLY. The following amounts reflect the 2015-17 one-time 3 funding items included in the appropriation in section 1 of this Act: 4 One-Time Funding Description 2013-15 <u>2015-17</u> 5 Information technology analysis \$0 \$150,222 6 Department web redesign 0 150,000 7 \$0 \$300,222 Total general fund 8 The 2015-17 one-time funding amounts are not a part of the entity's base budget for the 9 2017-19 biennium. The agriculture commissioner shall report to the appropriations committees 10 of the sixty-fifth legislative assembly on the use of this one-time funding for the biennium 11 beginning July 1, 2015, and ending June 30, 2017. 12 SECTION 3. TRANSFER - ENVIRONMENT AND RANGELAND PROTECTION FUND -13 MINOR USE PESTICIDE FUND. The agriculture commissioner shall transfer \$325,000 from the 14 environment and rangeland protection fund to the minor use pesticide fund during the biennium 15 beginning July 1, 2015, and ending June 30, 2017. 16 SECTION 4. ESTIMATED INCOME - ENVIRONMENT AND RANGELAND PROTECTION 17 **FUND.** The estimated income line item in section 1 of this Act includes the sum of \$6,464,295, 18 or so much of the sum as may be necessary, from the environment and rangeland protection 19 fund for the purpose of defraying the expenses of various department of agriculture programs, 20 for the biennium beginning July 1, 2015, and ending June 30, 2017. 21 SECTION 5. ESTIMATED INCOME - GAME AND FISH FUND. The estimated income line 22 item in section 1 of this Act includes the sum of \$499,585, or so much of the sum as may be 23 necessary, from the game and fish department operating fund for the purpose of defraying the 24 expenses of various department of agriculture programs, for the biennium beginning July 1, 25 2015, and ending June 30, 2017. 26 SECTION 6. ESTIMATED INCOME - STATE WATER COMMISSION - TRANSFER. The 27 estimated income line item in section 1 of this Act includes the sum of \$250,000 which the state 28 water commission shall transfer to the agriculture commissioner for the wildlife services 29 program, for the biennium beginning July 1, 2015, and ending June 30, 2017. 30 SECTION 7. AMENDMENT. Section 4-01-21 of the North Dakota Century Code is amended 31 and reenacted as follows:

- 2 The annual salary of the agriculture commissioner is ninety-nine thousand four hundred
- 3 thirty-five dollars through June 30, 2014, and one hundred two thousand four hundred-
- 4 eighteenone hundred six thousand five hundred fifteen dollars through June 30, 2016, and one
- 5 <u>hundred ten thousand seven hundred seventy-five</u> dollars thereafter.
