- 3. a. A parental directive is valid only if it is presented to the school district using a standardized form, prepared by the superintendent of public instruction, and signed by the student's custodial parent.
  - b. A parental directive is valid only until the conclusion of the school year in which it is received by the school district.
  - c. A parental directive submitted to a school district in accordance with this section must be retained as part of the student's educational record.
- 4. A school district is not liable for any consequences incurred by a student as a result of a parental directive submitted in accordance with this section.

- A school district is not required to provide instruction or activities for a student during the administration of any test or assessment referenced in the parental directive submitted by the student's parent.
- 6. Each school district shall post the parental directive form on its website and make the form available to a parent, upon request.
- 7. At the time and in the manner directed by the superintendent of public instruction, each school district shall provide a report regarding:
  - a. The number of parental directives received;
  - <u>b.</u> The number of parental directives applicable to students who are economically disadvantaged, students from major racial and ethnic groups, students with disabilities, and students with limited English proficiency; and

### REMARKS OF THE HONORABLE HEIDI HEITKAMP

Thank you for having me here today. It's a privilege to represent the people of North Dakota.

We have an amazing story in North Dakota. We've seen the farm and energy economies lift our state beyond compare - creating jobs, bringing in businesses, supporting revenue and growth. That is true whether corn is nine dollars a bushel or three, whether oil is one hundred dollars a barrel or twenty. Our strength has always been in our people and the land we inhabit.

So even though we have been challenged these past months with low commodity prices and high dollar values, North Dakota will continue to thrive; we always have.

That is, however, not a strategy for growth. We need to renew our goal of a strong and diverse economy. That means making sure our agriculture and energy industries continue to grow and thrive, but also that we build a strong manufacturing base, boost small businesses and startups, which represent more that 95 percent of the businesses in our state, and support other industries that will help keep our economy strong for well into the future.

The single biggest challenge policy makers will have in serving North Dakota is the development of a skilled and work ready work force.

You are currently spending millions to recruit new workers into North Dakota. I see the signs for the "good life." But slogans must reflect reality.

All that effort can be completely undone if we do not have policies in North Dakota that welcome and retain the next generation of workers. So issues that in the past have seemed irrelevant to the economic growth of our state must take center stage.

We cannot be a state that discriminates. As young and talented minds come to the realization that the work that they can do - cyber security, programming, accounting, and even medicine - can be performed anywhere in the world. We want those jobs in North Dakota.

We must support our universities and colleges, including our tribal college. It might be tempting to reduce support for higher education and research in tough times. .. that would be the wrong approach on so many levels.

We must nurture our children who are clearly our workforce of tomorrow and are getting a good start in life. I also want to take a moment to reinforce the importance of supporting Native American children in our state. All of North Dakota's citizens must be given a good start in life.

Safety must be our number one priority. We must guarantee that when called, first responders will come including ambulance, and fire and law enforcement. And we must make a pledge to rid our state of human trafficking, the practice of modern day slavery.

We must meet the mental and behavior health challenges of our society.

And we must value the rich environmental and cultural assets of our state. How do you put a value on the Elkhorn Ranch or a little Missouri vista or the view from the Pembina Gorge? These are also the inheritance of our children that should not be squandered for short term gain.

We also must continue to demand a respectful sovereign to sovereign relationship with the federal government.

The work that Congress does impacts you every day - and the budget that Congress just passed could push many federal programs onto states. The federal budget, which I didn't support, would block grant Medicaid pushing those additional costs on states like North Dakota. Those costs don't go away. It only burdens states more with the cost.

As we continue to address the Washington regulatory environment, including 111d, new source performance standards, WOTUS, and Conservation compliance.

In addition to pushing to prevent states from being burdened by programs that federal government should support, I also launched a new bipartisan initiative to help address the impact of federal regulations. Federal regulations help keep our drinking water safe, protect consumers from fraud, prevent Americans from consuming unsafe food or drugs, encourage innovation, and keep our economy running. But the federal government is big, and there are good programs that can get bogged down in unnecessary red tape. My #CutRedTape Initiative would create the first central location online for American families and businesses to voice their stories about how federal regulations impact them on a daily basis.

Thank you for having me here today. Every day in the U.S. Senate, I fight for what is best for North Dakota because our state is my top priority, over political party. I hope that each and every one of you puts the same bipartisan creed behind your work because that's what North Dakotans want and it's what they need.

- The superintendent of public instruction may not approve a project unless the school district proposing the project:
  - Demonstrates the need for the project and the educational utility of the project or demonstrates potential utilization of the project by a future reorganized school district;
  - b. In the case of new construction or a renovation affecting more than fifty percent of an existing structure's square footage, demonstrates that circumstances within the district are likely to result in a stable or increasing Demonstrates that the student population has been stable or has increased during the preceding five school years and is expected to be stable or increase during the ensuing five school years; and
  - c. Demonstrates the capacity to pay for the project under rules adopted by the superintendent of public instruction pursuant to chapter 28-32.
- a. If the superintendent of public instruction denies the project, the school board may appeal the superintendent's decision to the state board of public school education. In considering the appeal, the state board shall review:
  - (1) The need for the project;

- (2) The educational utility of the project;
- (3) The potential use of the project by a future reorganized school district:
- (4) The capacity of the district to pay for the project; and
- (5) Any other objective factors relative to the appeal.
- b. The decision of the state board is final.
- 4. This section is applicable to any construction, purchase, repair, improvement, renovation, or modernization, even if the school board pays for the project in whole or in part with moneys received on account of the leasing of lands acquired by the United States for flood control, navigation, and allied purposes in accordance with 33 U.S.C. 701c-3 or in accordance with moneys received under the American Recovery and Reinvestment Act of 2009.
- For purposes of this chapter, "facility" includes a public school parking lot, public school athletic complex, or any other improvement to real property owned by the school district."

(1) Request from the tax commissioner a statement of the estimated tax increase, in mills and dollars, which would be applicable to a residential parcel of average true and full value within the county in which the school district is headquartered, if a loan under this section and any associated school construction bond issue were to be authorized in accordance with chapter 21-03;
    - (2) Request from the tax commissioner a statement of the estimated tax increase, in mills and dollars, which would be applicable to an acre of cropland and to an acre of noncropland, of average true and full value within the county in which the school district is headquartered, if a loan under this section and any associated school construction bond issue were to be authorized in accordance with chapter 21-03;
    - (3) Publish in the official newspaper of the district the information from the statements required by this subdivision with the notice

- of the election to authorize the school construction bond issuance in accordance with section 21-03-12; and
- (4) Post on the school district's website the information from the statements required by this subdivision for at least the thirty-day period immediately preceding the date of the election to authorize the school construction bond issuance in accordance with chapter 21-03;
- Receive authorization for a bond issuance in accordance with chapter 21-03; and
- e. Submit a completed application to the Bank of North Dakota.
- 3. The Bank of North Dakota shall prioritize the applications and award loans under this section to eligible school districts during July of each year, beginning in 2015. The prioritization must be based on a consideration of:
  - a. Student occupancy and academic needs in the district;
  - b. The age of existing structures to be replaced or remodeled;
  - Building design proposals that are based on safety and vulnerability assessments;
  - d. Community support;
  - e. Cost of the project and the ability of the school district to repay the loan; and
  - f. Any other criteria established in rule by the superintendent of public instruction, after consultation with an interim committee appointed by the legislative management.
- 4. The term of a loan under this section is twenty years, unless a shorter term is requested by the board of a school district in its application.
- 5. The interest rate on a loan under this section may not exceed two percent.
- 6. The maximum loan amount to which a school district is entitled under this section is ten million dollars."

### STATEMENT OF PURPOSE OF AMENDMENT:

This amendment provides for the following:

- Creates school district construction loan program and provides program guidelines.
- Amends Section 15.1-36-01 regarding requirements for approval of school construction projects by the Superintendent of Public Instruction.
- Provides for a contingent transfer of \$100 million from the foundation aid stabilization fund to the school district construction loan fund. The transfer is contingent upon the passage of 2015 Senate Concurrent Resolution No. 4003 by the Legislative Assembly and approval of the measure by the voters of the state.
- Removes Sections 1, 2, and 5 which create a scholarship fund, provide for uses of the foundation aid stabilization fund, and provide a contingent transfer from the foundation aid stabilization fund to the scholarship fund.
