"SECTION 5. LEGISLATIVE INTENT - DIVISION OF FOOD AND LODGING LICENSE FEES. It is the intent of the sixty-fourth legislative assembly that the division of food and lodging of the state department of health, based on risk and pursuant to audit recommendations, adjust division of food and lodging license fees to generate up to \$150,000 of additional special fund revenue. SECTION 6. LEGISLATIVE MANAGEMENT STUDY - UNIVERSITY OF NORTH DAKOTA FORENSIC PATHOLOGY CENTER. During the 2015-16 interim, the legislative management shall consider studying the feasibility and desirability of the university of North Dakota acquiring the building that houses the university of North Dakota forensic pathology center. The legislative management shall report its findings and recommendations, together with any legislation required to implement the recommendations, to the sixty-fifth legislative assembly.

#### **SECTION 7. LEGISLATIVE MANAGEMENT STUDY - WASTE**

**MANAGEMENT.** During the 2015-16 interim, the legislative management shall consider studying onsite sewage disposal in the state, including areas of the state lacking environmental programs to address onsite sewage disposal, lack of uniform standards for disposal, regulation authority, and the impact of onsite sewage disposal and waste management on industry and the public. The legislative management shall report its findings and recommendations, together with any legislation required to implement the recommendations, to the sixty-fifth legislative assembly."

Make recommendations, not less than once each calendar quarter, to the board of university and school lands on grants to counties, cities, school districts, and other political subdivisions in oil and gas development impact areas based on identified needs, and other sources of revenue available to the political subdivision."

# REMARKS OF ND US SENATOR HEIDI HEITKAMP

Thank you. Thank you. I know a little bit about how extraordinarily busy you are and how important this time is for making deals and finalizing the work. And I just watched a unanimous vote, thinking boy I miss those days. I miss the days when people can sit down and actually work across the aisle and come up with a package that everybody can support and everybody can be proud that they're moving the state in the right direction. It's a feeling you don't get very often in Washington, D.C. But I will tell you how extraordinarily proud I am of representing the state. Most of you know that I am in a caucus of two. It's the "you weren't supposed to be here" caucus. According to Nate Silver, I had an 8% chance of getting elected to the United States Senate, so everybody was quite surprised and wanted to meet me right away. I used to tease them that they thought I was a unicorn, that I didn't really exist, because I was a Democrat who got elected in a state that the President lost by 21 points. I think it speaks to North Dakota's political culture that they are looking for solutions and they are looking for people who will work across the aisle, people who will resolve challenges. Every day it is an enormously gratifying sense and it motivates me every day that the state that I represent is the state of North Dakota with people who believe in working together, people who believe in meeting the challenges of actually making decisions and moving on and living to have a discussion later on.

I also have an amazing opportunity to tell the story of North Dakota every day. It's a place that has peaked a lot of curiosity. When you think about it, you think about an economy that was the fastest growing economy in the country. An economy that, the blank spot in the map, the flyover area of our country all of a sudden became center stage. We were blessed for a lot of years with high commodity prices, low dollar values, which added to our economic opportunity. Now our challenge is \$3/bushel corn, with maybe \$1 basis and some of your rural elevators and our challenge is taking a look at our uncertainty in terms of the oil patch. But what I can tell you with all that commodity uncertainty, the one thing that is not uncertain, is the quality of our people, is the opportunity we have every day to serve people who are just good, good folks. I think our strength has always been in our people and our strength has always been in the land that we inhabit. So even though we are facing these challenges of low commodity prices and high dollar values, I have no doubt, as I'm sure you don't, that North Dakota will continue to thrive, and grow and provide huge opportunities to the children that we raise here.

Hope isn't a strategy. We have to look at those things that present challenges into the future. I remember the last time I was here, I was talking about the challenge of providing housing, the challenges of providing services to this growing economy. Our challenge today, I think, is recruitment and retention of a workforce. We hear it everywhere. I could do this if I could find people. I was with an engineering firm in Fargo yesterday, asked them their biggest challenge. You would think maybe it's regulation of the government, and they said no, it's finding qualified workers. What we have to do, is I think, we have to understand that we have an opportunity not only to buy fancy ad campaigns, "The Good Life". I see the ads all over North Dakota, come to the good life. It's not enough have a slogan. We have to have reality behind that slogan. I know that "Millennials" are not "Baby Boomers" in terms of how they see opportunity and how they see how they are going to raise their kids and make a life where they live. If we really intend to retain and recruit a new workforce, we have to better understand the values and the culture of the new workforce that we are creating, because the reality is, they can go anywhere. If you want to be an accountant, you don't have to live in North Dakota to provide accountancy services. If you want to be a radiologist, guess what, you don't have to live in North Dakota to be a radiologist. If you want to write software programs for Blue Cross and Blue Shield, you don't have to live in North Dakota to do that. Their jobs are transportable. They have to want to live in our state. So how do we create that environment? I think the first thing we have to do is be welcoming. We cannot discriminate, against anyone for any reason. That is irrational. We have to have a culture of welcoming people. I think that when the message gets sent that we aren't welcoming, we do great damage, and no matter how much money you spend in an ad campaign, you can't overcome that obstacle.

I think we have to support our universities and colleges and the Tribal colleges. You know there might be a real inclination that we all have right now, given the budget constraints that you have, to pull back, and I would tell you that your inclination is to pour more. Not irrationally or wrongly, but invest in that research. Invest in those people. Invest in those opportunities. That's what's going to make the difference long-term for those economic opportunities. 95% of all business in the state of North Dakota is small business and we have a start up culture. If you don't believe me, go visit the Million Cups people. Go to an

event that I went to yesterday in Fargo where we were sitting around with people who wanted to start up new businesses and innovate. It's here, but we have to nurture it, and we have to support it. And we'll continue to fight for those federal dollars that are North Dakota's fair share of research dollars, but we have to continue to send the message that we value education. We have to nurture our children. They're the future workforce and that means Head Start. That means good quality health care. That means leaving no child without the same opportunities that all children have in our state. That means working with Native American groups, with Native American Tribal groups, to build a better opportunity for Native American kids, whether it's in Fargo or whether it's up in Turtle Mountain. They are the workforce of our future.

I think safety has to be our top priority. I've been everywhere in the state of North Dakota. We're challenged in rural areas providing fire service, providing ambulance service, providing law enforcement service, and when we stop protecting people in rural America, people will stop living in rural America. That's a challenge that we have to meet. That's a challenge that I've been working very hard on the Homeland Security Committee for us to meet that challenge.

I want to put a special plug in for behavior and mental health. Why do I say that? I have spent hours with school principals, I have spent hours with law enforcement, I have spent hours with firefighters and ambulances and you might think that they all have an issue. You know the first thing they want to talk about, they want to talk about behavior and mental health. I was sitting with a group in Fargo, where the Fargo/Moorhead Ambulance came in and they told us that they could pretty much tell me that over a very short period of time, 3 people in the Fargo/Moorhead Area who had been calling ambulance, one every other day and you had no choice, had cost that system almost a million dollars. That's a tragedy. That's a waste. That's wrong. But the worst thing about that is those people didn't get help. Because we don't have workforce and we don't have parody in mental and behavior health. Across the country and in North Dakota. And we're going to fight to make sure that we get families the help that they need, whether they're fighting addiction or whether they're fighting bipolar disease, whether they're fighting depression, whether they're fighting an epidemic of suicide. We have to do better. This is not a social issue. It's not a woman's issue. This is an economic issue. When you see the rates of problems in behavior and mental health. And so we hope that we'll be great partners.

I want to say something, too, about my experience in North Dakota. I first ran when I was 28 years old. I was driving around North Dakota, hadn't spent a lot of time looking at North Dakota. And I remember that moment when I drove up over the Pembina Gorge. I didn't even know the Pembina Gorge existed. It was early in the morning and I saw that come off and I stopped the car and I got out, 28 years old, and I said, "No matter what happens in this election, I will always remember this moment, that I saw the beauty of this spot". What's the value of that beauty? What's the value of a vista overlooking the Little Missouri? What's the value, culturally, of the Elkhorn Ranch? What are the values of these places? I will tell you with great certainty, this is the inheritance of our children. If we don't perceive the value, then we surely will sacrifice that inheritance, I think for short term gain. So, be with me, when you think about what you want your children to experience, what you want your grandchildren to experience in our state. It makes a difference and it makes a difference economically, as those "Millennials" are looking for that experience. They are going to look to states that protect that experience.

Finally, I want to say that probably the biggest challenge that I have in representing you, is trying to strike that balance between regulation that protects consumer products and keeps us safe. The regulation that allows your business to have a level playing field. That regulation that protects our clean water and our food regulation, and the regulation that doesn't make a lot of sense in America. We have been fighting a lot of the regulation that we don't think makes a lot of sense. Whether it is the greatly expanded waters of the United States. Whether it is 111D in coal country, whether it is resource performance standards. Whatever it is, we're there fighting that fight. But it is a little like "Whack-a-mole". One gets resolved, the next one crops up. The challenges continue, and literally millions and billions of dollars are spent not resolving issues in America, but in partisan and perhaps legal fights. And so I've started a project, with a friend of mine, the newest redhead to the Senate, a guy named James Langford. We're serious about this. And we've opened up a portal saying cut red tape. We are going to be looking at systematically changing the way we do regulation of the federal government. But too often what we hear from is K Street, we hear from groups like you who send us resolutions. We want to hear from Main Street. And I want you all to

really consider, as you're working with your constituents to encourage them to use that portal. I think it can make a huge difference in identifying those regulations that have long ago served their purpose or never achieved their rightful purpose.

We've got big challenges ahead of us in this country. Whether it is national security, whether it's homeland security, or whether it is economic security and responsible fiscal policy. Huge and enormous challenges. We live in an incredibly dangerous world. And we live in a world that is challenged by a new economy. But I will tell you this, there is not one day where I am not optimistic, because we are Americans. We've never given up. We've never met a challenge that we didn't think we could exceed and that goes double for us in North Dakota.

  - a. The commissioner of higher education;
  - b. The superintendent of public instruction;
  - c. The director of the department of human services;
  - d. The director of the state department of health;
  - e. A representative of the education standards and practices board;
  - f. A member of the house of representatives, appointed by the legislative management; and
  - g. A member of the senate, appointed by the legislative management.

- The membership of the advisory committee must be geographically balanced and include:
  - Representatives of public and private teacher education programs in the state;
  - Providers of behavioral health services to children under the age of eighteen;
  - Providers of mental health services to children under the age of eighteen;
  - d. Representatives of mental health advocacy organizations;
  - e. Representatives of the juvenile court;
  - f. Representatives of law enforcement; and
  - g. Representatives of Indian tribes in this state.
- 4. The committee shall meet as necessary to achieve the objective set forth in subsection 1 and shall present a report before September 1, 2016, to a committee designated by the legislative management."
