PUBLIC EMPLOYEES RETIREMENT SYSTEM

Bill Draft No. 118 decreases employee contributions under PERS for peace officers employed by the Bureau of Criminal Investigation and security officers employed by the National Guard and makes other technical adjustments

Bill Draft No. 119 increases employer and employee contributions under the PERS defined benefit and defined contribution plans

Bill Draft No. 120 provides for individual and group health insurance coverage of telehealth services

Bill Draft No. 18 provides for individuals employed by nonprofit organizations to participate in the PERS uniform group insurance program

Bill Draft No. 109 provides for firefighters employed by political subdivisions to join the public employees retirement system

SUPREME COURT

Bill Draft No. 117 provides for judges taking disability retirement under Section 54-52-17 to elect to continue participating in the uniform group insurance program
