Engrossed HB 1032 allocates an additional portion of the oil and gas gross production tax to the abandoned oil and gas well plugging and site reclamation fund, contingent upon the 'big trigger'.

Section 1 increases from \$5 million to \$7.5 million per fiscal year, the allocation to the abandoned oil and gas well plugging and site reclamation fund. Section 2 makes this contingent upon the 'big trigger' not being in effect during the period July 1, 2015 through December 31, 2015.

The January 2015 re-forecast does assume the 'big trigger' becomes effective beginning in June 2015. Therefore, consistent with the January re-forecast, the provisions of engrossed HB 1032 are assumed to not become effective.
