SB 2373 requires the owners of severed mineral interests that generate royalty payments to share in the surface owner's property taxes.

Studies indicate as much as 56% of private oil and gas royalty payments are received by persons living outside North Dakota. The net effect will be a shift of property tax burden from surface owners to severed mineral interest owners; the overall property tax liabilities will not change.
