

**FIRST ENGROSSMENT
with House Amendments
ENGROSSED SENATE BILL NO. 2023**

Introduced by

Appropriations Committee

(At the request of the Governor)

1 A BILL for an Act to provide an appropriation for defraying the expenses of various state
2 departments and institutions; and to declare an emergency.

3 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

4 **SECTION 1. APPROPRIATION.** There is appropriated out of any moneys in the general
5 fund in the state treasury, not otherwise appropriated, the sums as hereinafter provided or so
6 much of the sums as may be necessary, and from special funds derived from the disaster relief
7 fund in the state treasury. These sums increase the general fund and special fund authority
8 enacted by the sixty-third legislative assembly to the stated departments and institutions of the
9 state of North Dakota for the purpose of defraying their expenses, for the period beginning
10 January 1, 2015, and ending June 30, 2015, as follows:

28 **SECTION 2. ADJUTANT GENERAL - STATE DISASTER RELIEF FUND.** The operating
29 expenses line item in subdivision 9 of section 1 of this Act includes \$4,250,000 from the state
30 disaster relief fund.

31 **SECTION 3. EMERGENCY.** This Act is declared to be an emergency measure.
