The bill adjusts licensing and renewal fees and provides the Secretary of State with the ability to deny a license or renewal under certain circumstances. The fiscal impact is in Section 3 of the bill.

The fiscal impact is in Section 3 of the bill. The fees related to contractor licensing and renewals have not changed since 1993, 22 years. With the dramatic increase in the number of licensees, the agency's operating budget has been impacted. For example, the number of licensed contractors has increased from 5,587 on June 30, 2003 to approximately 14,300 today.

Under current law, the renewal fee for a Class D license is \$10. That amount does not cover the cost of processing the renewal and filing the associated certificate of liability insurance forms for each contractor. This bill increases the renewal fee for this license class to \$40, which will cover the administrative functions of mailing, processing, filing, etc.

It is expected that the number of issued contractor licenses will stay at approximately this level for the foreseeable future.
