**REMARKS OF MASTER CHIEF PETTY OFFICER, TIM PREABT**

We were all pleased so many North Dakotans enthusiastically and proudly came out for the commissioning. Everything was perfect, and of course the good weather you North Dakotans brought us really helped. All of us and our families and friends were honored and pleased with the wonderful party you hosted for us that evening after our commissioning.

Our crew was proud to provide a thorough tour of our boat to all those who wanted to see the workings of their attack sub. I know many North Dakotans spent an hour or more on their tours, and we enjoyed showing off what a great boat we have!

Your USS NORTH DAKOTA is now training and conducting exercises to work up for her first deployment. Rest assured NORTH DAKOTA will serve with distinction, and she will reap any threats from the deep. Through you and the great people of North Dakota, your boat will continue to draw strength from the soil.

May we always mutually cherish and support strong links binding NORTH DAKOTA with her namesake – the people and the State of North Dakota. Your continuing support throughout NORTH DAKOTA's 33 years of expected service life will inspire every submarine sailor who will sail with her into harm's way.

In token of our appreciation for your strong and loyal support, and on behalf of Captain Gordon and his crew, I am pleased to present you with this Honorary Plank Owner plaque. This plaque carries on a great Navy tradition from the days of wooden warships in which the first crew members of every US Navy warship were said to each own a plank of the ship. You have earned the proud ownership of one of our "planks."

Again, it is a great honor for me to serve as a submarine sailor in the United States Navy, and an even greater honor to have served as the first Chief of the Boat of the second warship named for our great state – the USS NORTH DAKOTA.

A surface owner may request a review of the temporarily abandoned status of a well that has been on temporarily abandoned status for at least seven years. The commission shall require notice and hearing to review the temporarily abandoned status. After notice and hearing, the surface owner may request a review of the temporarily abandoned status every two years. If none of the three preceding conditions are met, the industrial commission may require the well to be placed immediately on a single-well bond in an amount equal to the cost of plugging the well and reclaiming the well site. In setting the bond amount, the commission shall use information from recent plugging and reclamation operations. After a well has been in abandoned-well status for one year, the well's equipment, all well-related equipment at the well site, and salable oil at the well site are subject to forfeiture by the commission. If the commission exercises this authority, section 38-08-04.9 applies. After a well has

been in abandoned-well status for one year, the single-well bond referred to above, or any other bond covering the well if the single-well bond has not been obtained, is subject to forfeiture by the commission.

**SECTION 5. AMENDMENT.** Subsection 6 of section 38-08-04 of the North Dakota Century Code is amended and reenacted as follows:

6. To provide for the confidentiality of well data reported to the commission if requested in writing by those reporting the data for a period not to exceed six months. However, the commission shall release:

The industrial commission shall contract with the energy and environmental research center to compile the information and the center shall work with the department of mineral resources to analyze the existing regulations on construction and monitoring of produced water pipelines and provide a report with recommendations to the industrial commission and the energy development and transmission committee by December 1, 2015. The industrial commission shall adopt the necessary administrative rules necessary to improve produced water pipeline safety and integrity. In addition, the industrial commission shall contract for a pilot project on pipeline flow monitoring to evaluate a working leak detection system."

The state department of health shall license commercial oilfield special waste recyclers and may charge a license fee established by rule commensurate with the cost to the department of licensing and inspections. As a condition of obtaining and maintaining a license, a commercial oilfield special waste recycler and each recycling facility licensed under this chapter must extract and convert to a beneficial use at least sixty-five percent by weight of the solid oilfield special waste received by the recycler or recycling facility.

The health council shall adopt rules under chapter 28-32 governing operations of commercial oilfield special waste recyclers. The rules must be adopted to assure compliance with federal and state laws and rules for protection of the

state's water and air and public health in the handling and subsequent use of oilfield special waste.

1. Upon presentation of official credentials, an employee authorized by the state department of health may:
  - a. Examine the premises and facilities and copy books, papers, records, memoranda, or data of a commercial oilfield special waste recycler.
  - b. Enter upon public or private property for the purpose of taking action authorized by this chapter and rules adopted under this chapter, including obtaining information from any person, conducting surveys and investigations, and taking corrective action.
  - c. The commercial oilfield special waste recycler is liable for the cost of any inspection and corrective action required by the state department of health.
2. As a condition of licensure, the state department of health may require that a commercial oilfield special waste recycler must post a bond payable to the state in a sufficient amount for remediation of any release or disposal of oilfield special waste in violation of the rules of the department, on the premises or property of the facility or at a place where treated or untreated materials from the facility are taken for use or disposal.
3. As used in this section:
  - a. "Commercial oilfield special waste recycler" means a commercial recycling facility licensed under this chapter for extraction of reusable solids and fluids from any or all types of oilfield special waste.
  - b. "Drilling operation" means oil and gas drilling and production operations and any associated activities that generate oilfield special waste.
  - c. "Oilfield special waste" means waste associated with oil and gas drilling operations, exploration, development, or production and specifically includes drill cuttings, saltwater, and other solids and fluids from drilling operations.
4. Upon delivery of oilfield special waste to a commercial oilfield special waste recycler, which is licensed under this section and is not affiliated with the well operator; acceptance of the oilfield special waste by the recycler; and after the oilfield special waste has been treated and converted to a beneficial use as a usable product or legitimate substitute for a usable product, the well operator is not liable in any civil or criminal action for any subsequent claim or charge regarding the material converted to a beneficial use.

**SECTION 2. APPROPRIATION.** There is appropriated out of any moneys in the general fund in the state treasury, not otherwise appropriated, the sum of \$150,000, or so much of the sum as may be necessary, to the state department of health for the purpose of increased staffing needs to assist in completion of the department's duties to develop and adopt rules, conduct inspections, and perform other duties under section 23-29-04.2, for the biennium beginning July 1, 2015, and ending June 30, 2017. The state department of health is authorized one full-time equivalent position for this purpose."
