  - a. Each member of the legislative assembly is entitled to receive reimbursement for lodging, which may not exceed per calendar month the amount established under this subdivision by the director of the office of management and budget for lodging in state and which may not exceed the rate provided in section 44-08-04 for each calendar day during the period of any organizational, special, or regular session. On August first of each even-numbered year, the director of the office of management and budget shall set the maximum monthly reimbursement for the subsequent two-year period at an amount equal to thirty times seventy percent of the daily lodging reimbursement in effect on that date as provided under subdivision d of subsection 2 of section 44-08-04.
  - b. Notwithstanding subdivision a:
    - (1) A member of the legislative assembly may elect to be reimbursed for less than the amount to which the legislator is entitled under this subsection by claiming the lesser amount on a voucher submitted with the receipt required by section 44-08-04.
    - (2) The legislative management may establish guidelines that may result in a reduced maximum reimbursement for a single dwelling in which two or more legislators share lodging and the total rent for that dwelling exceeds the amount to which a legislator is entitled under subdivision a.
3.
  - a. Members of the legislative assembly who receive reimbursement for lodging are also entitled to reimbursement for travel for not to exceed one round trip taken during any calendar week, or portion of a week, the legislative assembly is in session, between their residences and the place of meeting of the legislative assembly, at the rate provided for state employees with the additional limitation that reimbursement for travel by common carrier may be only at the cost of coach fare and may not exceed one and one-half times the amount the member would be entitled to receive as mileage reimbursement for travel by motor vehicle.
  - b. A member of the legislative assembly who does not receive reimbursement for lodging and whose place of residence in the legislative district that the member represents is not within the city of Bismarck is entitled to reimbursement at the rate provided for state employees for necessary travel for not to exceed one round trip taken per day between the residence and the place of meeting of the legislative assembly when it is in session and may receive reimbursement for lodging at the place of meeting of the legislative assembly as provided in section 44-08-04 for each calendar day for which round trip travel reimbursement is not claimed, provided that the total reimbursement may not exceed the maximum monthly reimbursement allowed under subdivision a of subsection 2.
4. The amount to which each legislator is entitled must be paid following the organizational session in December and following each month during a regular or special session.

5. If during a special session, the legislative assembly adjourns for more than three days, a member of the legislative assembly is entitled to receive compensation during those days only while in attendance at a standing committee if the legislator is a member of that committee, a majority or minority leader, or a legislator who is not on that committee but who has the approval of a majority or minority leader to attend.
6. A day, or portion of a day, spent in traveling to or returning from an organizational, special, or regular session or a legislative committee meeting must be included as a calendar day during a legislative session or as a day of a legislative committee meeting for the purposes of this section.
7.
  - a. In addition, each member is entitled to receive during the term for which the member was elected, as compensation for the execution of public duties during the biennium, the sum of four hundred ~~eighty-~~ninety-five dollars a month, paid monthly.
  - b. If a member dies or resigns from office during the member's term, the member may be paid only the allowances provided for in this section for the period for which the member was actually a member.
  - c. The majority and minority leaders of the house and senate and the chairman of the legislative management, if the chairman is not a majority or minority leader, are each entitled to receive as compensation, in addition to any other compensation or expense reimbursement provided by law, the sum of three hundred ~~forty-~~fifty-five dollars per month during the biennium for their execution of public duties.
8. Attendance at any organizational, special, or regular session of the legislative assembly by any member is a conclusive presumption of entitlement as set out in this section and compensation and expense allowances must be excluded from gross income for income tax purposes to the extent permitted for federal income tax purposes under section 127 of the Economic Recovery Tax Act of 1981 [Pub. L. 97-34; 95 Stat. 202; 26 U.S.C. 162(i)].
9. Before each regular legislative session, the legislative management shall make recommendations and submit any necessary legislation to adjust legislative compensation amounts."

Provided, however, that when the interest sought to be acquired is a right of way for any project authorized in this chapter for which federal funds have been appropriated or state funds approved by the legislative assembly for a specific project have been appropriated, the district, after making a written offer to purchase the right of way and depositing the amount of the offer with the clerk of the district court of the county wherein the right of way is located, may thereupon take immediate possession of the right of way, as authorized by section 16 of article I of the Constitution of North Dakota. Within thirty days after notice has been given in writing to the landowner by the clerk of the district court that a deposit has been made for the taking of a right of way as authorized in this subsection, the owner of the property taken may appeal to the district court by serving a notice of appeal upon the acquiring agency, and the matter must be tried at the next regular or special term of court with a jury unless a jury be waived, in the manner prescribed for trials under chapter 32-15.

**SECTION 2. AMENDMENT.** Section 61-16.1-53.1 of the North Dakota Century Code is amended and reenacted as follows:

**61-16.1-53.1. Appeal of board decisions - State engineer review - Closing of noncomplying dams, dikes, or other devices for water conservation, flood control, regulation, and watershed improvement.**

1. The board shall make the decision required by section 61-16.1-53 within a reasonable time, not exceeding one hundred twenty days, after receiving the complaint. The board shall notify all parties of its decision by certified mail. ~~The Any aggrieved party may appeal the board's decision may be appealed to the state engineer by any aggrieved party.~~ The appeal to the state engineer must be made within thirty days from the date notice of the board's decision has been received. The appeal must be made by submitting a written notice to the state engineer, which must specifically set forth the reason why ~~the appealing party believes~~ the board's decision is erroneous. The appealing party shall also submit copies of the written appeal notice to the board and to all nonappealing parties. Upon receipt of this notice the board, if it has ordered removal of

- a dam, dike, or other device, is relieved of its obligation to procure the removal of the dam, dike, or other device. The state engineer shall handle the appeal by conducting an independent investigation and making an independent determination of the matter. The state engineer may enter property affected by the complaint ~~for the purpose of investigating to investigate~~ the complaint.
2. If the board fails to investigate and make a determination concerning the complaint within a reasonable time, not exceeding one hundred twenty days, the person filing the complaint may file the complaint with the state engineer within one hundred fifty days of the submittal date of the original complaint. The state engineer shall, without reference to chapter 28-32, ~~shall~~ cause the investigation and determination to be made, either by action against the board, or by ~~personally~~ conducting the investigation and ~~personally~~ making the determination.
  3. If the state engineer determines that a dam, dike, or other device has been constructed or established by a landowner or tenant contrary to title 61 or any rules adopted by the board, the state engineer shall take one of these three actions:
    1. a. Notify the landowner by certified mail at the landowner's post-office address of record;
    2. b. Return the matter to the jurisdiction of the board along with the investigation report; or
    3. c. Forward the dam, dike, or other device complaint and investigation report to the state's attorney.
  4. If the state engineer decides to notify the landowner, the notice must specify the nature and extent of the noncompliance and ~~must~~ state that if the dam, dike, or other device is not removed within ~~such a~~ reasonable time as determined by the state engineer ~~determines~~, but not less than thirty days, the state engineer shall procure the removal of the dam, dike, or other device and assess the cost of removal against the responsible landowner's property ~~of the responsible landowner~~. The notice from the state engineer must state that, within fifteen days of the date the notice is mailed, the affected landowner may demand, in writing, a hearing on the matter. Upon receipt of the demand, the state engineer shall set a hearing date within fifteen days from the date the demand is received. If, in the opinion of the state engineer, more than one landowner or tenant has been responsible, the costs may be assessed on a pro rata basis in proportion to the responsibility of the landowners. Upon assessment of costs, the state engineer shall certify the assessment to the county auditor of the county where the noncomplying dam, dike, or other device is located. The county auditor shall extend the assessment against the property assessed. Each assessment must be collected and paid as other property taxes are collected and paid. Assessments collected must be deposited with the state treasurer and ~~are hereby appropriated out of the state treasury and must be~~ credited to the contract fund established by section 61-02-64.1. Any person aggrieved by action of the state engineer under this section may appeal the decision of the state engineer to the district court ~~in accordance with~~ under chapter 28-32. A hearing by the state engineer as provided for in this section is a prerequisite to ~~such an~~ appeal.
  5. If the state engineer, after completing the investigation required under this section, decides to return the matter to the board, a complete copy of the investigation report must be forwarded to the board and it must include the nature and extent of the noncompliance. Upon having the matter returned to its jurisdiction, the board shall carry out the state engineer's decision ~~in accordance with~~ under the terms of this section.

6. If the state engineer, after completing the investigation required under this section, decides to forward the dam, dike, or other device complaint to the state's attorney, a complete copy of the investigation report must also be forwarded, which must include the nature and extent of the noncompliance. The state's attorney shall prosecute the complaint ~~in accordance with~~ under the statutory responsibilities prescribed in chapter 11-16.

7. In addition to the penalty imposed by the court ~~in the event of~~ on conviction under this statute, the court shall order the dam, dike, or other device removed within ~~such a~~ reasonable time period as the court determines, but not less than thirty days. If the dam, dike, or other device is not removed within the time prescribed by the court, the court shall procure the removal of the dam, dike, or other device, and assess the cost thereof against the property of the landowner responsible, in the same manner as other assessments under chapter 61-16.1 are levied. If, in the opinion of the court, more than one landowner or tenant has been responsible, the costs may be assessed on a pro rata basis in proportion to the responsibility of the landowners."

**SECTION 1.** Chapter 61-42 of the North Dakota Century Code is created and enacted as follows:

**61-42-01. Missouri River empower advisory council - Generally.**

The Missouri River comprises the vast majority of surface water flow in the state and is essential for providing the water supply for people, industry, irrigation, agriculture, energy, fish and wildlife, and recreational opportunities. A Missouri River empower advisory council is established to create a unified vision and voice for North Dakota and its stakeholders regarding the use and management of the Missouri River, and to advise the governor, legislative assembly, and state agencies on issues concerning the Missouri River.

**61-42-02. Members - Terms - Expenses.**

1. The following voting stakeholder members of the council must be appointed by the governor:
  - a. A representative of recreation;
  - b. A representative of irrigation;
  - c. A representative of cities;
  - d. A representative of regional rural water systems;
  - e. A representative of agriculture;
  - f. A representative of energy;
  - g. A representative of environment and conservation;
  - h. A representative of the Garrison Diversion Conservancy District;
  - i. Two at-large representatives;
  - j. Three county representatives, each representing counties along the Missouri River, one representing counties along the free flowing reach of the Missouri River, one representing counties bordering Lake Sakakawea, and one representing counties bordering Lake Oahe; and
  - k. The governor's designee.
2. Additional voting members of the council must include:
  - a. The chairman of the Three Affiliated Tribes of the Fort Berthold Reservation, or designee;
  - b. The chairman of the Standing Rock Sioux Tribe, or designee; and
  - c. The chairman of the Trenton Indian service area, or designee.

3. The following entities may be represented on the council, but are nonvoting members:
  - a. A legislator, appointed by the legislative management;
  - b. The director of the game and fish department, or designee;
  - c. The director of the parks and recreation department, or designee;
  - d. The state engineer, or designee;
  - e. The state health officer, or designee;
  - f. The commissioner of the department of commerce, or designee;
  - g. The director of the Indian affairs commission, or designee;
  - h. The commissioner of the department of trust lands, or designee;
  - i. The director of the oil and gas division, or designee; and
  - j. The commissioner of the department of agriculture, or designee.
4. All other state agencies shall provide assistance to the council as requested.
5. All appointed members shall serve for a term of four years or until their successors are appointed and qualified. Terms expire on the first day of July. The terms of appointed members must be staggered so that the terms of at least four members expire each year. Appointed members may be reappointed for additional terms and serve at the pleasure of the governor.
6. The governor or the governor's designee is chairman of the council.
7. The members of the council are entitled to receive mileage and expenses at the rates and under the terms as provided by law for state employees. The state water commission shall pay the expenses of council members.
8. The state water commission shall provide staffing and support services to the council.

**61-42-03. Duties - Report to legislative assembly.**

1. The council shall hold meetings at least twice per year, or as often as the chairman deems necessary. The meetings must be open to the public and provide an opportunity for the public to present issues or concerns to the council. The council shall provide the governor, legislative assembly, and state agencies with recommendations related to issues needing to be studied or addressed and relating to the protection and use of the Missouri River and operations of the reservoirs. The council shall gather input to build consensus, collaboration, and partnership opportunities to promote and advocate for North Dakota and its stakeholders' rights and interests in the Missouri River. The council shall recommend ways to strengthen the state's working relationship with the United States army corps of engineers, in order to improve the state's negotiating position with the United States army corps of engineers.
2. The county and stakeholder representatives shall work to understand and represent grassroots efforts being undertaken by organizations and individuals.
3. Any recommendations developed by the council must receive support from ten voting members before submission to the governor, legislative assembly, or state agencies.

4. The council may establish working groups and collaborate with organizations to make recommendations or accomplish objectives to protect all interests and rights of North Dakota and stakeholders in the Missouri River. This includes the eight authorized purposes identified in the Flood Control Act of 1944 and implemented by the United States army corps of engineers in their master manual, along with erosion and sedimentation, the management of federal lands, and any other existing or potentially beneficial uses.
5. The council shall report accomplishments, ongoing activities, and potential legislation to the legislative assembly."

1. The director of the office of management and budget shall control, manage, and maintain the state office building. The building must be considered a part of the state capitol building within the meaning of statutes relating to the custody, maintenance, and control of the state capitol building and grounds, and within the meaning of statutes requiring state departments or agencies to maintain their offices in the state capitol building.
2. Except as otherwise provided by law, the director of the office of management and budget has charge and control of the executive mansion, the capitol, and the park and public grounds connected therewith. Except as provided by sections 39-10-48, 39-10-50, 44-08-18, and 54-21-17.1, the director may adopt rules to promote the health, safety, and general welfare, to prohibit disturbances and disorderly assemblies, to keep the peace, and to regulate nuisances on the capitol grounds and in any of the buildings located on the capitol grounds. The rules may include regulation of public assemblies and accessibility to the

buildings and grounds, obstructions, fees, insurance, forms, indemnification by users, and waiver of insurance and indemnity requirements by the director. A person who violates a rule adopted by the director under this section is guilty of an infraction.

3. If an individual is allowed by a state agency housed on the capitol grounds to bring an infant to work, the office of management and budget shall provide the individual a temporary permit or use some other means that allow the individual to park in any parking area in which a member of the public is allowed to park, not including parking for the mobility impaired, emergency or fire zones, or zones for which another permit is required, on the capitol grounds for the time the individual is allowed to bring an infant to work."

**SB 2335:** A BILL for an Act to amend and reenact section 43-17-41 of the North Dakota Century Code, relating to the duty of a physician to report certain injuries.

Was read the first time and referred to the **Human Services Committee**.

**SB 2337:** A BILL for an Act to amend and reenact subsection 10 of section 57-51.1-03 of the North Dakota Century Code, relating to an oil extraction tax exemption; and to provide an effective date.

Was read the first time and referred to the **Finance and Taxation Committee**.

**SB 2339:** A BILL for an Act to amend and reenact paragraph 2 of subdivision a of subsection 15 of section 57-02-08 of the North Dakota Century Code, relating to the inclusion of buildings used in agritourism within the property tax exemption for farm buildings; and to provide an effective date.

Was read the first time and referred to the **Finance and Taxation Committee**.

**SB 2346:** A BILL for an Act to amend and reenact section 37-14-18 of the North Dakota Century Code, relating to county veterans' service officers.

Was read the first time and referred to the **Government and Veterans Affairs Committee**.

**SB 2347:** A BILL for an Act to amend and reenact section 49-23-01 and subsection 3 of section 49-23-05 of the North Dakota Century Code, relating to the removal of marking materials at excavation sites.

Was read the first time and referred to the **Industry, Business and Labor Committee**.

**SB 2348:** A BILL for an Act to amend and reenact section 32-03.1-02.3 of the North Dakota

Century Code, relating to training in the use of automated external defibrillators.  
Was read the first time and referred to the **Human Services Committee**.

**SB 2349:** A BILL for an Act to amend and reenact section 57-38-30 and subsection 1 of section 57-38-30.3, relating to reduction of the individual and corporation income tax rates; and to provide an effective date.  
Was read the first time and referred to the **Finance and Taxation Committee**.

**SB 2352:** A BILL for an Act to amend and reenact section 39-10-47 of the North Dakota Century Code, relating to vehicles obstructing highways; and to amend and reenact section 39-10-48 of the North Dakota Century Code, relating to vehicles illegally parked on highways.  
Was read the first time and referred to the **Transportation Committee**.

**SB 2357:** A BILL for an Act to create and enact section 12.1-17-07.2 and a new section to chapter 32-03 of the North Dakota Century Code, relating to the distribution of graphic or intimate images of someone without consent; and to provide a penalty.  
Was read the first time and referred to the **Judiciary Committee**.

**SB 2358:** A BILL for an Act to authorize the department of human services to convey land in Walsh County.  
Was read the first time and referred to the **Human Services Committee**.

**SB 2363:** A BILL for an Act to amend and reenact subsection 5 of section 57-40.3-04 of the North Dakota Century Code, relating to a motor vehicle excise tax exemption for transfer of a motor vehicle without consideration from grandparent to grandchild; and to provide an effective date.  
Was read the first time and referred to the **Transportation Committee**.

**SB 2364:** A BILL for an Act to amend and reenact subsections 1 and 2 of section 54-59-25, subsections 1 and 2 of section 54-59-26, and section 54-59-29 of the North Dakota Century Code, relating to the health information technology loan fund and confidential health information; and to repeal section 6-09-42 of the North Dakota Century Code, relating to the health information technology loan fund.  
Was read the first time and referred to the **Human Services Committee**.

**SB 2367:** A BILL for an Act to provide for the creation of a task force on substance exposed newborns; and to provide for a report to the legislative management.  
Was read the first time and referred to the **Human Services Committee**.

**SB 2371:** A BILL for an Act to create and enact subsection 30 to section 40-05-02 of the North Dakota Century Code, relating to the authority of a city council or board of city commissioners to establish administrative boards.  
Was read the first time and referred to the **Political Subdivisions Committee**.

#### **FIRST READING OF SENATE CONCURRENT RESOLUTIONS**

**SCR 4001:** A concurrent resolution directing the Legislative Management to study the financial reports required by law to be compiled and filed by political subdivisions to determine whether they are being used to full advantage and whether they should be improved, consolidated, or eliminated.  
Was read the first time and referred to the **Political Subdivisions Committee**.

**SCR 4002:** A concurrent resolution directing the Legislative Management to study statutory usage of various references to political subdivisions and the feasibility of differentiating references to political subdivisions based on whether the governing body is elected or appointed.  
Was read the first time and referred to the **Political Subdivisions Committee**.

**SCR 4003:** A concurrent resolution to amend and reenact section 24 of article X of the Constitution of North Dakota, relating to the foundation aid stabilization fund.  
Was read the first time and referred to the **Education Committee**.

**SCR 4005:** A concurrent resolution directing the Legislative Management to study judicial issues related to behavioral health, including 24-hour hold, termination of parental rights, and court committals.

Was read the first time and referred to the **Judiciary Committee**.

**SCR 4007:** A concurrent resolution directing the Legislative Management to study the feasibility and desirability of implementing a Results First Initiative program evaluation process in North Dakota.

Was read the first time and referred to the **Appropriations Committee**.

**SCR 4010:** A concurrent resolution to amend and reenact section 5 of article IV of the Constitution of North Dakota, relating to residency requirements of members of the legislative assembly.

Was read the first time and referred to the **Government and Veterans Affairs Committee**.

**SCR 4016:** A concurrent resolution urging Congress and the President of the United States to direct the federal Food and Drug Administration to allow the use of experimental medications to treat Pantothenate kinase-associated neurodegeneration (PKAN) for the benefit of the three children of the Kulsrud family living in Grace City, North Dakota.

Was read the first time and referred to the **Human Services Committee**.

**SCR 4017:** A concurrent resolution urging the United States Senate Committee on the Judiciary to support S. 2536, the Stop Advertising Victims of Exploitation (SAVE) Act, to provide for more stringent inquiry into the age and circumstances of those whose availability is being advertised on websites that facilitate human trafficking.

Was read the first time and referred to the **Judiciary Committee**.

**SCR 4019:** A concurrent resolution directing the Legislative Management to study the feasibility and desirability of utilizing state funds to provide health insurance, workers' compensation insurance, or other benefits to volunteer firefighters, volunteer emergency medical service personnel, and volunteer ambulance workers across the state, including determining whether the community volunteers would be covered in the case of an accident or injury, the scope and conditions of coverage, and the overall cost to insure community volunteers.

Was read the first time and referred to the **Political Subdivisions Committee**.
