The House convened at 1:00 p.m., with Speaker Belter presiding.

The prayer was offered by Rep. Kathy Hogan.

The roll was called and all members were present except Representative Frantsvog.

A quorum was declared by the Speaker.

POINT OF PERSONAL PRIVILEGE

REP. LOUSER rose on a point of personal privilege.

REMARKS OF REPRESENTATIVE LOUSER

MR. SPEAKER: Two weeks ago, I had the privilege of recognizing two state champions from Minot High School and today, I'm proud to have a second opportunity to recognize another champion from the same school. Last week Representative Klein spoke about the Bishop Ryan girls' basketball title team. As an aside, Ryan's Hannah Stewart was awarded the prestigious Miss Basketball Award on Saturday night.

Later Saturday night, the Minot High boys' basketball team won an epic and hard fought victory against rival Bismarck Century to cap an extremely successful season that saw the Magicians ranked at the top of the state and ran through their schedule with a 26 and 1 record.

The Magi were led by tournament MVP and most outstanding senior athlete Dakota Halvorson and all-tournament Brayden Lund. In the championship game, quiet leader Ben Bolinske led the team with 20 points, the best performance of his career in the biggest game of his life. Coach Dean Winczewski won his third title overall as a head coach.

Every state tournament, the committee recognizes the 25 year and 50 year anniversary title teams. Players from the 1965 and 1990 title teams attended championship night; both were from Minot High School. When referencing the hockey and gymnastics titles two weeks ago, I mentioned the Magician Tradition. The Minot High boys' basketball program holds the state record for tournament appearances at 74 and state titles at 16. So, does the 2015 compare well to the 1965, the 1990 or any other title teams? It's great the discussions are happening, but the real point is, this year's version of the Magi have been added to the fraternity of champions, and we congratulate the athletes, coaches, families, and fans...you've made a community very proud of our kids.

REMARKS OF REPRESENTATIVE KASPER

MR. SPEAKER: Members of the Assembly: The number one ranked Fargo Shanley Deacons girls' basketball team defeated Bismarck Century Saturday at the Fargo Dome by a score of 46-38 to win the Class A state girls' championship. Shanley finished the season 27-0 to take its unbeaten streak to 43 games. With this win, the Deacons successfully defended their state Class A championship from 2014.

Shanley head coach Tim Jacobson said, "We won't really feel it until next week or next year.

As long as I have been coaching, this season was unbelievable in that a group of young ladies could stay so calm and focused. They kept believing in what we were doing."

Shanley was led by its standout juniors - all state guard Sarah Jacobson and forward Lauren Rotunda. Jacobson scored 22 points in the championship game and was named tournament MVP. Rotunda and Jacobson were joined by Alivia Fraase on the all-tournament team. Coach Tim Jacobson was named Class A Coach of the Year.

BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

SECTION 1. TASK FORCE - SCHOOL DISTRICT BOUNDARIES.

1. The legislative management shall consider creating a task force to study issues related to school district boundaries, including the feasibility and desirability of maintaining existing boundaries; the parameters currently governing annexation, reorganization, and dissolution processes; and options for instituting boundary changes in the case of significant educational or financial impacts.

2. A task force created under this section is governed by Senate Bill No. 2300, as approved by the sixty-fourth legislative assembly."

BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

SECTION 1. Section 5-01-22 of the North Dakota Century Code is created and enacted as follows:

5-01-22. Powdered alcohol products prohibited - Penalty - Exceptions.

1. As used in this section, "powdered alcohol product" means any alcohol prepared or sold in a powder form for either direct use or reconstitution in a liquid beverage or food.
2. A person may not sell, offer to sell, purchase, offer to purchase, possess, or consume a powdered alcohol product.
3. A violation of this section is a class B misdemeanor.
4. This section does not apply to the use of powdered alcohol products for research by a:
 - a. Health care provider that operates primarily for the purpose of conducting scientific research;
 - b. State institution;
 - c. Private college or university; or
 - d. Pharmaceutical or biotechnology company."
