**REPORT OF PROCEDURAL COMMITTEE**

**FIRST READING OF SENATE BILL**

**SB 2379:** A BILL for an Act to provide for the reduction of general fund appropriation authority; to authorize transfers from the budget stabilization fund and the Bank of North Dakota; to provide appropriations for the department of human services and the department of corrections and rehabilitation; to provide for reports; to provide legislative intent; and to provide an effective date.

Was read the first time and referred to the **Appropriations Committee**.

**REPORT OF STANDING COMMITTEE**

**SB 2379: Appropriations Committee (Rep. Delzer, Chairman)** recommends **DO PASS** (16 YEAS, 4 NAYS, 3 ABSENT AND NOT VOTING). SB 2379 was placed on the Fourteenth order on the calendar.
