## BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

**SECTION 1. AMENDMENT.** Section 38-08-01 of the North Dakota Century Code is amended and reenacted as follows:

# 38-08-01. Declaration of Oil and gas policy.

It is hereby declared to be in the public interest to foster, to encourage, and to promoteregulate the development, production, and utilization of natural resources of oil and gas in the state in such a manner as will prevent waste; to authorize and to provide for the operation and development of oil and gas properties in such a manner that a greater ultimate recovery of oil and gas be had and that the correlative

rights of all owners be fully protected; and to encourage and to authorize cycling, recycling, pressure maintenance, and secondary recovery operations in order that the greatest possible economic recovery of oil and gas be obtained within the state to the end that the landowners, the royalty owners, the producers, and the general public realize and enjoy the greatest possible good from these vital natural resources."

- SB 2343: Energy and Natural Resources Committee (Sen. Schaible, Chairman) recommends AMENDMENTS AS FOLLOWS and when so amended, recommends DO PASS and BE REREFERRED to the Appropriations Committee (5 YEAS, 2 NAYS, 0 ABSENT AND NOT VOTING). SB 2343 was placed on the Sixth order on the calendar.
- Page 1, line 1, after "A BILL" replace the remainder of the bill with "for an Act to create and enact a new section to chapter 54-17 of the North Dakota Century Code, relating to a report on the fiscal impact of certain orders by the industrial commission to the legislative assembly or budget section; and to provide for retroactive application.

## BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

**SECTION 1.** A new section to chapter 54-17 of the North Dakota Century Code is created and enacted as follows:

Report to legislative assembly or budget section on the fiscal impact of certain orders of the industrial commission.

If the industrial commission makes an order that has a fiscal effect or estimated fiscal effect on the state in excess of five million dollars in a biennium, the industrial commission shall report to the legislative assembly when in session and otherwise to the budget section of the legislative management on the fiscal impact of the effect of the order on state revenues and expenditures, including any effect on the funds of the industrial commission.

**SECTION 2. RETROACTIVE APPLICATION.** This Act applies retroactively to orders of the industrial commission made after July 31, 2013, and applies specifically to the orders of the industrial commission on flaring. The industrial

commission shall report on the fiscal impacts of past orders within ninety days of the effective date of this Act."
