HB 1056 expands the property tax credit for disabled veterans to include properties placed in trust for a surviving spouse.

Section 1 of HB 1056 enables a designated trustee to receive the disabled veteran property tax credit for residential property placed in trust for a surviving un-remarried spouse of a disabled veteran. If enacted, HB 1056 will increase state general fund expenditures by the amount of the property tax credit for qualifying trust-owned properties. The amount of the expenditure increase cannot be determined.
