1 A BILL for an Act to amend and reenact subsections 5 and 7 of section 39-06.1-06,
2 paragraph 33 of subdivision a of subsection 3 of section 39-06.1-10, and subdivisions g, h, and i
3 of subsection 1 of section 39-09-02 of the North Dakota Century Code, relating to statutory
4 fees, entries against driving record, and speed limitations; and to provide a penalty.

5 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

6 **SECTION 1. AMENDMENT.** Subsection 5 of section 39-06.1-06 of the North Dakota
7 Century Code is amended and reenacted as follows:

8 5. On a highway on which the speed limit is a speed higher than fifty-five miles
9 [88.51 kilometers] an hour, for a violation of section 39-09-02, or an equivalent
10 ordinance, a fee established as follows:

11	Miles per hour over	Fee
12	lawful speed limit	
13	1 - 40 15	\$2/each mph over limit
14	4 16 +	\$20 plus \$5/each mph over 10 mph over limit

15 **SECTION 2. AMENDMENT.** Subsection 7 of section 39-06.1-06 of the North Dakota
16 Century Code is amended and reenacted as follows:

17 7. On a highway on which the speed limit is posted in excess of ~~sixty-five~~seventy miles
18 [~~104.64~~112.65 kilometers] an hour, for a violation of section 39-09-02, or equivalent
19 ordinance, a fee of five dollars for each mile per hour over the limit.

20 **SECTION 3. AMENDMENT.** Paragraph 33 of subdivision a of subsection 3 of section
21 39-06.1-10 of the North Dakota Century Code is amended and reenacted as follows:

22 (33) On a highway on which the speed limit is posted in
23 excess of ~~sixty-five~~seventy miles [~~104.64~~112.65 kilometers] an hour,

12 **SECTION 4. AMENDMENT.** Subdivisions g, h, and i of subsection 1 of section 39-09-02 of
13 the North Dakota Century Code are amended and reenacted as follows:

- 14 g. ~~Sixty-five~~Seventy miles [~~104.64~~112.65 kilometers] an hour on paved two-lane
15 highways if posted for that speed, unless otherwise permitted, restricted, or
16 required by conditions.
- 17 h. ~~Seventy~~Seventy-five miles [~~112.65~~120.70 kilometers] an hour on paved and
18 divided multilane highways, unless otherwise permitted, restricted, or required by
19 conditions.
- 20 i. ~~Seventy-five~~Eighty miles [~~120.70~~128.75 kilometers] an hour on
21 access-controlled, paved and divided, multilane interstate highways, unless
22 otherwise permitted, restricted, or required by conditions.
