1 A BILL for an Act to provide an appropriation for defraying the expenses of the office of the
2 secretary of state and public printing; and to provide an exemption.

3 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

4 **SECTION 1. APPROPRIATION.** The funds provided in this section, or so much of the funds
5 as may be necessary, are appropriated out of any moneys in the general fund in the state
6 treasury, not otherwise appropriated, and from special funds derived from federal funds and
7 other income, to the secretary of state for the purpose of defraying the expenses of the
8 secretary of state and public printing, for the biennium beginning July 1, 2017, and ending
9 June 30, 2019, as follows:

3 **SECTION 2. HEALTH INSURANCE INCREASE.** The appropriation in subdivision 1 of
4 section 1 of this Act includes the sum of \$94,446, of which \$91,588 is from the general fund, for
5 increases in employee health insurance premiums from \$1,130 to \$1,249 per month.

6 **SECTION 3. ONE-TIME FUNDING.** The following amounts reflect the one-time funding
7 items approved by the sixty-fourth legislative assembly for the 2015-17 biennium:

11 **SECTION 4. EXEMPTION - GENERAL SERVICES OPERATING FUND.** Any unexpended
12 and unobligated balance remaining in the secretary of state's general services operating fund
13 on June 30, 2017, is not subject to the provisions of section 54-09-08, and any unexpended
14 funds are available and may be expended by the secretary of state during the biennium
15 beginning July 1, 2017, and ending June 30, 2019.
