**ENGROSSED SENATE BILL NO. 2343**

1 A BILL for an Act to create and enact two new sections to chapter 16.1-08.1 of the North Dakota  
2 Century Code, relating to campaign disclosure statements; to amend and reenact section  
3 16.1-08.1-01, subsections 6 and 7 of section 16.1-08.1-02.1, sections 16.1-08.1-03.1 and  
4 16.1-08.1-03.3, subsection 3 of section 16.1-08.1-05, and subsection 5 of section 16.1-12-02.2  
5 of the North Dakota Century Code, relating to definitions, campaign disclosure statements, and  
6 use of campaign contributions; to repeal sections 16.1-08.1-02, 16.1-08.1-03, 16.1-08.1-03.1,  
7 16.1-08.1-03.8, 16.1-08.1-03.9, 16.1-08.1-03.10, 16.1-08.1-03.12, 16.1-08.1-03.13, and  
8 16.1-08.1-04 of the North Dakota Century Code, relating to campaign disclosure statements;  
9 and to provide a penalty.

10 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

11 **SECTION 1. AMENDMENT.** Section 16.1-08.1-01 of the North Dakota Century Code is  
12 amended and reenacted as follows:

13 **16.1-08.1-01. Definitions.**

14 As used in this chapter, unless the context otherwise requires:

- 15 1. "Affiliate" means an organization that controls, is controlled by, or is under common  
16 control with another organization. For purposes of this definition, control means the  
17 possession, direct or indirect, of the power to direct or cause the direction of the  
18 management and policies of an organization, whether through the ownership of voting  
19 securities, by contract other than a commercial contract for goods or nonmanagement  
20 services, or otherwise. Control is presumed to exist if an organization, directly or  
21 indirectly, owns, controls, holds with the power to vote, or holds proxies representing  
22 fifty percent or more of the voting securities of any other organization.
- 23 2. "Association" means any club, association, union, brotherhood, fraternity, organization,  
24 or group of any kind of two or more persons, including labor unions, trade

1 associations, professional associations, or governmental associations, which is united  
2 for any purpose, business, or object and which assesses any dues, membership fees,  
3 or license fees in any amount, or which maintains a treasury fund in any amount. The  
4 term does not include corporations, cooperative corporations, limited liability  
5 companies, political committees, or political parties.

- 6 3. "Candidate" means an individual who seeks nomination for election or election to  
7 public office, and includes:
- 8 a. An individual holding public office;
  - 9 b. An individual who has publicly declared that individual's candidacy for nomination  
10 for election or election to public office or has filed or accepted a nomination for  
11 public office;
  - 12 c. An individual who has formed a campaign or other committee for that individual's  
13 candidacy for public office;
  - 14 d. An individual who has circulated a nominating petition to have that individual's  
15 name placed on the ballot; and
  - 16 e. An individual who has, in any manner, solicited or received a contribution for that  
17 individual's candidacy for public office, whether before or after the election for  
18 that office.
- 19 4. "Conduit" means a person that is not a political party, political committee, or candidate  
20 and which receives a contribution of money and transfers the contribution to a  
21 candidate, political party, or political committee when the contribution is designated  
22 specifically for the candidate, political party, or political committee and the person has  
23 no discretion as to the recipient and the amount transferred. The term includes a  
24 transactional intermediary, including a credit card company or a money transfer  
25 service that pays or transfers money to a candidate on behalf of another person.
- 26 5. "Contribution" means a gift, transfer, conveyance, provision, receipt, subscription,  
27 loan, advance, deposit of money, or anything of value, made for the purpose of  
28 influencing the nomination for election, or election, of any person to public office or  
29 aiding or opposing the circulation or passage of a statewide initiative or referendum  
30 petition or measure. The term also means a contract, promise, or agreement, express  
31 or implied, whether or not legally enforceable, to make a contribution for any of the

1 above purposes. The term includes funds received by a candidate for public office or a  
2 political party or committee which are transferred or signed over to that candidate,  
3 party, or committee from another candidate, party, or political committee or other  
4 source including a conduit. The term "anything of value" includes any good or service  
5 of more than a nominal value. The term "nominal value" means the cost, price, or  
6 worth of the good or service is trivial, token, or of no appreciable value. The term  
7 "contribution" does not include:

8 a. ~~A loan of money from a bank or other lending institution made in the regular~~  
9 ~~course of business.~~

10 b. Time spent by volunteer campaign or political party workers.

11 c. ~~Money spent by a candidate on the candidate's own behalf.~~

12 ~~d.b.~~ Money or anything of value received for commercial transactions, including rents,  
13 advertising, or sponsorships made as a part of a fair market value bargained-for  
14 exchange.

15 ~~e.c.~~ Money or anything of value received ~~by a candidate in that person's personal~~  
16 ~~capacity, including pursuant to a contract or agreement made for personal or~~  
17 ~~private employment purposes, and not received for anything other than a political~~  
18 ~~purpose or to influence the performance of that person's official duty.~~

19 ~~f.d.~~ ~~Contributions of products~~ Products or services for which the actual cost or fair  
20 market value are reimbursed by a payment of money.

21 ~~g.e.~~ An independent expenditure.

22 6. "Cooperative corporations", "corporations", and "limited liability companies" are as  
23 defined in this code, and for purposes of this chapter "corporations" includes nonprofit  
24 corporations. However, if a political committee, the only purpose of which is accepting  
25 contributions and making expenditures for a political purpose, incorporates for liability  
26 purposes only, the committee is not considered a corporation for the purposes of this  
27 chapter.

28 7. "Expenditure" means:

29 a. A gift, transfer, conveyance, provision, loan, advance, payment, distribution,  
30 disbursement, outlay, or deposit of money or anything of value, except a loan of  
31 money from a bank or other lending institution made in the regular course of

- 1                   business, made for a political purpose or for the purpose of influencing the  
2                   passage or defeat of a measure.
- 3           b.    A contract, promise, or agreement, express or implied, whether or not legally  
4           enforceable, to make any expenditure.
- 5           c.    The transfer of funds by a political committee to another political committee.
- 6           d.    An independent expenditure.;
- 7    8.    ~~"Incidental committee" means a committee, club, association, or other group of~~  
8           ~~persons that makes a contribution or expenditure, but for which making contributions~~  
9           ~~and expenditures for political purposes is not its primary purpose."~~Expenditure  
10           categories" means the categories into which expenditures must be grouped for reports  
11           under this chapter. The expenditure categories are:
- 12           a.    Advertising;
- 13           b.    Campaign loan repayment;
- 14           c.    Consulting;
- 15           d.    Operations;
- 16           e.    Postage;
- 17           f.    Printing;
- 18           g.    Travel; and
- 19           h.    Miscellaneous.
- 20    9.    "Independent expenditure" means an expenditure made for a political purpose or for  
21           the purpose of influencing the passage or defeat of a measure if the expenditure is  
22           made without the express or implied consent, authorization, or cooperation of, and not  
23           in concert with or at the request or suggestion of, any candidate ~~or a candidate,~~  
24           ~~committee, or measure committee~~political party.
- 25    10.   "Patron" means a person who owns equity interest in the form of stock, shares, or  
26           membership or maintains similar financial rights in a cooperative corporation.
- 27    11.   "Person" means an individual, partnership, political committee, association,  
28           corporation, cooperative corporation, limited liability company, or other organization or  
29           group of persons.

1       12. "Personal benefit" means a benefit to the candidate or another person which is not for  
2       a political purpose or related to a candidate's responsibilities as a public officeholder,  
3       and any other benefit that would convert a contribution to personal income.

4       13. "Political committee" means any committee, club, association, or other group of  
5       persons which receives contributions or makes expenditures for political purposes and  
6       includes the following:

7       a. A political action committee, derived from a corporation, cooperative corporation,  
8       limited liability company, affiliate, subsidiary, or an association ~~that is prohibited~~  
9       ~~from making a contribution for political purposes under section 16.1-08.1-03.5,~~  
10       ~~and which~~that solicits or receives contributions from its employees or members or  
11       makes expenditures for political purposes on behalf of its employees or  
12       members;

13       b. A candidate committee, established to support an individual candidate seeking  
14       ~~statewide, judicial, or legislative~~public office which solicits or receives  
15       contributions for political purposes;

16       c. A political organization ~~governed by the Internal Revenue Code and~~ registered  
17       with the federal election commission, which solicits or receives contributions or  
18       makes expenditures for political purposes;

19       d. A multicandidate political committee, established to support multiple groups or  
20       slates of candidates seeking public office, ~~that~~which solicits or receives  
21       contributions for political purposes; and

22       e. A measure committee, including an initiative or referendum sponsoring  
23       committee at any stage of its organization, which solicits or receives contributions  
24       or makes expenditures for the purpose of aiding or opposing a measure sought  
25       to be voted upon by the voters of the state, including any activities undertaken for  
26       the purpose of drafting an initiative or referendum petition, seeking approval of  
27       the secretary of state for the circulation of a petition, or seeking approval of the  
28       submitted petitions; ~~and~~

29       f. ~~An incidental committee.~~

30       ~~13.~~14. "Political party" means any association, committee, or organization which nominates a  
31       candidate for election to any office which may be filled by a vote of the electors of this

1 state or any of its political subdivisions and whose name appears on the election ballot  
2 as the candidate of such association, committee, or organization.

3 ~~14.15.~~ "Political purpose" means any activity undertaken in support of or in opposition to the  
4 election or nomination of a candidate to public office and includes using "vote for",  
5 "oppose", or any similar support or opposition language in any advertisement whether  
6 the activity is undertaken by a candidate, a political committee, a political party, or any  
7 person. In the period thirty days before a primary election and sixty days before a  
8 special or general election, "political purpose" also means any activity in which a  
9 candidate's name, office, district, or any term meaning the same as "incumbent" or  
10 "challenger" is used in support of or in opposition to the election or nomination of a  
11 candidate to public office. The term does not include activities undertaken in the  
12 performance of a duty of a statepublic office or any position taken in any bona fide  
13 news story, commentary, or editorial.

14 ~~15.16.~~ "Public office" means every office to which an individual can be elected by vote of the  
15 people under the laws of this state.

16 ~~16.17.~~ "Subsidiary" means an affiliate of a corporation under the control of the corporation  
17 directly or indirectly through one or more intermediaries.

18 **SECTION 2. AMENDMENT.** Subsection 6 of section 16.1-08.1-02.1 of the North Dakota  
19 Century Code is amended and reenacted as follows:

20 6. If a net gain from the convention is transferred to the accounts established for the  
21 support of the nomination or election of candidates, the total transferred must be  
22 reported as a contribution in the statements required by section 16.1-08.1-034 of this  
23 Act.

24 **SECTION 3. AMENDMENT.** Subsection 7 of section 16.1-08.1-02.1 of the North Dakota  
25 Century Code is amended and reenacted as follows:

26 7. If a net loss from the convention is covered by a transfer from the accounts  
27 established for the support of the nomination or election of candidates, the total  
28 transferred must be reported as an expenditure in the statements required by section  
29 16.1-08.1-034 of this Act.

30 **SECTION 4.** A new section to chapter 16.1-08.1 of the North Dakota Century Code is  
31 created and enacted as follows:

1        **Pre-election, supplemental, and year-end campaign disclosure statement**  
2 **requirements for candidates, political committees, and political parties.**

3        1. Prior to the thirty-first day before a primary, general, or special election, a candidate or  
4 candidate committee formed on behalf of the candidate, a political committee, or  
5 political party shall file a campaign disclosure statement that includes all contributions  
6 received and expenditures made from January first through the fortieth day before the  
7 election. The statement may be submitted for filing beginning on the thirty-ninth day  
8 before the election. The statement must include:

- 9        a. For each aggregated contribution from a contributor which totals in excess of two  
10 hundred dollars received during the reporting period:  
11        (1) The name and mailing address of the contributor;  
12        (2) The total amount of the contribution; and  
13        (3) The date the last contributed amount was received;  
14        b. The total of all aggregated contributions from contributors which total in excess of  
15 two hundred dollars during the reporting period;  
16        c. The total of all contributions received from contributors that contributed two  
17 hundred dollars or less each during the reporting period;  
18        d. The balance of the campaign fund on the fortieth day before the election;  
19        e. The balance of the campaign fund on January first; and  
20        f. The total of all expenditures made during the reporting period.

21        2. Beginning on the thirty-ninth day before the election through the day before the  
22 election, a person that files a report under subsection 1 must file a supplemental  
23 statement within forty-eight hours of the start of the day following the receipt of a  
24 contribution or aggregate contribution from a contributor which is in excess of five  
25 hundred dollars. The statement must include:

- 26        a. The name and mailing address of the contributor;  
27        b. The total amount of the contribution received during the reporting period; and  
28        c. The date the last contributed amount was received.

29        3. Prior to February first, a candidate or candidate committee formed on behalf of the  
30 candidate who sought nomination or election to public office during the previous year  
31 or who holds public office, a political committee, or political party shall file a campaign

- 1           disclosure statement that includes all contributions received and expenditures made  
2           from January first through December thirty-first of the previous year. The statement  
3           may be submitted for filing beginning on January first. The statement must include:
- 4           a.   The balance of the campaign fund on January first;  
5           b.   For each aggregated contribution from a contributor which totals in excess of two  
6           hundred dollars received during the reporting period:  
7           (1) The name and mailing address of the contributor;  
8           (2) The total amount of the contribution; and  
9           (3) The date the last contributed amount was received;  
10          c.   The total of all aggregated contributions from contributors which total in excess of  
11          two hundred dollars during the reporting period;  
12          d.   The total of all contributions received from contributors that contributed two  
13          hundred dollars or less each during the reporting period;  
14          e.   For each recipient of an expenditure from campaign funds in excess of two  
15          hundred dollars in the aggregate which is a candidate, political committee, or  
16          political party:  
17          (1) The name and mailing address of the recipient;  
18          (2) The total amount of the expenditure; and  
19          (3) The date the last expenditure was made to the recipient;  
20          f.   The aggregate total of all expenditures from campaign funds of two hundred  
21          dollars or less to recipients that are candidates, political committees, or political  
22          parties;  
23          g.   The total of all other expenditures made during the previous year, separated into  
24          expenditure categories; and  
25          h.   The balance of the campaign fund on December thirty-first.
- 26          4.   A person required to file a report under subsection 1 or subsection 3, other than a  
27          candidate for judicial office or a candidate committee for a candidate for judicial office,  
28          shall report each aggregated contribution from a contributor which totals five thousand  
29          dollars or more during the reporting period. For these contributions, the report must  
30          include:

- 1           a. The contributor's occupation, employer, and the employer's principal place of  
2               business; or  
3           b. If the contributor was a political committee or political party, the name and mailing  
4               address of the contributor.  
5           5. The filing officer shall assess and collect fees for any reports filed after the filing  
6               deadline. A person that filed a late report shall pay the late fee before any subsequent  
7               filing from the person may be accepted.

8           **SECTION 5. AMENDMENT.** Section 16.1-08.1-03.1 of the North Dakota Century Code is  
9 amended and reenacted as follows:

10           **16.1-08.1-03.1. Contributions statement**~~Special requirements for statements required~~  
11 **of measure committees circulating or promoting passage or defeat of initiated or**  
12 **referred measure.**

- 13           1. ~~Any person or measure committee, as described in section 16.1-08.1-01, that is~~  
14 ~~soliciting or accepting a contribution for the purpose of aiding or opposing the~~  
15 ~~circulation or passage of a statewide initiative or referendum petition or measure~~  
16 ~~placed upon a statewide ballot by action of the legislative assembly at any election~~  
17 ~~shall file a statement in accordance with this subsection if the person has received any~~  
18 ~~contribution in excess of one hundred dollars. The statement must include the name~~  
19 ~~and mailing address of each person that contributed in excess of one hundred dollars~~  
20 ~~to the person, the amount of each reportable contribution, and the date each~~  
21 ~~reportable contribution was received. The statement must include the name and~~  
22 ~~mailing address of each recipient of an expenditure exceeding one hundred dollars in~~  
23 ~~the aggregate, the amount of each reportable expenditure, and the date the~~  
24 ~~expenditure was made.~~  
25           2. ~~A person or measure committee as described in section 16.1-08.1-01 which is~~  
26 ~~soliciting or accepting a contribution for the purpose of aiding or opposing the~~  
27 ~~circulation or passage of a statewide initiative or referendum petition or measure~~  
28 ~~placed upon a statewide ballot by action of the legislative assembly may not accept a~~  
29 ~~contribution of more than one hundred dollars from an out-of-state person or political~~  
30 ~~committee unless the contribution is accompanied by a certified statement from the~~  
31 ~~contributor listing the name, address, and amount contributed by each person that~~

1           contributed more than one hundred dollars of the contribution. The statement must  
2           indicate if no person contributed in excess of one hundred dollars of the out-of-state  
3           person's or political committee's overall contribution. The certified statement must also  
4           list the occupation, employer, and principal place of business for each individual who  
5           contributed more than one hundred dollars of the contribution. The person soliciting or  
6           accepting a contribution for the purpose of aiding the circulation of a statewide  
7           initiative or referendum petition or of promoting passage or defeat of a statewide  
8           initiated or referred measure shall include this statement with the contribution  
9           statement required to be filed under subsection 1.

10        3. The statement required of a person or measure committee under subsection 1 must  
11        be filed with the secretary of state no later than the thirty-second day before the date  
12        of the election in which the measure appears or would have appeared on the ballot  
13        complete from the beginning of that calendar year through the fortieth day before the  
14        date of the election. A complete statement for the entire calendar year for each  
15        statement required to be filed under this section must be filed no later than the  
16        thirty-first day of January of the following year. Even if a person required to report  
17        according to this section has not received any contributions in excess of one hundred  
18        dollars during the reporting period, the person shall file a statement as required by this  
19        chapter. A statement filed according to this section during the reporting period must  
20        show the following:

- 21        a. The gross total of all contributions received and expenditures made in excess of  
22        one hundred dollars;
- 23        b. The gross total of all contributions received and expenditures made of one  
24        hundred dollars, or less; and
- 25        c. The cash on hand in the filer's account at the start and close of the reporting  
26        period. For each reportable contribution under section 4 of this Act, the threshold  
27        for reporting is one hundred dollars for any person or measure committee  
28        circulating or promoting passage or defeat of an initiated or referred measure.

29        2. For contributions received from an out-of-state contributor, a person or measure  
30        committee circulating or promoting passage or defeat of an initiated or referred

- 1           measure shall include the following information regarding subcontributors in the  
2           statements required under section 4 of this Act:
- 3           a. A designation as to whether any person contributed in excess of one hundred  
4           dollars of the total contribution;
- 5           b. The name and mailing address of each subcontributor that contributed in excess  
6           of one hundred dollars of the total contribution;
- 7           c. The contribution amounts of each disclosed subcontributor; and
- 8           d. The occupation, employer, and address for the employer's principal place of  
9           business of each disclosed subcontributor.
- 10          3. An initiative and referendum sponsoring committee also shall file a disclosure  
11          statement by the date the secretary of state approves the petition for circulation, and  
12          shall file an additional statement on the date the petitions containing the required  
13          number of signatures are submitted to the secretary of state for review. The  
14          statements required under this subsection must be in the same form as the year-end  
15          statements under section 4 of this Act.
- 16          4. A sponsoring committee shall file a statement regarding its intent to compensate  
17          circulators before paying for petitions to be circulated.

18          **SECTION 6. AMENDMENT.** Section 16.1-08.1-03.3 of the North Dakota Century Code is  
19 amended and reenacted as follows:

20          **16.1-08.1-03.3. Campaign contributions by corporations, cooperative corporations,**  
21 **limited liability companies, and associations - Violation - Penalty - Political action**  
22 **committees authorized.**

- 23          1. A corporation, cooperative corporation, limited liability company, or association may  
24          establish, administer, and solicit contributions to a separate and segregated fund to be  
25          utilized for political purposes by the corporation, cooperative corporation, limited  
26          liability company, or association. It is unlawful for:
- 27          a. The person or persons controlling the fund to make contributions or expenditures  
28          utilizing money or anything of value secured by physical force, job discrimination,  
29          financial reprisals, or the threat of them; or utilize money from dues, fees,  
30          treasury funds, or other money required as a condition of membership in an  
31          association, or as a condition of employment; or utilize money obtained in any

- 1 commercial transaction. Moneys from fees, dues, treasury funds, or money  
2 obtained in a commercial transaction may, however, be used to pay costs of  
3 administration of the fund.
- 4 b. Any person soliciting an employee, stockholder, patron, board member, or  
5 member for a contribution to the fund to fail to inform the employee or member of  
6 the political purposes of the fund at the time of the solicitation or of the general  
7 political philosophy intended to be advanced through committee activities.
- 8 c. Any person soliciting an employee or member for a contribution to the fund to fail  
9 to inform the employee or member at the time of the solicitation of the right to  
10 refuse to contribute without any reprisal.
- 11 d. Any contribution to be accepted without keeping an accurate record of the  
12 contributor and amount contributed and of amounts expended for political  
13 purposes.
- 14 e. Any contribution to be accepted from any person ~~who~~ is not an employee, a  
15 stockholder, a patron, a board member or a member of the corporation,  
16 cooperative corporation, limited liability company, or association maintaining the  
17 political action committee, except a corporation may accept a contribution from  
18 an employee, a stockholder, a patron, a board member, or a member of an  
19 affiliate or a subsidiary of the corporation.
- 20 f. Any expenditure made for political purposes to be reported under this section  
21 before control of the expenditure has been released by the political action  
22 committee except if there is a contract, a promise, or an agreement, expressed or  
23 implied, to make such expenditure.
- 24 2. ~~All political action committees, as described in section 16.1-08.1-01, formed for the~~  
25 ~~purpose of administering the segregated fund provided for in this section shall file a~~  
26 ~~statement showing the name and mailing address of each contributor of an amount in~~  
27 ~~excess of two hundred dollars in the aggregate for the reporting period and a listing of~~  
28 ~~all expenditures of an amount in excess of two hundred dollars in the aggregate made~~  
29 ~~for political purposes with the secretary of state. The statement must include the~~  
30 ~~amount of each reportable contribution and the date it was received and the amount of~~  
31 ~~each reportable expenditure and the date it was made. A year-end statement covering~~

1 the entire calendar year must be filed no later than the thirty first day of January of the  
2 following year. A pre election statement must be filed no later than the thirty second  
3 day before any primary, special, or general election and must be complete from the  
4 beginning of the calendar year through the fortieth day before the election. Even if a  
5 political action committee has not received any contributions or made any  
6 expenditures in excess of two hundred dollars during the reporting period, the political  
7 action committee shall file a statement as required by this chapter. A statement filed  
8 according to this section during the reporting period must show the following:

- 9 a. The gross total of all contributions received and expenditures made in excess of  
10 two hundred dollars;
- 11 b. The gross total of all contributions received and expenditures made of two  
12 hundred dollars, or less; and
- 13 e. The cash on hand in the filer's account at the start and close of the reporting  
14 period.

15 3. A political action committee shall report the occupation, employer, and principal place  
16 of business of each person, or the political committee if not already registered  
17 according to state or federal law, who contributed five thousand dollars or more in the  
18 aggregate during the reporting period.

19 4. A person may not make a payment of that person's money or of another person's  
20 money to any other person for a political purpose in any name other than that of the  
21 person ~~who~~that supplies the money and a person may not knowingly receive the  
22 payment nor enter nor cause the payment to be entered in that person's account or  
23 record in any name other than that of the person by ~~whom~~which it actually was  
24 furnished.

25 ~~5-3.~~ If an officer, employee, agent, attorney, or other representative of a corporation,  
26 cooperative corporation, limited liability company, or association makes any  
27 contribution prohibited by this section out of corporate, cooperative corporation, limited  
28 liability company, or association funds or otherwise violates this section, it is prima  
29 facie evidence of a violation by the corporation, cooperative corporation, limited liability  
30 company, or association.

1     ~~6.4.~~ A violation of this section may be prosecuted in the county where the contribution is  
2           made or in any county in which it has been paid or distributed.

3     ~~7.5.~~ It is a class A misdemeanor for an officer, director, stockholder, manager, governor,  
4           member, attorney, agent, or representative of any corporation, cooperative  
5           corporation, limited liability company, or association to violate this section or to counsel  
6           or consent to any violation. Any person ~~who~~that solicits or knowingly receives any  
7           contribution in violation of this section is guilty of a class A misdemeanor.

8     ~~8.6.~~ Any officer, director, stockholder, manager, governor, member, attorney, agent, or  
9           representative who makes, counsels, or consents to the making of a contribution in  
10          violation of this section is liable to the company, corporation, limited liability company,  
11          or association for the amount so contributed.

12        **SECTION 7.** A new section to chapter 16.1-08.1 of the North Dakota Century Code is  
13    created and enacted as follows:

14        **Personal use of contributions prohibited.**

15        A candidate may not use any contribution received by the candidate, the candidate's  
16    candidate committee, or a multicandidate political committee to:

- 17        1. Give a personal benefit to the candidate or another person;  
18        2. Make a loan to another person;  
19        3. Knowingly pay more than the fair market value for goods or services purchased for the  
20        campaign; or  
21        4. Pay a criminal fine or civil penalty.

22        **SECTION 8. AMENDMENT.** Subsection 3 of section 16.1-08.1-05 of the North Dakota  
23    Century Code is amended and reenacted as follows:

- 24        3. An audit may not be made or requested of a statement for the sole reason that it was  
25        not timely filed with the secretary of state. An audit made or arranged according to this  
26        section must audit only those items required to be included in any statement,  
27        registration, or report filed with the secretary of state according to this chapter. The  
28        secretary of state may collect any payment obligation arising out of this section by civil  
29        action or by assignment to a collection agency, with any costs of collection to be  
30        added to the amount owed and to be paid by the delinquent filer. Any remaining  
31        moneys collected by the secretary of state after an audit is paid for under this section

1            must be deposited in the state's general fund. This section does not apply to  
2            statements filed ~~according to sections 16.1-08.1-03.10 and~~ under section  
3            16.1-08.1-03.11 or to statements filed by candidates for county office or by candidate  
4            committees for candidates for county office.

5            **SECTION 9. AMENDMENT.** Subsection 5 of section 16.1-12-02.2 of the North Dakota  
6 Century Code is amended and reenacted as follows:

7            5. An individual who intends to be a write-in candidate for any legislative district office  
8            shall file a certificate of write-in candidacy with the secretary of state. The certificate  
9            must contain the name, address, and signature of the candidate. Certificates must be  
10           filed by four p.m. on the fourth day before the election. When the candidate files a  
11           certificate, the candidate also shall file the contribution statement provided for under  
12           section ~~16.1-08.1-024 of this Act~~ complete through the day of the filing of the  
13           certificate.

14           **SECTION 10. REPEAL.** Sections 16.1-08.1-02, 16.1-08.1-03, 16.1-08.1-03.1,  
15           16.1-08.1-03.8, 16.1-08.1-03.9, 16.1-08.1-03.10, 16.1-08.1-03.12, 16.1-08.1-03.13, and  
16           16.1-08.1-04 of the North Dakota Century Code are repealed.
