## ENGROSSED SENATE BILL NO. 2022

1 A BILL for an Act to provide an appropriation for defraying the expenses of the commission on  
2 legal counsel for indigents.

3 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

4 **SECTION 1. APPROPRIATION.** The funds provided in this section, or so much of the funds  
5 as may be necessary, are appropriated out of any moneys in the general fund in the state  
6 treasury, not otherwise appropriated, and from special funds derived from other income, to the  
7 commission on legal counsel for indigents for the purpose of defraying the expenses of the  
8 commission on legal counsel for indigents, for the biennium beginning July 1, 2017, and ending  
9 June 30, 2019, as follows:

1 | **SECTION 2. HEALTH INSURANCE INCREASE.** The salaries and wages line item in  
2 section 1 of this Act includes the sum of \$114,999, of which \$112,215 is from the general fund,  
3 for increases in employee health insurance premiums from \$1,130 to \$1,241 per month.

4 | **SECTION 3. ONE-TIME FUNDING.** The following amounts reflect the one-time funding  
5 items approved by the sixty-fourth legislative assembly as adjusted for the 2015-17 biennium.
